JUSTIFICATION FOR REQUEST:

The Gaston County Department of Health and Human Services – Public Health Division received funds from Upstream during fiscal year 2022. The Upstream organization provides evidence-based reproductive health training to engage health agencies in a contraceptive care quality improvement partnership. Upstream provided training to the Health Department Family Planning Program and the Health Department received funds for achieving the quality improvement milestones and processes. These funds will be used for employee development/training. These are non-County funds.
