BACKGROUND

The Gaston County Board of Commissioners approved funding in the FY 20-21 budget to complete improvements at the Gaston County Finance Office and the Tax Mapping Office. Due to continued growth and expansion of Gaston County and ultimately the staffing of these departments, it became necessary to reconfigure the space/layouts of these offices. Public Works has worked with the Finance & Tax Mapping departments alongside Boomerang Design to arrive at a solution that will accommodate the current needs and future growth of these departments. The project was publicly advertised on January 8, 2021 and a public bid opening was held February 1, 2021 at 2:00pm. The following bids were submitted:
