SEPTEMBER 27, 2016

The Gaston County Board of Commissioners (BOC) met in Regular Session on September 27, 2016 at 6:00 p.m., in The Harley B. Gaston, Jr. Public Forum, Gaston County Courthouse.

Chairman Tom Keigher presided with Commissioners Jason Williams, Vice-Chairman; Chad Brown, and Joe D. Carpenter. \*Commissioner Allen R. Fraley joined the meeting via telephone at 6:38 p.m.

Commissioners Tracy L. Philbeck and Mickey Price were not in attendance.

Others present included Earl Mathers, County Manager; Charles L. Moore, County Attorney; and Donna S. Buff, Clerk to the Board.

Upon request of Chairman Keigher, Pastor Josh Glandon, Calvary Baptist Church, Gastonia NC, led those assembled in the Invocation and Commissioner Carpenter led in the Pledge of Allegiance.

### Proclamations, Commendations, Awards, Certificates

Chairman Keigher presented a Commendation to Dr. Bill Thierfelder, President, and Mr. Rolando Rivas, Director of Marketing and Communications of Belmont Abbey College upon being *Ranked in the Top Ten of Best Regional Colleges in the South* in the 2017 Edition of U.S. News & World Report Best Colleges.

Dr. Thierfleder thanked the BOC on behalf of the students, faculty staff and the monastic community.

Continued Public Hearing – Re: To Approve an Appropriation of \$165,000 and Authorize the EDC to Conduct Engineering Tests for the Apple Creek Site to be Developed for an Industrial Business Park (Future Capital Expenditure Fund)

Chairman Keigher announced the Public Hearings as advertised; explained procedures to be used; called for the motion to enter into Public Hearings.

On motion introduced by Commissioner Brown and seconded by Commissioner Carpenter, the BOC unanimously entered into Public Hearings.

Chairman Keigher introduced the County Manager for comments.

County Manager stated there are some issues with the property, which is probably true of any industrial park under consideration; is unlikely that the County will be able to acquire property on both sides of the road; now looking at a smaller second tier industrial park, which County has a great need for; will study the land to address challenges, including the fact that a portion of property is in a flood plain; not making a commitment one way or the other but would propose

continuation of the hearing in order to obtain more information; Mr. Donny Hicks, Executive Director, Economic Development Commission is available to answer any additional questions.

Commissioner Carpenter asked if a motion to continue was required.

County Attorney and County Manager confirmed the procedure in order to continue the hearing.

Chairman Keigher called for citizen comment.

Mr. Frank Matthews, Gastonia, asked for clarification on the motion.

Chairman Keigher stated the County Manager and EDC Director are recommending that this item be continued to the next BOC meeting so that additional studies and research can be completed.

Mr. Matthews stated he has great concern with the County developing property using taxpayer dollars then competing with tax-paying private citizens that are trying to develop a tract of land for sale or development. He noted that he has owned 300 acres on King Mountain Highway with a partner since 1965; paying taxes since 1965; developed a portion in 1975 and has since been put out of business by the Tech-Park; Mr. Matthews stated he supported that endeavor in Gaston County, but can't sell his property for development because he can't compete with government. He noted the difficulty of encouraging private development if the County continues to compete against, and/or under-sell private developers.

Chairman Keigher explained the need for "shovel ready" sites in order to attract industry and noted the difficulties private land owners would have in attaining this requirement.

Mr. Matthews stated his property has water and sewer; EDC has done mapping on land.

Commissioner Brown suggested that Mr. Hicks and Mr. Matthews discuss a price per acre for his land and get a comparison.

Chairman Keigher asked Mr. Matthews if the County had ever approached him regarding pricing for his property; Mr. Matthews stated "yes".

On motion introduced by Commissioner Brown and seconded by Commissioner Carpenter the BOC unanimously continued the Public Hearing – To Approve an Appropriation of \$165,000 and Authorize the EDC to Conduct Engineering Tests for the Apple Creek Site to be Developed for an Industrial Business Park (Future Capital Expenditure Fund) to the October 11, 2016 Rescheduled Regular Meeting.

#### Public Hearing – City of Bessemer City – Bessemer City Planning Board ETJ

Chairman Keigher reported that one position was available on subject board; application was received from Mr. Michael Flanigan, as recommended by the Bessemer City Council, to serve as an extraterritorial jurisdiction representative. The Chairman called for any additional applications or citizen comment and with none being heard, called for BOC comment.

Chairman Keigher called for a motion to approve.

On motion introduced by Commissioner Carpenter and seconded by Commissioner Brown, the BOC unanimously reappointed Mr. Michael Flanigan to the **Bessemer City Planning Board** to a term ending June, 2019.

<u>Public Hearing – Re: To Authorize the Sale of Real Property for Economic Development Pursuant</u> to §G.S. 158-7.1 to Park Sterling Bank

Chairman Keigher introduced the County Attorney for comments.

The County Attorney stated the County was approached by Park Sterling Bank about purchasing property at The Summit Crossing off Court Drive for a back office operation; approximately \$3 million investment; public hearing was advertised in accordance with state statute; Mr. Hicks is present to answer any questions; sale will almost clean out the Court Drive sites that remain.

Chairman Keigher called for citizen comment and for questions from the BOC; hearing none, he called for a motion to approve.

# 2016-241 Commissioner Carpenter – County Attorney – To Authorize the Sale of Real Property for Economic Development Pursuant to §G.S. 158-7.1 to Park Sterling Bank

On motion introduced by Commissioner Carpenter and seconded by Commissioner Brown, the BOC unanimously approved Resolution **2016-241** as follows:

WHEREAS, North Carolina General Statute §158-7.1 authorizes a County to undertake an economic development project by conveying property to a company in order to cause the company to locate or expand its operations within the county; and,

WHEREAS, Gaston County is the owner and developer of The Summit at Court Drive; and,

WHEREAS, Gaston County and Park Sterling Bank have engaged in private negotiations for the conveyance of approximately 6.5 acres, subject to survey, to the end that Park Sterling Bank may construct an office building on the site, and have reached tentative agreement on the terms for conveyance; and.

WHEREAS, the Gaston County Board of Commissioners has held a public hearing to consider whether to approve conveyance of the tract to Park Sterling Bank;

NOW, THEREFORE, BE IT RESOLVED that Gaston County Board of Commissioners:

 The Chairman of the Gaston County Board of Commissioners is authorized to execute the necessary documents to convey to Park Sterling Bank the real property more particularly described below:

6.5 acres (subject to survey) on Summit Crossing Place.

- 2. The conveyance of the property to Park Sterling Bank will stimulate the local economy and promote business. The median average hourly wage in Gaston County, as determined by the North Carolina Employment Security Commission, is \$18.05 per hour. The probable average hourly wage at the facility to be constructed by Park Sterling exceeds \$19.59, which is above the current median hourly wage in the county. This determination of the probably average hourly wage at the facility is based upon materials provided to the County by Park Sterling.
- 3. The fair market value of the property, subject to the covenants and conditions associated with The Summit at Court Drive, is \$140,000 per acre. This determination of fair market value is based upon the sales prices of comparable tracts of land in Gaston County, as reported to the Gaston County Board of Commissioners.

4. As consideration for the conveyance of the property, Park Sterling has agreed to construct on the property an office facility at a cost of at least \$3,740,500. As consideration for the conveyance of the property, Park Sterling will pay \$140,000 per acre, subject to survey, and certain conditions outlined in the proposal, at closing.

Public Hearing – Re: Naming of Private Drive as Robert Lee Thomas Dr.

Chairman Keigher recognized Mrs. Sarah Penley, Planning GIS Specialist III, for a brief overview.

Mrs. Penley stated the property owner petition under consideration, which received 100% signatures, is for the naming of a private drive, located at the conclusion of Leroy Avenue off New Hope Road, as Robert Lee Thomas Drive; duplicate address existing already on this road; would be beneficial for the naming of the private drive for the safety and benefit of the three existing residents that live there. Mrs. Penley outlined the property using aerial maps; advised property is located inside the City of Ranlo ETJ (Extraterritorial Jurisdiction); Ranlo ETJ has jurisdiction over zoning matters and regulations but Gaston County does the addressing for 9-11; Petition received staff support; Planning Board reviewed the recommendation at its regularly scheduled meeting in August and unanimously recommended approval for consideration by the Board of Commissioners. All mailings and notifications were posted and/or sent out in accordance with the County policy; full support of Emergency 911 Communications to name this private drive; no calls for inquiry or comment were received.

Chairman Keigher called for citizen comment.

Ms. Zandra Thomas Rankin, Mt. Holly, NC, stated that Robert Lee Thomas was her grandfather; was a loving man who raised 10 children, 23 grandchildren, 60 great grand-children and 34 great great-grandchildren on this land; naming the street after him will honor and maintain his legacy.

Mr. Daniel James Thomas stated he was the grandson of, and was raised by, Mr. Robert Lee Thomas; would be a great honor to name the road after him.

Chairman Keigher called for questions from the BOC.

Commissioner Brown relayed sentiments to Mr. Daniel Thomas, noting that he grew up with him and knew his grandfather; was a great man and always supportive; look forward to voting in favor of this request.

Commissioner Williams stated Mr. Robert Lee Thomas would be honored to hear the things said about him; stated the BOC is honored and looked forwarded to voting in favor of the request.

Commissioner Carpenter congratulated the family for staying together; thanked them for attending the meeting and congratulated the family.

Chairman Keigher called for a motion to approve.

# Public Hearing - Re: Final Draft of the Gaston County 2035 Comprehensive Land Use Plan

Chairman Keigher recognized Mr. David Williams, Director of Planning and Development Services, for a brief overview.

Mr. Williams stated that after a 15-18 month process of drafting and reviewing the final draft of the 2035 Comprehensive Land Use Plan, the County Planning Board recommended approval on August 23, 2016, at its regular Planning Board meeting; process included working with a land use consultant, ten citizen-input meetings, various meetings and interviews with City and School officials, nonprofit organizations and 12-15 Steering Committee meetings; all the work associated with the process has been incorporated into the final draft. County Planning staff was charged principally with writing a vast majority of the document with guidance from the consultant. The final draft was reviewed with the BOC at its Work Session on September 13, 2016 and scheduled for a public hearing; full copy of the final draft was posted on the County's website and advertised in accordance with County policy. Mr. Williams thanked the Steering Committee members, the Planning Board and Planning staff for all of their assistance and work in developing the plan; thanked the BOC for their support.

Mr. Williams introduced Dr. Robyn Byers Stuber, Ph.D., Land Use Planning Consultant for a brief overview.

Dr. Robyn Stuber noted the difficulty of drafting a comprehensive plan adding that her firm worked very well with County staff; always had the background needed in order to move forward; had a fair amount of people show up and voice their concerns, especially around Belmont, which was the largest meeting; everyone seemed happy with the plan which is unusual; speaks to the validity of this plan and how it relates to Gaston County.

Vice-Chairman Williams called for citizen comment, hearing none asked for comments from the BOC.

Commissioner Carpenter stated he participated in the drafting of the plan; thanked the citizens, staff, consultant and all those that participated in the creation of the Land Use Plan.

Chairman Keigher called for a motion to approve.

On motion introduced by Commissioner Carpenter and seconded by Commissioner Brown, the BOC unanimously approved Resolution **2016-243** as follows:

WHEREAS, In June 2014, the County Commission charged the County Planning Board with the update of the Comprehensive Land Use Plan for the County; and,

The Board of Commission, to obtain a range of input, appointed a diverse Steering Committee to work directly with County Planning Staff, N-Focus Planning and Design of Kannapolis, NC, Robyn Stuber, PhD, (Land Use Planning Consultant), and through a series of monthly meeting over an eighteen month period and ten County wide Citizen input small area meetings, the Steering Committee approved a draft plan and recommended it to the County Planning Board for review; and,

WHEREAS, The Planning Board, in turn, reviewed the draft Comprehensive Land Use Plan, unanimously approving the draft on August 23, 2016, forwarding same (copy on file in Clerk's Office) to the County Commission with a recommendation for approval; and,

WHEREAS, Board of Commission held a work session on September 13, 2016 to review and examine the contents of the final draft of the plan, and instructed staff to set a public hearing for September 27, 2016; and,

WHEREAS, The County Commission held a public hearing on the final draft Comprehensive Land Use Plan on September 27, 2016 to take citizen comment, with comments being on file in the Commission Clerk's Office: and.

WHEREAS, The Commission is requested to consider the public hearing comment, Planning Board recommendation and other pertinent information; then approve the Comprehensive Plan as presented.

NOW, THEREFORE, BE IT RESOLVED by the County Commission that after consideration of the Planning Board recommendation and comment from the public hearing process:

1) approves the final draft of the Comprehensive Land Use Plan, as recommended by the Gaston County Planning Board.

2) authorizes the County Manager to begin implementation of recommendations set forth in the Plan.
