The Gaston County Board of Commissioners (BOC) met in Regular Session at 6:19 pm on February 27, 2024, immediately following its Rescheduled Work Session, in The Harley B. Gaston, Jr. Public Forum, Gaston County Courthouse.

Chairman Chad Brown presided with Commissioners Bob Hovis, Vice-Chairman; Cathy Cloninger, Allen R. Fraley, Kim Johnson, Tom Keigher and Ronnie Worley in attendance.

Others present included Dr. Kim S. Eagle, County Manager; John D. Joye, County Attorney; and Donna S. Buff, Clerk to the Board.

Upon request of Chairman Brown, Commissioner Hovis led those assembled in the Invocation and Commissioner Johnson led in the Pledge of Allegiance during the preceding Work Session.

Public Hearing - RE: Commissioner Worley - Building & Development Services - Zoning Map Change: REZ-23-11-22-00165, Charles Matthew Burrell (Applicant); Property Parcel: 193896, Located at 3117 Ratchford Dr., Gastonia, NC, Rezone from the (R-1) Single Family Limited Zoning District with (US) Urban Standards Overlay to the (R-2) Single Family Moderate Zoning District with (US) Urban Standards Overlay

Chairman Brown announced the Public Hearings as advertised, outlined the Rules of Procedure for the hearings and called for a motion to enter into Public Hearing.

On motion introduced by Commissioner Worley and seconded by Commissioner Hovis, the BOC unanimously entered into Public Hearing.

Chairman Brown introduced Mrs. Laura Hamilton, Planner III - Building and Development Services, for comments.

Mrs. Hamilton advised Mr. Charles Matthew Burrell (Applicant) is requesting to rezone property parcel 193896 (9.66 acres) located at 3117 Ratchford Dr., Gastonia, NC from the (R-1) Single Family Limited Zoning District with US (Urban Standards) Overlay to the (R-2) Single Family Moderate Zoning District with US Overlay; the property is located in the southeastern area of County.

She reviewed aerial, zoning, and adjacent property owners' maps and reported as follows:

- Aerial map depicts the property is currently vacant; is located in a mixed residential limited commercial area in the southeastern region of the County with 1) different housing types, styles, and communities; 2) neighborhoods for site built and single wide/double wide manufactured homes; 3) farmland and forestry within the vicinity
- Zoning Map depicts current zoning districts (R-1, C-3, R-2, R-3, and NBS) with US Overlay;
   if approved, any uses in the R-2 with US Overlay would be permitted per standards/regulations of the Zoning Ordinance
- The site will be serviced via a private well/septic and accessed off an NCDOT road (Ratchford Dr.)
- Adjacent Property Owners Map depicts those that were notified of today's Public Hearing

- The *Table* depicts those who received the mailed notices that were mailed on February 9<sup>th</sup>; the sign was placed on the site on February 13<sup>th</sup> per NCGS
- Staff received one phone call from a nearby neighbor who was in favor of the rezoning request.

The subject property is located in Area 4: The Garden Gaston; key issues for citizens in the area include road improvements and better connectivity to other areas of the County and throughout the region, another bridge crossing Catawba River, increased walkability and connectivity between communities, continued coordination amongst local government agencies and maintaining the enhanced quality of life.

The future land use designation is Rural (this designation exemplifies Gaston County and the existing natural resources throughout the jurisdiction). Residential homes are located on large lots and are set back from the roads they front upon. It is understood that this is the default use designation for Gaston County.

The TRC (Technical Review Committee) reviewed the project and had no comments; there are no planned transportation projects in the vicinity.

The Planning Board heard the request on February 5<sup>th</sup> and recommended approval via a 9-0 vote.

Chairman Brown called for comments from the Applicant.

Mr. Charles Matthew Burrell (Applicant), 8417 Island Point, Charlotte, NC, advised he was available to answer any questions.

Chairman Brown called for citizen comment and for questions from the BOC; hearing none, declared the Public Hearing closed.

Chairman Brown recapped that the Planning Board recommended approval via a 9-0 vote and called for a motion to approve.

On motion introduced by Commissioner Worley and seconded by Commissioner Hovis, the BOC unanimously approved **2024-039**, upon consideration of the map change application, public hearing comment, and recommendation from the Planning Board and Planning staff finds:

The map change request is consistent with the County's approved Comprehensive Land Use Plan. It is consistent with the goals of the Comprehensive Land Use Plan as it will keep the parcel residential in nature as envisioned by the rural future land use designation. Rural areas are characterized by green, rolling hills and plenty of open space, along with farmstead-style housing. This designation exemplifies Gaston County and the existing natural resources that exist throughout the jurisdiction, road improvements and better connectivity to other areas of the County and throughout the region, continued coordination amongst local government agencies, and maintaining the enhanced quality of life. Residential homes are located on large lots and are set back from the roads they front upon in The Garden Gaston / Southeast Gaston area of the Comprehensive Land Use Plan.

The Commission considers this action to be reasonable and in the public interest, based on: Planning Board recommendation and compatibility with existing land uses in the immediate

The County Attorney advised that the Consistency Statement is the same as the one in the Resolution passed by the Planning Board.

Chairman Brown directed the County Attorney to submit it to the Clerk for the record.

Public Hearing - RE: Commissioner Fraley - Building & Development Services - Zoning Map Change: REZ-23-12-11-00166, Jennie Rebecca Black (Applicant); Property Parcel: 157227, Located at 5030 Jason Black Dr., Cherryville, NC, Rezone from the (R-1) Single Family Limited Zoning District to the (R-2) Single Family Moderate Zoning District

Chairman Brown introduced Mrs. Laura Hamilton, Planner III - Building and Development Services, for comments.

Mrs. Hamilton advised Ms. Jennie Rebecca "Becky" Black (Applicant) is requesting to rezone property parcel 157227 at 5030 Jason Black Dr., Cherryville, NC, in its entirety. It is located outside of Cherryville on 6.046 acres (north of Cherryville's municipal limits and south of Lincoln County).

She reviewed aerial, zoning, and adjacent property owners' maps and advised as follows:

- Aerial map depicts the property is wooded with a couple of structures surrounded by residential uses; surrounding houses are a mixture of site-built homes and manufactured housing; the majority of homes north of the subject property are manufactured homes in the R-2 zoning district; two structures on the property must be permitted along with the home permitting if the rezoning is approved to bring them into compliance with the Zoning Ordinance; if it is not approved, staff will work with the property owner on all possible options to bring structures into compliance; more information was included in BOC's packet on this issue; the parcel also has some flooding areas on the southern end of it
- Per Zoning Map the property is currently zoned R-1 (Single Family Limited); Applicant is requesting to rezone to the R-2 (Single Family Moderate); the abutting area is zoned R-1 and R-2; there is some I-2 and Cherryville ETJ R-40 in surrounding area
- Adjacent Property Owners Map depicts those that were notified of today's Public Hearing
- Public notices were mailed on February 9<sup>th</sup>; a sign was placed on property on February 13<sup>th</sup> per NCGS
- Staff received one phone call which appeared to be favorable to the rezoning request
- The Table depicts the property owners who received mailed notices
- The lot will be serviced by a private well/septic, and access is off a recorded easement.

The (GCL)MPO (Gaston-Cleveland-Lincoln Metropolitan Planning Organization) advised there are no planned transportation improvements in this area.

The area is in *Area 1: Rural Gaston / Northwest Gaston* small area plan of the Comprehensive Land Use Plan (CLUP); key issues for citizens in the area are the preservation of open space, road improvements, and better connectivity to other areas of the County and throughout the region, more transportation alternatives, preservation of agriculture and maintaining the rural "feel" of the community, and steering development towards existing infrastructure and areas immediately surrounding the cities and towns.

The future land use designation is *Rural* (rural communities exemplify Gaston County and the existing natural resources throughout the jurisdiction.) Rural areas are characterized by green, rolling hills and plenty of open space, along with farmstead-style housing and agribusiness. It is understood that this is also the default designation for Gaston County.

The TRC (Technical Review Committee) reviewed this project and had no comments at this time.

The Planning Board recommended approval of the request, as presented to the R-2 zoning district, via a 9-0 vote; this concludes the presentation.

Chairman Brown called for comments from the Applicant.

Ms. Jennie Rebecca "Becky" Black noted appreciation for the BOC hearing the request and for Mrs. Hamilton's helpfulness.

Chairman Brown called for citizen comment and for questions from the BOC; hearing none, the public hearing was closed.

Chairman Brown recapped the Planning Board recommended approval via a 9-0 vote and called for a motion to approve.

On motion introduced by Commissioner Fraley and seconded by Commissioner Johnson, the BOC unanimously approved **2024-040**, upon consideration of the map change application, public hearing comment, and recommendation from the Planning Board and Planning staff finds:

The map change request is consistent with the County's approved Comprehensive Land Use Plan. It is consistent with the goals of the Comprehensive Land Use Plan as it will keep the parcel residential in nature as envisioned by the rural future land use designation. Rural areas are characterized by green, rolling hills and plenty of open space, along with farmstead-style housing, as well as agribusinesses. Chairman Brown introduced Ms. Peyton Ratchford, Planner II – Building and Development Services, for comments

Ms. Ratchford advised Ms. Linda Strickland (Applicant) is requesting to rezone parcel 164394 (a .93-acre parcel) located off NC27 Hwy., Iron Station, NC, from the (R-1) Single Family Limited Zoning District to the (R-2) Single Family Moderate Zoning District.

She reviewed vicinity, aerial, zoning, and adjacent property owners' maps and advised:

- Vicinity Map depicts the parcel is located south of the Gaston County/Lincoln County line, north of Stanley's city limits
- Aerial Map depicts the property is currently vacant and heavily treed on a residential street
- Zoning Map depicts surrounding R-1 and R-2 zoning districts; there are a few parcels of C-1 to the south of the property off NC-27 Hwy.; if approved, any uses in the (R-2) Single Family Moderate Zoning District would be permitted per standards/regulations adopted in the UDO (Unified Development Ordinance)
- The site will be served via a private well/septic system and is along Oakhill St. (an NCDOT-maintained road)
- Adjacent Property Owners Map depicts those who received notices of tonight's public hearing
- Notices were mailed out and a sign was placed on the site on February 12th per NCGS
- The *Table* depicts the owners who received a mailed notice.

The subject parcel is located in Area 3: Riverfront Gaston/Northeast Gaston, as outlined in the Comprehensive Land Use Plan (CLUP); key issues for area citizens include the preservation of open space, road improvements, and better connectivity to other areas of the County and throughout the region, increased job opportunities, and maintaining the rural "feel" of the area.

The future land use designation is *Rural Center* (Rural centers are those rural community areas that serve a specific purpose for the immediate area. These can be civic-oriented, anchored by a church, community center, historic structures, etc. Or these areas can also serve a commercial purpose, anchored by a rural market, small store, gas station, community daycare centers, etc. These areas exist where transportation and communities exist to support these services.)

The TRC (Technical Review Committee) reviewed this project; there was one comment from Natural Resources regarding a stream and soil type on the site; if approved, the Applicant will work with Natural Resources on these items during the permitting process; there are no planned transportation improvements projects in the immediate vicinity of this site.

The Planning Board heard the request on February 5<sup>th</sup> and recommended approval by a 9-0 vote.

Ms. Summey stated that staff has been working with Crescent Communities and is requesting a Level Two Grant; Crescent Communities will invest \$22M to make substantial upgrades to a site off Industrial Pike Rd., will construct a 185,000SF facility and will assist with bringing more

prospects to the western side of the County; this issue will go before the City of Gastonia next week; the proposed Level Two Grant is a nine-year grant.

Chairman Brown called for citizen comment and for questions from the BOC; hearing none, declared the Public Hearing closed.

On motion introduced by Commissioner Keigher and seconded by Commissioner Hovis, the BOC unanimously approved **2024-042** as follows:

The Town of Stanley will vote on this issue next week.

Chairman Brown called for citizen comment and for questions from the BOC; hearing none, declared the Public Hearing closed.

Ms. Summey advised that staff has been working with Project Miami, another existing company in the County; Project Miami is looking to invest over \$19M at their four different locations making substantial upgrades to their existing building plus new machinery and equipment; they plan to add 190 new jobs with an average salary of \$54,000/year; staff is also working with the State on the project and the State is offering Project Miami a Building Reuse Grant.

Chairman Brown called for citizen comment and for questions from the BOC; hearing none, the public hearing was closed and Chairman Brown called for a motion to approve.

On motion introduced by Commissioner Worley and seconded by Commissioner Fraley, the BOC unanimously approved **2024-044** as follows:

WHEREAS, Project Miami is considering a total investment of \$19,200,000 to renovate four existing buildings and purchase machinery & equipment in order to increase its manufacturing and distribution capabilities in Gaston County; and,

Chairman Brown asked the speakers to meet with Mr. Brian Sciba (Planned Growth and Development Manager) and Mr. Vincent Wong (Public Safety Manager) after Citizen Recognition, for guidance on whom to contact; he asked Mr. Sciba to contact Natural Resources about the runoff.

Commissioner Hovis asked if the photograph still looked that way today.

Mrs. Babcox responded, "Yes, sir."

Commissioner Worley advised that this is not a unique situation; a resident's backyard in the Rivermist Community in Belmont looked like a pond during heavy rain, and hopefully, the County and the municipalities can work on remedying these types of issues.

Chairman Brown asked Mr. Sciba to involve the Soil & Water Conservation District as well as Natural Resources. He explained that an ETJ (extra territorial jurisdiction) area is an area one mile outside the city limits; the General Assembly can extend an ETJ to a two-mile radius for a city of more than 10,000-25,000 people.

#### **Appointments**

On motion introduced by Commissioner Fraley and seconded by Commissioner Keigher, the BOC unanimously reappointed Mr. Carl Harris, Sr. to the *Planning Board* to a term ending January 31, 2027.

On motion introduced by Commissioner Fraley and seconded by Commissioner Keigher, the BOC unanimously appointed Ms. Sharon Padgett to the *Parks and Recreation Advisory Board* to an unexpired term ending May 31, 2025.

On motion introduced by Commissioner Worley and seconded by Commissioner Fraley, the BOC unanimously appointed Mr. Brandon Broome to the *Child Fatality Prevention Team (CFPT)* to a term ending January 31, 2028.

On motion introduced by Commissioner Brown and seconded by Commissioner Hovis, the BOC unanimously appointed Mr. Jaime Roman to the *Equalization and Review Board* to a term ending December 31, 2026.

On motion introduced by Commissioner Brown and seconded by Commissioner Hovis, the BOC unanimously appointed Mr. Bill Carstarphen to the *Gaston College Board of Trustees* to an unexpired term ending June 30, 2025.

### **Commissioners Committee Reports**

Commissioner Brown reported attendance to the *Hans Kissle Grand Opening* in the Apple Creek Business Park, along with Vice-Chairman Hovis, County Manager and EDC staff. Hans Kissle has a job fair coming up.

Premix, across the street from Hans Kissle, is coming up next; the County continues to fill up the Park; thanked EDC's staff for everything it does for the County.

Chairman Brown thanked Police Chief Stephen Zill and Mark Lamphiear, GEMS Director, for their professionalism in handling the accident that occurred over the weekend; welcomed Sergeant Matt Harris as the new Security Officer for the Public Forum Room.

### **Other Matters**

Commissioner Cloninger advised that she received many calls about the long wait times at the landfill (in some cases up to an hour), commercial and residential trucks going in at the same time, and muddy conditions due to heavy rains. She contacted the County Manager, who made some calls and worked with staff to address the issue.

She concluded that she learned from a pleased citizen today who reported that the timeframe has lessened due to the separation of commercial and residential drop-offs. She added that continuing this practice will be important going forward, and she commended the County Manager and staff for making this change for the citizens.

Commissioner Keigher requested the County Manager to provide an update to the BOC on future industrial park property and School bonds. He also advised that a landfill user contacted him questioning why out-of-county users pay the same fee as in-county users. He concluded that the BOC should look at that, as there is only so much land available for garbage, and added he thinks out-of-county users should pay a little more.

Commissioner Cloninger concurred that out-of-county users should pay more at the landfill and noted that many of them are coming from Mecklenburg County.

Commissioner Worley recalled the fatal incident involving our law enforcement and first responders and noted that the BOC extends prayers and sympathies to the family involved.

### **County Manager's Report**

The County Manager advised she did not have a formal report but would provide a brief response to Commissioner Cloninger and Keigher's comments:

- The County is in the process of closing out Unit 2 at the Landfill; that cell is almost full; which has impacted some of the wait times; staff has already started analyzing the usage, and Mecklenburg County makes up about 8% of the current usage; will provide a written report on the landfill; Unit 3 (new cell) will be open in April and will help with the wait times
- Will provide a follow-up report on future industrial park property and School Bonds; staff is planning for the BOC's March 12<sup>th</sup> Strategy Session, and those items are a part of that conversation.

Chairman Brown asked the County Manager to include a discussion on that fee schedule during the individual budget meetings.

#### **County Attorney's Report**

The County Attorney advised he had no report but is getting settled in; it is an honor to be here and a pleasure to be home.

Chairman Brown welcomed him on behalf of the Board.

Chairman Brown advised that the 2023 Annual Report is out; noted that Tuesday, March 5<sup>th</sup> is Primary Election Day.

### **Adjournment**

In closing, Chairman Brown announced that the March 12 Work Session had been canceled and a Budget Strategy Session has been scheduled for that day from 1-4 p.m., at the Daniel Stowe Botanical Garden. He called for a motion to adjourn.
