BUDGET ORDINANCE IMPACT

Increase Donation revenues by \$1,950 and appropriate \$1,000 into Furn/Equip<\$5,000 and \$950 into Support Canine account.

BACKGROUND

GEMS has received donations totaling \$1,950; \$300 of the funds were donated by Dr. Andrew Matthews in Memory of Lt. Melanie Massagee and her love of dogs and the GEMS therapy dog program.

- GEMS received \$1,450 from a local dental office and \$200 from a local restaurant.

A portion of the funds (\$950) will be used to purchase therapy dog equipment such as harnesses, bedding, and other needed supplies. GEMS has a highly successful program that has been published in EMS World and EMS International; the funds will allow the therapy dog to be more available to public safety personnel around the county. The remaining \$1,000 will be used to purchase a projector for GEMS training room. The department provides four weeks of in-house training for new employees as well as annual training for existing employees and a projector is needed for continuing education.
