Transfers \$1,168,545 from school debt service to debt services for Gaston College

BACKGROUND

On May 24, 2016 \$5,020,000 of school and Gaston College General Obligation bonds were refunded. During the budget process, the debt service payments for the bonds were all inadvertently budgeted as school debt. The attached budget change request transfers \$1,168,545 from the school debt service fund (Fund 31) to the County debt service fund (Fund 30) to cover the Gaston College portion of the refunding bond payments.
