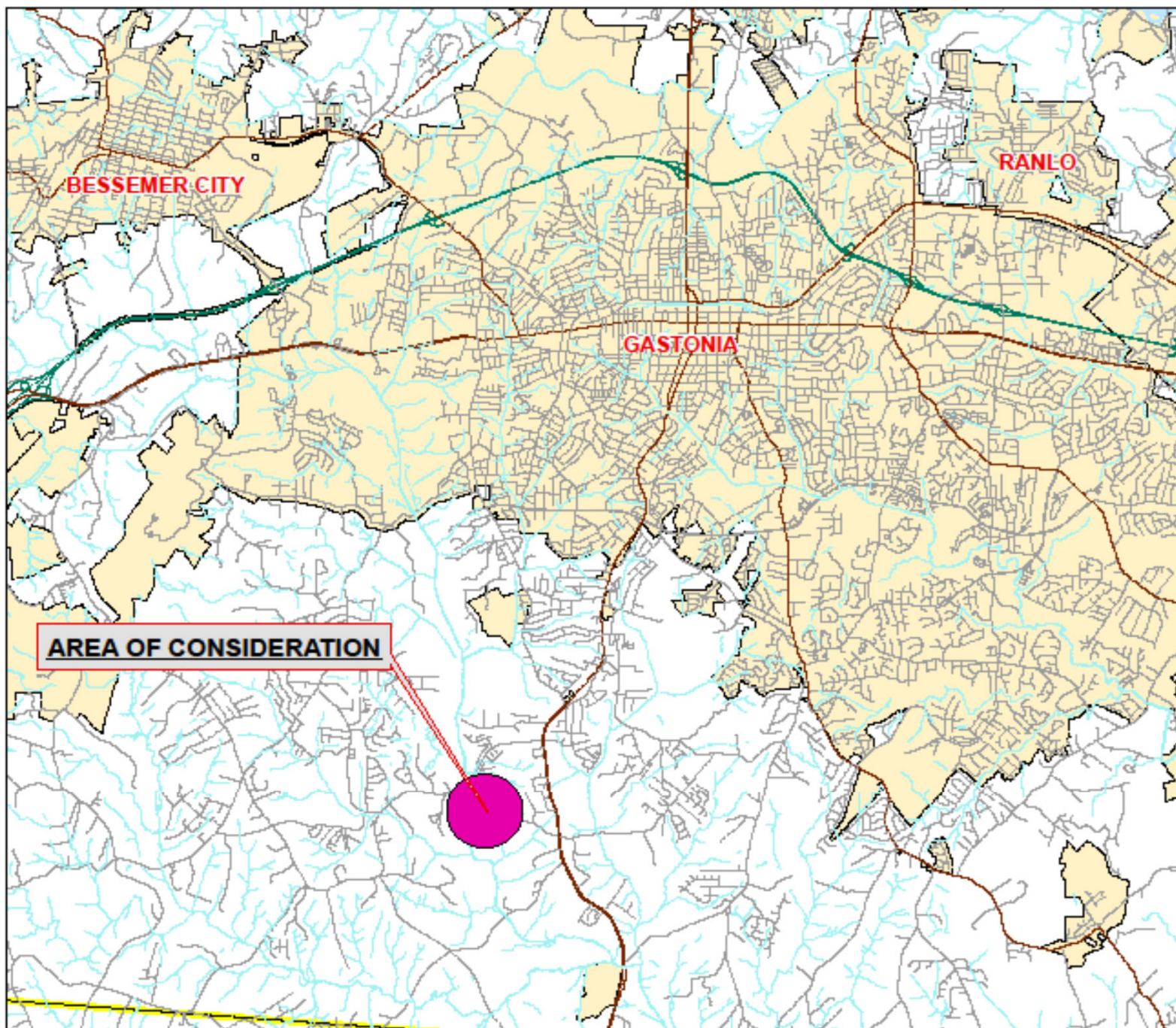

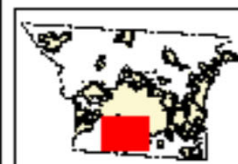


Gaston County Overview Map

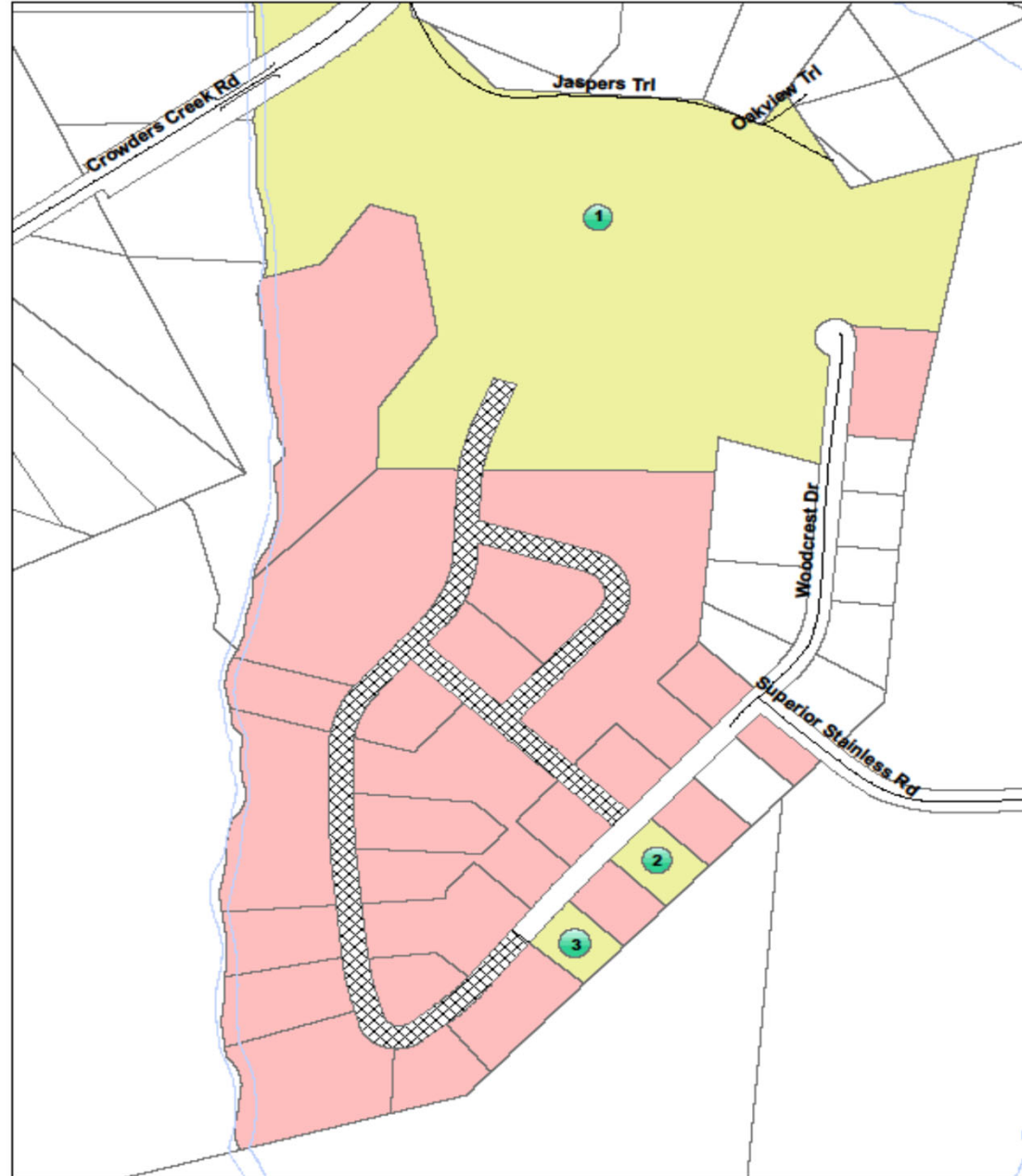
