ZONING MAP CHANGE: REZ-25-03-25-00223, MCKENZIE MARIE MAIERS (APPLICANT); PROPERTY PARCEL: 171661, LOCATED AT 220 FL MAIERS RD., GASTONIA, NC, REZONE FROM THE (R-1) SINGLE FAMILY LIMITED ZONING DISTRICT WITH (US) URBAN STANDARDS OVERLAY TO THE (R-2) SINGLE FAMILY MODERATE ZONING DISTRICT WITH (US) URBAN STANDARDS OVERLAY

WHEREAS,

the Planning Board recommended approval of the map change request for parcel 171661, located at 220 FL Maiers Rd., Gastonia, NC, to be rezoned from the (R-1) Single Family Limited Zoning District with (US) Urban Standards Overlay to the (R-2) Single Family Moderate Zoning District with (US) Urban Standards Overlay on August 4, 2025, based on: staff recommendation; and the request is reasonable and in the public interest and is consistent with the Comprehensive Land Use Plan as it will keep the parcel residential in nature as envisioned by the rural future land use designation as it is rural in nature with larger lots with homes that sit back from the roads they front upon.
