- WHEREAS, Holy Angels currently serves 100 residents and offers a variety of programs and services for their residents and their residents' families; and,
- WHEREAS, Holy Angels continues to be a strong economic and educational partner in Gaston County, employing some 300 staff members, 23 support employees and an additional 31 individuals through its Life Choices program; and,
- WHEREAS, Holy Angels also contributes to the local economy through its affiliated enterprises which offer vocational training and meaningful employment opportunities for adults in its care, including Cherubs Café, which opened its doors in Belmont in 1996, followed by Cherubs Candy Bouquets, and in Cramerton, Cherubs Market, which opened in 2016 in conjunction with Life Choices adult day program; and,
