JANUARY 23, 2024

The Gaston County Board of Commissioners (BOC) met in Regular Session on January 23, 2024, at 6:00 pm in The Harley B. Gaston, Jr. Public Forum, Gaston County Courthouse.

Chairman Chad Brown presided with Commissioners Bob Hovis, Vice-Chairman; Cathy Cloninger, Allen R. Fraley, Tom Keigher and Ronnie Worley in attendance.

Commissioner Kim Johnson was not in attendance.

Others present included Dr. Kim S. Eagle, County Manager; Courtney C. Rogers, Interim County Attorney; and Donna S. Buff, Clerk to the Board.

Upon request of Chairman Brown, Commissioner Hovis led those assembled in the Invocation and Commissioner Keigher led in the Pledge of Allegiance.

<u>Commissioner Keigher – Proclamation – To Proclaim the Week of January 28, 2024 – February 3, 2024 as Catholic School Week in Gaston County (To be Adopted under Consent Agenda)</u>

Commissioner Keigher read and presented the Proclamation to Mr. Jacob Nolan, St. Michael School Headmaster.

<u>Commissioner Hovis – Commendation – Finance Staff – GFOA Certificate of Achievement for</u> <u>Excellence in Financial Reporting Award</u> (*To be Adopted under Consent Agenda*)

Commissioner Hovis invited Finance Department staff to the podium to receive the GFOA Certificate of Achievement for Excellence in Financial Reporting Award.

Mr. Justin Amos, Finance & Partner Agency Manager/Chief of Staff, accepted and thanked the BOC for the Award on behalf of the Finance Department members.

<u>Commissioner Brown – Proclamation – To Proclaim the Month of January 2024 as Human</u> <u>Trafficking Awareness Month</u> (*To be Adopted under Consent Agenda*)

Commissioner Worley read and presented the Proclamation to Ms. Heather Kauffman, Hope United CAC Supervisor, who was accompanied by Ms. Emily McCabe (Court Services Program Manager), Ms. Hannah Hopper (Human Trafficking & Sexual Assault Social Worker), Mr. Steve Eaton (DHHS - Public Health Division Director) and Dr. Gregory Grier (Community Support Services).

Presentation – FY22-23 Gaston County Audit

Ms. Kelly Gooderham, Senior Audit Manager with Martin Starnes & Associates, CPAs, PA, provided a PowerPoint presentation on the FY22-23 Gaston County Audit. The presentation slides, the FY22 Annual Comprehensive Financial Report and the Audit Letter were provided to the BOC and are on file with the Clerk to the Board.

Ms. Gooderham's presentation is summarized as follows:

- Gaston County was issued a *Clean, Unmodified Opinion* on financial statements (no material misstatements were found)
- **General Fund Summary**: *Revenues* were over budget by roughly \$16M; major drivers were property taxes and intergovernmental revenues which include federal/state grants; *Expenditures* were under budget by roughly \$28M; major drivers included Human Services and Public Safety
- Fund Balance Position General Fund: The LGC (Local Government Commission) uses a calculation to compare the Available Fund Balance within the General Fund with units across the state Total Fund Balance (\$124M); Less: Nonspendable, which includes inventories, prepaids and leases; Less: Stabilization by State Statute for a total Available Fund Balance of \$104M due to an overall increase over prior year of roughly \$15M
- The **General Fund Available Fund Balance** is turned into a percentage of expenditures and compared to other NC counties within the same population group; the County's percentage gradually increased over the past several years and ended at 35.76% (an overall increase of roughly 3.21%)
- Unassigned Fund Balance Position General Fund: Started with *total Fund Balance Less: Nonspendable and Stabilization by State Statute*; reduced that for all other external/internal constraints including the *Restricted* fund balance (which includes Medicaid Maximization, General Government, Building Inspections and Register of Deeds) less the *Assigned* (which includes insurance reserves, subsequent years expenditures appropriation and tap fees) for a total *Unassigned Fund Balance* under \$43M (an increase over prior year of \$4.6M)
- Unassigned Fund Balance General Fund (12-Year Comparison as Percentage of Total Fund Balance): There was a significant increase from 2021 to 2022, but remains comparable between 2022 and 2023 with an overall increase of 1%; next slide also is a 12-year comparison of Unassigned Fund Balance as opposed to total Fund Balance; there was a gradual increase over the last three years in both categories with a significant increase in 2020
- **Top 3 General Fund Revenues**: *Property Taxes*; *Other Taxes & Licenses* (which includes sales tax and real estate transfer tax); *Restricted Intergovernmental* (which includes federal/state grants and federal/state detention reimbursements)
- **Property Tax** is roughly 57% of total revenues; current year exceeded budget by \$3M; an overall increase over prior year of \$2M or 1%
- Other Taxes & Licenses equates to 12% of total revenues; current year exceeded budget by roughly \$400,000; and increased over prior year roughly \$2M or 6%
- **Restricted Intergovernmental** is roughly 18% of total revenues; current year revenues exceeded budget by \$4M; increased over prior year roughly \$6M or 13%
- **Top 3 General Fund Expenditures:** *Public Safety* (Police, EMS, Jail and Sheriff) expenses equates to roughly 32% of total expenditures and budget exceeded actual by \$14.5M; there was an overall increase over prior year of roughly \$17M or 22%; *Human Services* (Administration, Personal Health and Family Planning) is 27% of total expenditures and budget exceeded actuals by \$22M; there was an overall current year decrease of \$5.5M or 7%; *Education* (Public Schools and Gaston College) is 20% of total expenditures and budget exceeded actual by \$300,000 and stayed comparable to only a \$500 increase

- Solid Waste Enterprise Fund Revenues and Net income: Operating Revenues is \$13.7M, an overall increase of \$107M or 14% over prior year; Operating Income (Loss) is \$469,000 due to an increase in operating expenses
- Performance Indicators noted on the LGC's data input sheet: a stable property tax valuation and collection percentage; consistent available Fund Balance percentage; one material weakness and three significant deficiency findings on County's major program compliance testing at DSS; proper resolution of County's priorities/findings noted in FY2022; additional information on the findings can be found in back of the Audit Report in the compliance package.

She concluded her presentation and asked if there were any questions.

Chairman Brown thanked Ms. Gooderham for the report and called for questions from the BOC.

Commissioner Cloninger asked why the amounts increased for Public Safety and decreased for Human Services.

Ms. Gooderham responded the increase for Public Safety was due to salaries, benefits, equipment purchases for GEMS and Sheriff's Office, and the implementation of the new GASBY96 standard this year which included subscriptions assets and related capital outlay; the decrease for Human Services was due to the ERA (Emergency Rental Assistance) Program; it increased the prior year (2nd year) and the majority of the program's activity was in that year at roughly \$14M; this year it came to a close at roughly \$2M.

Commissioner Cloninger asked if there were any findings that needed to be addressed in the report.

Ms. Gooderham responded the findings that were noted were compliance and not financial statements findings; Finance is already working with DSS to rectify some of the internal controls noted and hopes to get those resolved in the coming year.

Chairman Brown called for additional questions; hearing none, thanked Ms. Gooderham again and stated the BOC looks forward to the 2023-24 Audit soon.

RESOLUTION AUTHORIZING AND APPROVING AN INSTALLMENT FINANCING CONTRACT WITH BANC OF AMERICA PUBLIC CAPITAL CORP AND AUTHORIZING THE EXECUTION AND DELIVERY OF DOCUMENTS IN CONNECTION THEREWITH

WHEREAS, the County of Gaston, North Carolina (the "County"), is a political subdivision organized and existing under the laws of the State of North Carolina; and

WHEREAS, the Board of Commissioners for the County (the "Board") has determined to finance a portion of the cost of acquiring various motor vehicles and equipment (the "Project"); and

WHEREAS, in order to finance a portion of the cost of the Project, the Board has determined that it is in the best interests of the County to enter into Schedule of Property No. 10 (the "Purchase Agreement"), between Banc of America Public Capital Corp (the "Lender") and the County, which supplements the Master Equipment Financing Agreement dated as of February 14, 2013, pursuant to the authority granted to the County under Section 160A-20 of the General Statutes of North Carolina, whereby the Lender will advance funds, in an amount not to exceed \$4,634,989.65, for such purpose and the County will make installment payments in consideration thereof; and

WHEREAS, there has been made available at this meeting, the form of the Purchase Agreement between the County and the Lender; and

WHEREAS, the Board wants to approve the Purchase Agreement and to authorize other actions in connection therewith.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners for the County of Gaston, North Carolina as follows:

Section 1. The Purchase Agreement, in the form submitted to this meeting, is hereby approved, and the Chair of the Board, the County Manager, the Interim Finance Director for the County and the Clerk to the Board are each hereby authorized and directed to execute and deliver the Purchase Agreement, with such changes, insertions or omissions as each may approve, the execution thereof by any of them to constitute conclusive evidence of such approval.

Section 2. The Chair of the Board, the County Manager, the Interim Finance Director for the County, the Clerk to the Board and the County Attorney are each hereby authorized to take any and all such further action and to execute and deliver such other documents as may be necessary or advisable to carry out the intent of this Resolution and to effect the installment financing pursuant to the Purchase Agreement. Without limiting the generality of the foregoing, the Interim Finance Director is authorized to approve all details of the financing, including without limitation, the amount advanced under the Purchase Agreement (which shall not exceed \$4,634,989.65), the principal payments under the Purchase Agreement, the term of the Purchase Agreement and the interest rate thereunder. Execution of the Purchase Agreement by the Chair of the Board, the County Manager or the Interim Finance Director, shall conclusively evidence approval of all such details of the financing.

Section 3. All actions of the County effectuating the proposed financing are hereby approved, ratified and authorized pursuant to and in accordance with the transactions contemplated by the documents referred to above.

Section 4. This resolution shall take effect immediately upon its passage.

(Chairman Brown announced the BOC voted to reschedule its February 13th Work Session to precede the February 27th Regular Meeting.)

Items Pulled from Consent Agenda

2024-038 Commissioners Brown, Hovis, & Keigher - Public Works - To Authorize the Purchase of Properties Located at 803 N. Oakland Street, Gastonia PID's 104358 (4.52 acres), 104359 (5.11 acres), and 104364 (.74 acres) for the Total Purchase Price (\$7,500,000) and the Estimated Closing Costs (\$50,000)

Chairman Brown introduced Commissioner Cloninger for comments.

Commissioner Cloninger advised that a mill is located on one of the three parcels for sale; it was built in 1903 (closed 12 years ago), and is in average condition with three floors; it has been used as a warehouse; inquired if it was anticipated to be used as a warehouse in the future.

Mr. Ray Maxwell, Infrastructure & Asset Manager, responded "that is correct"; it was built in 1903; additions were made in the 1960s and 1984.

Commissioner Cloninger asked what the warehouse would house and how much it would cost to upfit the project.

Mr. Maxwell advised that portion of the project has not been fully planned out; staff has discussed moving some of the County's warehousing functions from the York-Chester building to this location; part of the purpose for the purchase is to provide the County with adequate acreage for the combined Public Safety Campus.

Commissioner Cloninger referenced the architect's drawings and asked for the estimated cost of the Public Safety Campus.

Mr. Maxwell responded that staff does not have information on that particular building; the renderings for the building just show what it could look like once renovated; staff will refine the Public Safety Campus cost estimates as it moves forward with the design.

Commissioner Cloninger asked if the campus would be built in stages.

Mr. Maxwell responded the existing building would not necessarily be used as part of the public safety function; the Public Safety Campus would be built first and then the existing building would be renovated at some point in the future.

Commissioner Cloninger stated she understands the importance of a Public Safety Campus but does not understand why that piece of property is so expensive.

Mr. Maxwell responded staff asked a local appraiser to review the property and provide an idea of what the market value was for that; the appraiser looked at eight properties to come up with the appraised value and that is how staff arrived at that number.

Commissioner Worley asked if the County would be able to use ARPA funding for this purchase.

Mr. Maxwell responded, "That is correct". There would not be any local County tax dollars associated with it; would be purchased with ARPA funds.

Commissioner Cloninger asked if ARPA funds would be used to build the facility.

Mr. Maxwell responded ARPA funds would only be used to purchase the property.

Chairman Brown responded that the ARPA funds will be sunsetting in 2026. He noted that the County Police Department is bursting at the seams due to a lack of office space; Emergency Management will be located there as well; GEMS is also experiencing similar congestion with three agencies operating in one building. He noted the Elections, Probation Office and County Police building, located in the FUSE District, would go back onto the tax rolls; the City of Gastonia is trying to help build that area up; excited to see this come to fruition for our Public Safety officers.

The County Manager advised staff is completing a packet report on the ARPA funds allocations; the design for the Public Safety Campus is in the current year's budget.

Commissioner Hovis noted the 911 Communications Center is extremely crowded; the new facility will provide the expansion sorely needed for employees to have a proper work environment; it will also provide GEMS with the additional storage space they need.

Chairman Brown agreed the campus will allow for a centrally located, safe storage facility for public safety apparatus.

Commissioner Worley echoed Chairman Brown's comments about the security of personnel and equipment; it is an excellent opportunity for the County and will ultimately better serve the citizenry; one central location will allow for public safety personnel to more readily communicate with one another. He also noted the lack of available property in general.

Chairman Brown advised it will be a first-class facility once it is built out; there is also a lot of infrastructure that is already in place there.

Chairman Brown called for a motion to approve.
