# **BACKGROUND**

In a competitive process, the NC Governor's Crime Commission awards a maximum of \$24,500 to selected law enforcement agencies through the federal Edward Byrne Memorial Justice Assistance Grant (JAG) funding. Funding may only be used for equipment purchases. The GCPD will purchase a Digital Vehicular Repeater System (DVRS) that will be installed in the Gaston County Police Mobile Command Truck to allow for improved radio communications.
