BACKGROUND

The NC Housing Finance Agency makes Urgent Repair Program funds available on a competitive basis to qualified organizations during each funding cycle to finance emergency home repairs and modifications for low income homeowners with special needs. The funds provide deferred, forgiven loans of up to \$10,000 to qualified homeowners for emergency repairs. A portion of the program funds are allocated for program support expenses and is accounted for and claimed on a unit-by-unit basis. The maximum amount of program support available varies with amount of program funds used for hard costs on each unit.
