BACKGROUND

On September 22, 2020 the Board of Commissioners authorized the issuance of General Obligation Refunding Bonds. On October 28, 2020, Gaston County issued General Obligation Refunding Bonds in the amount of \$50,145,000. The all-in true interest cost (TIC) was .705% with a net present value (PV) savings of \$4,324,978 for the County. The bond premium was \$10,371,875.10 for a total appropriation of \$60,516,875.10.
