- 2. The badge worn by Assistant Chief Shelor be given to him as a remembrance of his service with the Gaston County Police Department.
- 3. The service side arm, Glock, Model 45MOS, Serial Number BRTV307 be permanently retired by the Gaston County Police Department and offered to Assistant Chief Shelor for a purchase price of \$1.00.
- 4. The Chief of the Gaston County Police Department is directed to award Assistant Chief Shelor with the service side arm and badge as specified and worn by him during his service to Gaston County, in accordance with the North Carolina General Statutes and the policy of the Board.
- BE IT FURTHER RESOLVED that the Gaston County Board of Commissioners expresses their sincere gratitude for the dedicated service of Assistant Police Chief Myron K. Shelor and wishes him the best in his retirement.
