JUSTIFICATION FOR REQUEST:

The Family Violence Prevention Services Act is the primary federal funding stream dedicated to supporting emergency shelters and related assistance for victims of domestic violence and their children. Funding will be used to contract with a public outreach specialist to iincrease public awareness about the prevalence of domestic violence, dating violence and family violence and to support shelter victim services and operating expenses.
