The Gaston County Board of Commissioners (BOC) met in Rescheduled Regular Session on November 10, 2016, immediately following its Work Session at 7:42 pm, in The Harley B. Gaston, Jr. Public Forum, Gaston County Courthouse.

Chairman Tom Keigher presided with Commissioners Jason Williams, Vice-Chairman; Chad Brown, Joe D. Carpenter, Allen R. Fraley, Tracy L. Philbeck, and Mickey Price in attendance.

Others present included Earl Mathers, County Manager; Charles L. Moore, County Attorney; and Donna S. Buff, Clerk to the Board.

During the preceding Work Session, Chairman Keigher led those assembled in the Invocation and Commissioner Philbeck led in the Pledge of Allegiance.

Judge William Gaston Award Presentations

Chairman Keigher presented:

- A very important part of this Board's mission is to encourage citizen participation in county government and community involvement
- In 1998, the County Commission established an annual award bearing the name of the County's namesake, Judge William Gaston (1778-1844), to recognize those volunteers who have demonstrated exemplary commitment, dedication, and leadership. Since its establishment, the County Commission has honored 53 recipient volunteers for their services to the Gaston County community
- This year the Board of Commissioners has the privilege of presenting the William Gaston Award to four outstanding individuals: *Mr. Richard (Dick) S. Cromlish, Jr., Mr. James Russell Beam, Mr. Stephen D. Campbell and Mr. J. Brett Keeter

Chairman Keigher directed that all four recipients' names be set forth in the Minutes of the November 10, 2016 Rescheduled Regular Meeting.

Mr. Richard (Dick) S. Cromlish

Commissioners Carpenter and Price presented:

- Mr. Dick Cromlish has been described by his colleagues as a reliable and engaged proponent of economic development and quality

Chairman Keigher called for a motion to approve.

On motion introduced by Commissioner Brown and seconded by Commissioner Carpenter, the BOC unanimously approved Commissioner Keigher's request to move items O and P to the Non-Consent Agenda as stated above.

Approval of Minutes

On motion introduced by Commissioner Price and seconded by Commissioner Philbeck, the BOC unanimously approved the Minutes of the Regular Meeting of September 27, 2016 and the Rescheduled Regular Meeting of October 11, 2016.

Citizen Recognition

Ms. Barbara Lingerfelt, 135 Acre Rd, Bessemer City, spoke in favor of Zoning Map Change Z16-09 and expressed her dismay to the reaction from neighbors; grew up on the land; has been for sale for over 5 years; turned down a previous offer because seller wanted to put chicken houses on the property; supports solar farm and new energy sources that will benefit everyone in the neighborhood.

Mr. Michael P. Lingerfelt (Applicant), Bellevue Washington, native of Gaston County, stated that he was unable to attend the October 11, 2016 Public Hearing for Z16-09. His family requested the public hearing after entering into a conditional contract with Gardner Capital Solar. Affter the due diligence was completed, they moved forward with the rezoning request. Mr. Lingerfelt refuted the misunderstanding that the land would be used for housing; have had several

opportunities to sell but felt that this was the best use of the property; County has zoning process in place to ensure neighborhoods are protected; asked Commissioners to approve the rezoning request so the company can proceed with a conditional use permit for a solar farm.

Gaston County Sheriff, Alan Cloninger addressed the two items pulled from the Consent Agenda related to the radio system; agreed that a new system is needed but the evaluation process was flawed; only County staff members were included in the selection of VIPER even though municipalities will be serviced by the new service. He asked the BOC to consider delaying the vote and cited his concerns regarding VIPER; does not support VIPER or UASI at this stage and suggested removing VIPER from the resolution.

Honorable Rick Coleman, Mayor of Dallas expressed his concern that the municipalities were not involved in the review and selection process for the new radio service; that if the new system results in a property tax increase, the Town of Dallas would in turn have to raise taxes to pay their share of the system. He questioned the need for a grant at this stage if the County does not have the funds for the purchase; asked the BOC to allow more time and involve municipalities in the process.

Honorable Ronnie Worley, Mayor of Cramerton, stated the Town of Cramerton fully supports pursuing a grant for the purchase of a new radio system, however is not willing to commit to a specific radio system at this time; suggested removing VIPER from the resolution. He added that every municipality is a tax paying stakeholder and deserves a voice in this decision and suggested that having all municipalities sign the Memorandum of Understanding (MOU) would increase the probability of receiving the grant; additional research is needed to determine what is best for Gaston County; recalled his experience as a State Trooper and expressed his concerns regarding VIPER.

Mr. Aaron Halimi, San Francisco, California, Senior Vice President of Solar Development for Gardner Capital, thanked the BOC for allowing him to speak on Zoning Map Change Z16-09; has worked with the utility companies and applicant for the last year to get to this point; wanted to reaffirm to the community and the BOC that the full intent of Gardner Capital is to develop, own and operate a solar facility that will develop clean and reliable energy, limit impacts on traffic and increase tax revenue without drawing on any of the local resources.

Mr. Norman Picard signed up to speak but stated that his concerns were answered by Mr. Halimi.

Non-Consent

FAILED Commissioner Keigher – BOC – To Approve a Resolution to Expedite the Provision of Permanent Water Supplies to Residents Near Allen Steam Station

Chairman Keigher called for a motion for purposes of discussion. Commissioner Price introduced the motion and Commissioner Fraley provided the second.

Commissioner Carpenter spoke in opposition of the resolution; stated Duke Energy has been working with the State and has developed a plan to deal with this issue. He noted that while sympathetic, he has received conflicting reports regarding the source of the chromium material; suggested that citizens can request volunteer annexation from Belmont or Cramerton to obtain water. He added that Duke Energy is a good corporate citizen of Gaston County.

Commissioner Philbeck stated that he would not support the resolution but is willing to personally meet with representatives in Raleigh to push the action and nail down the facts; believes that will be more helpful and expeditious than a resolution of support from the BOC.

Chairman Keigher stated his support for the resolution, noting his willingness to contact Legislators and the Speaker of the House to help expedite matters.

Commissioner Williams spoke in opposition to the resolution and indicated that he was unable to independently verify that Duke Energy is responsible; will not support a resolution that directs a company to do something when it has not been proven that they are responsible for causing the problem.

With discussion coming to a close, Chairman Keigher called for the vote and the motion failed to carry as follows:

2016-318 Commissioners Brown and Fraley – Fire Department – Resolution To Support the Designation of the NC State Highway Patrol Voice Interoperability Plan for Emergency Responders (VIPER) as the Next Generation Emergency Services Radio System Platform for Gaston County; Specifically, to Endorse the Fire Service Application for a 2016 FEMA Assistance to Firefighters Grant and to Provide the Required 10% Matching Funds Not to Exceed \$200,000

Chairman Keigher noted that he has received calls from several mayors and city managers in the last couple weeks; expressed his concerns for obtaining funding for the project in light of the \$40M school bond allocation; suggested removing the designation of VIPER in the resolution.

Chairman Keigher called for a motion for the purpose of discussion. Commissioner Brown introduced the motion and Commissioner Fraley provided the second.

Commissioner Brown noted the matter has undergone a diligent evaluation process for more than three years; old system is antiquated and costly to maintain, specifically since the City of Gastonia left the County system and contracted with UASI; the State has recognized VIPER as its system and the application is for a State recognized grant through the Federal Government; County Managers Office sent a letter to all of the municipal managers in April, 2016. After briefly discussing financial impacts, he concluded that that during a UASI meeting this week, the Charlotte representative indicated that in a catastrophic event/high priority call in Gaston County, UASI wouldn't have enough room for everyone and would have to switch over to VIPER.

Commissioner Fraley asked Chief Jeff Cash, Cherryville Fire Department, to address any questions that the BOC may have regarding the grant.

Chief Cash stated he was approached by the Fire Fighters Association to be the host for the grant; grant deadline is next week; clarified to the BOC that the grant is \$1.7-\$1.8M; the grant would buy the majority of the radios needed for fire service in Gaston County; since VIPER is a state-wide system, the grant application would be merited with more point value; UASI is a regional system; interoperability is the number one priority in this FEMA grant program; the grant must be hosted by a fire department (cannot be done by the County Fire Marshal's office or other agency); demographics for the grant cover the entire County. Regarding the one-year time period, he noted that the grant program allows for extensions as long as steps for implementation are being taken.

Chairman Keigher received an affirmative response that if the radios were purchased before the system, they would be conducive to either system.

With discussions coming to a close, Chairman Keigher called for the vote.

On motion introduced by Commissioner Brown and seconded by Commissioner Fraley, the BOC unanimously approved Resolution **2016-318** as follows:

WHEREAS, the citizens of Gaston County are currently protected by an antiquated and obsolete UHF/VHF emergency services radio system that is approaching 15 years of service and becoming increasingly difficult to maintain adequately: and

WHEREAS, in September 2013 a multi-agency subcommittee of public safety officials along with County staff was commissioned to evaluate available options for the next generation emergency services radio system platform; and

WHEREAS, following an extensive evaluation of multiple system options the subcommittee voted unanimously to designate the NC VIPER system as the preferred system for implementation; and

WHEREAS,
due to the predicted cost burden, it was deemed to be in the public interest for all agencies to develop creative funding sources where possible, and specifically for the fire service, to collaboratively seek a Joint Regional Federal Emergency Management Agency (FEMA) Assistance to Firefighters Grant (AFG) to more cost-effectively purchase and install the county-wide VIPER radio system; and

WHEREAS, the FEMA AFG program limits such radio system grant awards to non-infrastructure purchases to a maximum of \$2 million dollars and requires the regional grant partners to provide a one-time 10% fund

NOW, THEREFORE, BE IT RESOLVED, that the Gaston County Board of Commissioners wishes to designate the NC State Highway Patrol Voice Interoperability Plan for Emergency Responders (VIPER) as the next generation emergency services radio system platform and to endorse the county-wide fire service bid for a Joint Regional Federal Emergency Management Agency Assistance to Firefighters Grant by providing the required 10% matching grant funds not to exceed \$200,000 dollars.

Chairman Keigher called for a motion for the purpose of discussion. Commissioner Brown introduced the motion and Commissioner Carpenter provided the second.

Chairman Keigher stated his concern is not related to the system but with the lack of a funding.

The County Manager indicated that long term financing has been identified for the infrastructure (approximately \$7M or half the cost); could finance the \$7M for a 10-year period; would have an impact on the overall debt service; with the issuance of the \$40M new school bonds, it will be challenging financially for the next several years, however it can be managed; need a new public safety radio system – current system is fifteen years old and is not state-of-the-art; maintenance of the infrastructure under the current contract is inadequate; BOC recently approved \$65,000 to take some corrective action to get through another couple years; many good reasons for moving forward and is confident the County can find a way to make it work.

Commissioner Brown stated his belief that there is a substantial amount of money that will be saved each year by going with the VIPER system; the money used to pay Gastonia would overwhelmingly help offset the debt service.

Commissioner Fraley asked the County Manager to confirm that \$1.6M was spent last year in maintaining the current system; the County Manger replied "yes" and confirmed that there was a "100% probability" that amount would be spent in the coming year as well.

With discussion coming to a close Commissioner Philbeck called the question.

Chairman Keigher called for the vote, and Resolution **2016-319** approving the Purchase/Replacement of the Public Safety Radio System with the NC VIPER System, which Includes the System Infrastructure and the Replacement of 1800 County Handheld and Mobile Radios and Includes a 12-Channel, 8-Site Simulcast System with 25 Consoles (The total estimated cost of the system is \$15,135,500), was adopted unanimously. **Chairman Keigher failed to vote, therefore his vote is cast with the majority.
