BACKGROUND

The State of North Carolina Department of Veterans Services has made a distribution of grant funds to those North Carolina Counties which: (1) Fund and operate a County Veterans Services Office, and (2) Submitted a timely application for a portion of the available funds. Gaston County applied for a share of the grant funds. The application was accepted, and on or about April 14, 2016, \$3,813 was directly deposited to Gaston County's account.
