Following award, it is expected that the acquisition of right-of-way, bidding, and construction of the project will take twelve (12) months.

Project Description Overview:

Summary:

The project consists of the construction of 4,332 linear feet of primarily 18" (with some 12") PVC, underground, sanitary sewer main linking the Town of Dallas sanitary sewer collection and treatment system to the Two Rivers Utilities (Gastonia) Long Creek Wastewater treatment plant. The portion of the line that falls within the jurisdiction, and is the economic responsibility of, Two Rivers (Gastonia) is 810 linear feet, or approximately 18.7%. Conversely, the line portion which falls within the jurisdiction, and is the economic responsibility of, the Town of Dallas is 3,552 linear feet, or approximately 81.3%. The overall estimated construction cost of the project is \$640,589.00 – with the Dallas portion accounting for \$500,116.00 of the total, and the Two Rivers (Gastonia) portion making up the remaining \$140,473.00. All of the engineering and design work for the project is complete – meaning the project is ready for bid upon the securing of complete financing; as is the preparation of the surveyed, Right-of-way maps -- which will allow for the rapid acquisition of the necessary right-of-way easements from seven (7) identified property-owners. Once in place, the line will have the capacity to carry a "peak-flow" of 1.97 MGD (million gallons per day) of effluent produced by the Dallas Collection system for conveyance to the Long Creek plant for treatment. Total treatment capacity at the Long Creel Plant is 16MGD; with approximately 50% (8MGD) of such capacity deemed excess and currently unused. The City of Gastonia (Two Rivers) and the Town of Dallas have jointly funded the engineering work completed to date and have further agreed to each cover the construction costs of the portion of the line falling within their individual jurisdiction(s). By unanimously-adopted resolution of the Board of Aldermen on November 10, 2015, (copy attached) Dallas has committed to cover all portions of its construction cost obligations exceeding the \$300,000 being sought from the County by this request. The City of Gastonia, and by extension, its Two Rivers Utility System/Fund, is responsible to cover the complete cost of its portion of the project (letter of commitment attached).

By completing the inter-connect line, the following outcomes will be achieved:

- The Town of Dallas will achieve 100% redundancy ("back-up" capacity) to its treatment system assuring that the environment will be protected from over-flows or discharges that would otherwise occur in the event of a disruption in operations at the Dallas Wastewater Treatment Plant.
- The Town of Dallas could support large-scale industrial and economic development growth knowing its collection system could be expanded beyond its current treatment capacity – given the inter-connection to the Long Creek Plant.
- The physical infrastructure would be in place to allow Dallas and Gastonia (Two Rivers) to negotiate the long-term consolidation of their treatment and/or collection systems—possibly also allowing for the elimination of the Dallas Treatment Plant discharge into the South Fork of the Catawba River.
- The cause of County-wide Water/Sewer would be further supported and enhanced.
- Economic efficiencies and economies of scale would be achieved in overall treatment, benefitting both Gastonia and Dallas residents and rate-payers by keeping costs lower than with separate, independent treatment systems.

1. Impact:

The 2010 Census lists the Dallas Township population as 21,436. Something over 7,000 of those residents are either already served by the Dallas wastewater collection and treatment system, or could be served by an "inter-connected" system that would have access to greater capacity as a result of such "inter-connection". As such, a full One-Third (33%) of all Dallas Township residents would be impacted. In addition, in Gastonia Township (2010 census: 85,249) nearly all of the residents of the city of Gastonia (beneficial owners of the Two Rivers Utility system and Long Creek treatment plant) whose 2010 Census population is listed as 71,741, (84% of Township) would indirectly be impacted by, and benefit from the inter-connection to Dallas.

2. Sustainability:

This one-time, public infrastructure project, once-completed, would be 100% sustainable without any further County financial support. The inter-connect line would be owned and/or maintained by the Town of Dallas and Two Rivers Utility, either individually or collectively in perpetuity.

3. Match/Leverage:

Total Project cost for the construction of the Inter-connect line is estimated at \$640,589.00; and the Township Grant Application Request is for \$300,000 – meaning that \$340,589.00, or 53.2% of all required funding will come from sources other than Gaston County. (Dallas: \$200,116.00 and Two Rivers (Gastonia): \$140,473.00).

4. Job Creation/Economic Development:

Initially, the \$640,589.00 construction project will mean that a local or regional underground utility contractor/firm will provide or support 8-10 construction jobs for 8-10 months. However, of greater importance and impact is the significant areas around the current Dallas collection system boundaries where sewer line expansions could occur to serve economic development knowing such areas then became effectively "inter-connected" to the large amount of excess treatment capacity at the Long Creek Plant.

5. Education:

There are no immediately-identified gains to primary, secondary, or higher education as a result of the project. However, the longer-term positive effect on economic development could serve the cause of financial support to education in the County.

6. Quality of Life/Health/Safety:

This project significantly lowers the risk of environmental damage from overflows or discharges occurring as a result of disruptions to operations at the Dallas treatment plant and as such is enthusiastically supported by the NCDENR. In addition, it offers the future prospect of completely eliminating the treatment plant discharge into the South Fork of the Catawba River authorized for ongoing operation of the Dallas Plant. Its possible enhancement of economic development also bodes well for a general enhancement of the quality of life for the Dallas area and Gaston County as a whole.

**Resolution Requesting That the Gaston County Board of Commissioners Consider
The Provision of Financial Support, From Caromont Lease Proceed Revenues,
Toward The Construction of A Sanitary Sewer Inter-Connect Line Linking The
Town of Dallas to The Two Rivers Utilities Long Creek Wastewater Treatment
Plant.**

Whereas, The Town of Dallas and the City of Gastonia, through its Two Rivers Utility, have worked jointly and cooperatively over the past several years to plan for, design, and engineer a sanitary sewer inter-connect line linking the Town of Dallas Waste-water collection system to the Long Creek Waste-water treatment plant; and,

Whereas, such an inter-connect would provide a critically-important back-up for the Town of Dallas in the event its waste-water treatment plant operations were compromised, disrupted, or ultimately discontinued in the cause of utility consolidation and environmental stewardship; and,

Whereas, both the City of Gastonia and Town of Dallas are committed to seeing this multi-jurisdictional infrastructure project completed – having each contributed financially to fully complete the design engineering for the project – however, the estimated \$640,000 construction cost (of which \$500,000 is the Town of Dallas Share; and \$140,000 is the City of Gastonia/Two Rivers) is precluding the project from moving forward; and,

Whereas, If the Gaston County Board of Commissioners would consider and approve a contribution of \$300,000 toward the Town of Dallas' \$500,000 inter-connect line cost-share, from the recently-negotiated Caromont Lease Proceeds Revenues, then the Town of Dallas would commit the remaining \$200,000 from its Water/Sewer Fund Balance, which, along with the City of Gastonia' commitment of its \$140,000 cost-share will allow this "shovel-ready" project to move forward quickly; and,

Whereas, the long-term cause of utility consolidation and County-wide water and sewer would be furthered by this high-priority project while also supporting economic development within the greater Dallas area by linking the significant excess treatment plant capacity at the long Creek Plant to the Dallas collection system.

Now Therefore Be It Resolved: The Town of Dallas, by the affirmative vote of its Board of Aldermen does hereby officially request that the Gaston County Board of Commissioners Approve the Contribution of \$300,000 toward the Dallas cost-share of the Long Creek sanitary sewer inter-connect line linking the Dallas sanitary sewer collection system to the Two Rivers Long Creek Waste-water treatment plant, and in turn, the Town of Dallas does hereby commit to provide the remaining cost-share funds (estimated to be \$200,000) from its Water/Sewer Fund Balance and only further dependent upon the City of Gastonia/Two Rivers Utility providing for its \$140,000 cost-share.

Dear Mr. Palenick:

On December 13, 2013, the City of Gastonia and the Town of Dallas entered into an agreement to design a sewer interconnection between Dallas' Wastewater Treatment Plant and Gastonia's Long Creek Outfall Sewer Line. The project was to develop a design for the repair and/or replacement of the existing (former) sewer line between our municipalities. The project as planned includes the installation of a new metering point near Robinson Clemmer Road, a new sewer line from the metering point to the Dallas WWTP, repairs to the existing sewer line from Robinson Clemmer Road to the Long Creek Outfall, and additional right-of-way acquisition as applicable.

The project length is approximately 4,300 LF of which 3,500 LF will be on the Dallas system and 800 LF on the Gastonia system. The previously estimated (total) cost for the sewer line construction is \$640,000, which includes \$500,000 for the Dallas portion and \$140,000 for the Gastonia portion. Robinson & Sawyer, Inc. prepared the design and easement maps for the project; said engineering services are completed and the Project is ready to be submitted for NCDENR permitting.

It is our understanding that Dallas will be applying for a Gaston County 'Township Grant' to fund this project in the amount of \$300,000, more specifically that the Dallas Board of Aldermen have formally resolved to cover all "Dallas" proportional costs over and above the \$300,000, and are requesting that Gastonia commit to cover the estimated \$140,000 portion of the project allocated to it. Accordingly, contingent upon the execution of the applicable interlocal agreement between Dallas and Gastonia, we support the application for the Project as outlined above, and we look forward to continuing our partnership in completing this regional sanitary sewer interconnect.

High Shoals is currently conducting business out of a single wide modular office building. We only have two businesses in the City of High Shoals and they are located in the only two commercial structures in our city limits. We have two major obstacles we are trying to overcome. One is that it is very difficult to attract businesses while representing our city out of a single wide modular unit and that if we were able to convince someone to bring their business to High Shoals we have no available structure for them to occupy.

The current City Hall is located on a 1.58 acre parcel owned by the City of High Shoals. Our plans for this parcel is to construct an attractive modern designed brick City Hall with a Clerk's Office, Council Offices, a Small Meeting Room along with a Council Chambers/Community Meeting Room. Our plan is once City Hall is paid for we construct a second building for flex space with the intent of attracting new businesses to High Shoals. We hope to repeat this process as each additional structure is paid off until we max out the 1.58 acre parcel, with the intent of making High Shoals an economic center for the northern portion of the County.

We are currently working on obtaining the adjacent 30 acre parcel, the old mill property, and developing it with a Brown Field Grant. We hope to develop this parcel for commercial and recreational use. An established central business center on our current 1.58 acre parcel will further help enhance the development of the mill property.

This would be a 15 to 20 year plan with us unable to start the 2nd phase (constructing the first flex space building) for five years, the time we it would take to pay off City Hall, without any help from the County.

If we were awarded this grant from the County we could possibly start the 2nd phase within the next twelve months allowing us to start growing our economic center enhancing not only High Shoals but creating a very large economic benefit for this area of the County. We have experienced asset growth over the past few years and these projects will enhance this growth greatly.

WHEREAS, The City of High Shoals is planning for economic growth to be established from the building of the new city hall

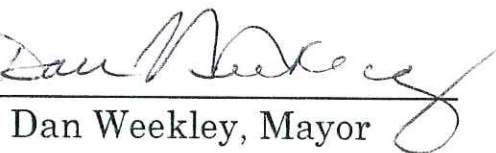
WHEREAS, The City of High Shoals is looking toward the future and being proactive in the development of new businesses in the area

Description of Proposed Program

The Dream Center of Gaston County is committed to addressing the physical, educational, and spiritual needs of impoverished families, to break the cycle of dependency, both government assistance dependency and substance abuse, through education.

The **Dream Center Academy** is a college access mission of the Dream Center of Gaston County that will empower students in Gaston County:

to **LEAD** - to **SUCCEED** - to **SERVE**

1. By developing real world leadership experiences and skills.
2. Through academic excellence and perseverance.
3. By actively contributing to the world around them.

What is the Dream Center Academy?

The DCA is a College Access Program for Title 1 students in Gaston County Schools. DCA will take 50 6th grade students per school year beginning in 2016 and add 50 more 6th grade students in 2017 and each year beyond. In 6 years, the Dream Center Academy will have 400 students in the program from 6th – 12th grade.

The DCA will involve **daily after school tutoring** with credentialed teachers and a **hot meal** for the students. The tutoring will be from 3:30pm – 5:30pm.

The DCA will take students on **field trips** to Washington DC, New York City, and over 30 Colleges and Universities.

The DCA's goal is to **equip** young men and women that will be the future leaders of Gaston County through educational, leadership, and character development.

Why should Gaston County give the Dream Center a Grant?

The DCA has a **\$200,000 challenge grant** from the David Belk Cannon Foundation to begin the Dream Center Academy. The grant from Gaston County would be matched and would allow the DCA to begin IMMEDIATELY! The David Belk Cannon Foundation has asked that the Dream Center raise \$200,000 and then they will release the \$200,000 challenge grant.

The Dream Center Academy will be a **unique** program in Gaston County that is very measurable and will allow the citizens of Gaston County to be able to tangibly track the benefits of the \$150,000 investment. This project can be measured every 9 weeks and will be tracked by Gaston County Schools to ensure the viability of the program.

The DCA has **partnered with Gaston County Schools** to provide a one of a kind program that will give our students a world class mentoring program that will see these children reach their God given potential.

AS SOON AS DCA GETS THE GASTON COUNTY GRANT, WE WILL HIT THE GROUND RUNNING!

Our first step will be to hire a director and begin to meet with prospective students and their families to prepare the students for the DCA beginning in August 2016.

Need for the Program

Located in the western part of Gaston County, the Dream Center is surrounded by neighborhoods that struggle with issues that face poverty stricken families. Within a three-mile radius of the Dream Center of Gaston County there are approximately 27,000 residents, **28%** of which live below the poverty level, **40%** are single mothers, **39%** do not have a high school diploma or GED, and **25%** are concerned about basic needs such as food, clothing, and shelter. These factors lead to issues with higher crime rates, lower parental participation, less support for school age children, and limited community resources.

A report released in 2014 by National Student Clearinghouse, which examined data from more than 3.5 million high school graduates, found that poverty remains a more important indicator of whether a student will go to college than high school demographics or location.

Hundreds of students in Gaston County that are born into poverty dream of what it would be like to succeed in school and wonder if they would ever be able to attend any college. The Dream Center Academy is an opportunity for students to get the tools they need to succeed in high school and ultimately graduate from college. Our goal is to help these students reach their potential and become leaders in our community.

The Dream Center Academy wants to raise high character and high integrity students who believe in the importance of owning their own education while developing a deeper understanding of their opportunity to make a difference in the world.

Objectives and Purposes of the Program

The Dream Center Academy model is based on an already extremely successful program in Durham, NC – Student U. The Durham program has seen their students grow and succeed since its inception in 2007. 100% of Student U's students have graduated from high school and 97% have gone on to attend college. Also when compared to other low-income Durham students the Student U's students outperformed on End of Grade testing. We believe we can have these great results here in Gaston County with the implementation of the Dream Center Academy.

How the Objectives and Programs will be met

The Dream Center of Gaston County is a community-based facility located at 2782 Fairview Drive in Gastonia, NC. The Dream Center Academy will work closely with Gaston County Schools to **identify the students** in most need for the program and to recommend qualified teachers and staff to ensure the students receive the highest quality education.

The Academy will consist of the following:

Year-Round Support:

1. Daily After-School Program

Students receive two hours of structured support and enrichment every school day during the year at Dream Center Academy's Year Round Program. Students begin their after-school day with a healthy snack and spend time connecting with their peers. Students then move to Study Skills where they complete their homework and

build healthy study habits. Students end their day in enrichment clubs focused on arts, STEM, leadership, character building, and/or academic intervention.

2. Out-of-School Support

Community Days allow students, families, and teachers to reconnect with the DCA community and develop a service minded character. Every 3 Week Phone Calls and Quarterly Parent Conferences between Year Round Staff and families ensure that students are receiving the support they need to become their best selves.

When necessary DCA's School Social Worker provides students and families with social and emotional support.

Summer Enrichment:

Students participate in a **five-week academic enrichment program** during the summer. Students receive project based hands-on, small group instruction. Students take core classes in **reading, math, and science**. They also will select from various different elective courses. The curriculum taught is designed using Common Core standards and written by professional education professionals. College students serve as teachers with the guidance of experienced mentor teachers.

The Dream Center Academy values "outside of the classroom" learning experiences for students. During the summer program students take weekly field trips to local colleges and community organizations. All students participate in an extended field trip where they travel outside of Gaston County to connect curriculum to the real world.

The Dream Center Academy teachers are matched with a small group of students to serve as their advisor. Teachers call the student's families once a week and write an end of summer evaluation for the students. The goal is to form a strong bond with the students and their families which will continue throughout the school year.

Organizational Information

The Dream Center of Gaston County was established in 2013, based on a model used by more than 150 Dream Centers located throughout the United States. The organizational model has been **proven** to provide a positive impact on **breaking the cycle of poverty** in economically distressed and high crime neighborhoods across the country. We are partnering with local agencies such as **Crisis Pregnancy Center, Gaston College, As One Ministries, CaroMont Health, and Gaston County Schools** to provide programs and services on a daily and weekly basis. The Dream Center of Gaston County has quickly become a premier resource for families seeking a **helping hand** rather than a handout to empower their families to achieve higher goals.

Our mission is to empower families to achieve self-sufficiency through programs that focus on three key objectives: education, character development, and spiritual mentoring.

Together we can make a difference in our community!

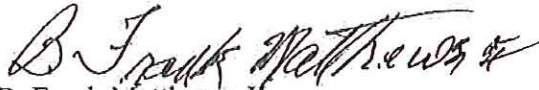
