- 3. The service side arm, GLOCK, Model 45MOS, Serial Number BYRV600 and Aimpoint Acro P2 be permanently retired by the Gaston County Sheriff's Office and offered to Sheriff Cloninger for a purchase price of \$1.00.
- 4. The Gaston County Sheriff's Office is proud to award Sheriff Cloninger with the service side arm and badge as specified and worn by him during his service to Gaston County, in accordance with the North Carolina General Statutes and the policy of the Board.
