#### **BACKGROUND**

Each year the County receives grant funds for various juvenile crime prevention programs within the County. For fiscal year 2016, the County is required to return \$2,500 of the grant funds received for the Psychological Testing Program. These funds were unspent at June 30, 2016 and reverted into fund balance at the close of the fiscal year. The funds cannot be carried forward and must be returned to the NC Department of Public Safety. This Board Action appropriates the \$2,500 out of fund balance in order to submit the refund.
