BACKGROUND

The attached Budget Change Request corrects the original Budget Change Request by reversing the transfer from the General Fund to the Community Investment Fund by \$10,000,000. It also reverses the amounts applied to the Public Safety Chargeback and Future Capital expenditure accounts. The original Budget Change Request was only intended to appropriate the expense and revenue, to the General Fund, associated with the ARPA Standard Allowance.
