

# RESOLUTION TITLE: TO ACCEPT, APPROVE, AND AUTHORIZE THE EXECUTION OF THE KROGER OPIOID SETTLEMENT AND THE NORTH CAROLINA SECOND SUPPLEMENTAL AGREEMENT FOR ADDITIONAL FUNDS (SAAF-2)

WHEREAS,	the opioid overdose epidemic has taken the lives of more than 37,000 North Carolinians since 2000; and,
WHEREAS,	the COVID-19 pandemic has compounded the opioid overdose crisis, increasing levels of drug misuse, addiction, and overdose death; and,
WHEREAS,	the Centers for Disease Control and Prevention estimates the total economic burden of prescription opioid misuse alone in the United States is \$78.5 billion a year, including the costs of healthcare, lost productivity, addiction treatment, and criminal justice involvement; and,
WHEREAS,	certain counties and municipalities in North Carolina joined with thousands of local governments across the country to file lawsuits against opioid manufacturers, pharmaceutical distribution companies, and chain drug stores to hold those companies accountable for their misconduct; and,
WHEREAS,	a settlement has been reached in litigation against the Kroger Co. ("Kroger") as well as its subsidiaries, affiliates, officers, and directors named in the Kroger Settlement; and,
WHEREAS,	representatives of local North Carolina governments, the North Carolina Association of County Commissioners, and the North Carolina Department of Justice have negotiated and prepared a Second Supplemental Agreement for Additional Funds (SAAF-2) to provide for the equitable distribution of the proceeds of these settlements; and,
WHEREAS,	by joining the settlements and approving the SAAF-2, the state and local governments maximize North Carolina's share of opioid settlement funds to ensure the needed

#### **BACKGROUND**

Gaston County, along with other counties and municipalities in North Carolina, joined with thousands of local governments across the country to file lawsuits against opioid manufacturers, pharmaceutical distribution companies, and chain drug stores to hold those companies accountable for their misconduct.

A new Proposed Settlement has been reached in litigation against Kroger Co. (Kroger), as well as their subsidiaries, affiliates, officers, and directors named in the Proposed Settlement.

Representatives of local North Carolina governments, the North Carolina Association of County Commissioners, and the North Carolina Department of Justice have negotiated and prepared a Second Supplemental Agreement for Additional Funds (SAAF-2) to provide for the equitable distribution of the proceeds of this Proposed Settlement.

Approval of this Resolution authorizes the County Manager (or County Attorney) to execute all documents necessary to enter into the Proposed Settlement with Kroger, to execute the SAAF-2, and to provide such documents to Rubris, the Implementation Administrator.
