

BACKGROUND

Gaston County was appropriated \$7,853,000 from the Drinking Water and Wastewater Reserve in the Other Projects Category for the Dallas-High Shoals Water Line Project (Project # SRP-D-ARP-0075) The project will install the infrastructure necessary to provide water service between the Town of Dallas and the City of High Shoals.

The Dallas-High Shoals Water Interconnect Project was publicly advertised, and bids were received and publicly opened on September 11, 2025 A total of 4 bidders submitted for Contract 3-Pump Station with the results listed below Gilbert Engineering Co submitted the apparent low, responsive, responsible bid in the amount of \$1,519,287 00
