TWO INCENTIVE GRANT PURSUANT TO N.C.GEN.STAT. §158-7.1 AND TO AUTHORIZE GASTON COUNTY TO ENTER INTO AN ECONOMIC DEVELOPMENT AGREEMENT (EDA)

WITH PROJECT NEXUS

WHEREAS, Project Nexus is considering a total investment of \$27,000,000 to establish a 170,000

square foot warehouse and distribution facility near Cox Road, with the expectation to

complete this investment on or before December 31, 2026; and,

WHEREAS, North Carolina General Statute §158-7.1 authorizes a County to undertake an economic

development project by providing grants for the location of industry; and,

WHEREAS, Gaston County developed an economic grant policy to provide global advanced

manufacturing companies and distribution facilities with incentives to develop high quality

industries within the County; and,

WHEREAS, it is anticipated that the Firm's capital investment in and at the Property thereat will

generate significant ad valorem tax, sales tax and other revenues to the County and will

qualify for a Level One or Level Two Incentive Grant; and,

WHEREAS, the County will prepare a detailed Economic Development Agreement (EDA), between

Project Nexus, the County and the City of Gastonia, so as to induce the firm to generate significant capital investment in a facility which will enhance the County's ability to attract

additional business and industry which provide good job opportunities.

NOW, THEREFORE, BE IT RESOLVED that the Gaston County Board of Commissioners approves a Level
One or a Level Two Incentive Grant, as determined by County policy, and authorizes the

Chairman, Vice-Chairman or the County Manager to execute any documents necessary

to complete an Economic Development Agreement for Project Nexus.
