BACKGROUND

Gaston County's Department of Health and Human Services and Social Services (DHHS) was awarded State Disaster funds for rental assistance due to Hurricane Helene. Gaston County's original funding award has been reduced due to a reallocation of funding done by the State. The original award amount for the Disaster Rental Assistance Grant, accepted and appropriated on January 28, 2025 (Res. 2025-010), was \$45,646.00. This amount was reduced on March 25, 2025 (Res. 2025-074) by \$30,000. The latest two reductions were \$13,000.00 in March 2025 and another \$1,446.00 in May 2025 totaling an additional \$14,446.00 reduction. The new revised award amount is now \$1,200.00.
