BUDGET IMPACT

General Fund: Increase federal grant revenue by \$10,643. Increase ARPA State Aid to Libraries expenses by \$10,643.

BACKGROUND

To amend the Grant Contract between the Department of Natural and Cultural Resources and Gaston County Library where the Library was originally awarded \$142,871, an additional \$10,643 has been added. Both parties agree to show amount awarded as \$153,514 and that awarded funds are to be used for materials, salaries, equipment, and operating costs which are consistent with allowable uses outlined in 07 NCAC 021.0202 State Aid Grants from the Aid to Public Library Fund.
