- 3. The service side arm, Glock, Model 45, Serial Number BRTV324 be permanently retired by the Gaston County Police Department and offered to Officer Robinson for a purchase price of \$1.00.
- 4. The Chief of the Gaston County Police Department is directed to award Master Police Officer Robinson with the service side arm and badge as specified and worn by him during his service to Gaston County, in accordance with the North Carolina General Statutes and the policy of the Board.

BE IT FURTHER RESOLVED that the Gaston County Board of Commissioners expresses their sincere gratitude for the dedicated service of Master Police Officer Ronald D. Robinson and wishes him the best in his retirement.
