The Gaston County Board of Commissioners (BOC) met in Regular Session on March 28, 2017 at 7:16 pm, immediately following the Work Session, in The Harley B. Gaston, Jr. Public Forum, Gaston County Courthouse.

Chairman Chad Brown presided with Commissioners Ronnie Worley, Vice-Chairman; Don Grant, Bob Hovis, Tom Keigher and Tracy L. Philbeck in attendance.

Commissioner Allen R. Fraley was not in attendance.

Others present included Earl Mathers, County Manager; Charles L. Moore, County Attorney; and Donna S. Buff, Clerk to the Board.

Upon request of Chairman Brown, Commissioner Hovis led those assembled in the Invocation and Commissioner Worley led in the Pledge of Allegiance during the preceding Work Session.

Chairman Brown announced the Public Hearings as advertised; explained procedures to be used; called for the motion to enter into Public Hearings.

On motion introduced by Commissioner Worley and seconded by Commissioner Keigher, the BOC unanimously entered into Public Hearings.

<u>Public Hearing Continued from the Regular Meeting of February 14, 2017 - Parallel Conditional Use Permit PCUP17-01 - Gastonia Solar Center, LLC (Applicant); Property Parcel 139183 Located at 609 Neal Hawkins Road, Gastonia, NC, Request for a PCUP Zoning District from the (RS-12) Single Family 12,000 Square Feet District to a (CU/R-2) Conditional Use / Single Family Moderate Zoning District (PCUP), Essential Services Class 3 Facility (Solar Farm)</u>

Chairman Brown advised that a PCUP was a quasi-judicial process requiring sworn testimony of any speakers; asked if any Planning Board members or Commissioners had any reason not to rule in the case; with none being heard, the Chairman then impaneled the Planning Board and Commissioners to hear the request; called for any attendees wishing to give testimony to please stand; he then administered the oath to those standing and provided additional directions for the procedure.

With a quorum of the Planning Board in attendance, Chairman Brown recognized Mr. Willie King, Planning & Development Services Manager, for comments.

Mr. King cited application information as outlined and set forth above and presented as follows: property owner - Evangelical Assembly of God (Generation Church of Gastonia); property location - Neal Hawkins Road; current zoning - RS-12 (single family limited) at 12,000SF; request is to rezone property to a Parallel Conditional Use District CU/R-2 single family moderate; involves approximately 34.59 acres for a solar farm categorized in Unified Development Ordinance (UDO) as an essential services class three; proposed plan was provided in advance to the TRC (Technical Review Committee) and if approved will be sent back through each reviewing agency, Building Inspections and the Planning Office prior to starting the solar farm; reviewed vicinity and aerial maps depicting property off Neal Hawkins Rd., street networks, property boundaries, surrounding zoning, existing buildings and vegetation, neighboring residential

properties and the proposed solar farm facility; advised staff had received a revised, more readable site plan map than the one in BOC's packet.

On motion introduced by Commissioner Philbeck and seconded by Commissioner Keigher, the BOC unanimously accepted the revised site plan map, Exhibit One, as information.

Mr. King further advised the Applicant would also speak to the plan in his comments; a type "A" screening is required for essential services class three per UDO; condition #7 (to comply with applicant decommission statement as included in the application) was added to proposed conditions that staff, developer and Applicant had discussed, negotiated and agreed upon; property is located in southeast small area and is also known as "Garden Gaston"; staff contacted City of Gastonia whose jurisdiction neighbored the subject property; MPO transportation comments were included in BOC packets; the proposed rezoning and permit request is consistent with Comprehensive Land Use Plan (Comp Plan); things important to citizens in this area of the County is to maintain quality of life, better connectivity and road improvements; notices were provided per County policy; when this application was tabled last month, the Planning Department notified the adjacent property owners again as to the continued meeting but the February 14<sup>th</sup> date was inadvertently was left in the letter; however, additional letters were sent to help ensure that citizens knew the hearing was continued to this date; staff received five calls for information; the applicant will address information related to the findings of fact.

Chairman Brown asked the Applicant to provide any pertinent information to the BOC.

Mr. Peter Davis, Applicant and Inter Park Inc. employee, advised the solar developer engineering, procurement and construction firm is a vertically integrated solar company - from greenfield development to financing and ownership of facilities; solar panels contain no chemicals or toxic materials; silicon is the main element and it is enclosed and sealed between tempered glass and a teflon back sheet; everything else is common materials (transformers and low voltage cabling); will operate at roughly 1,000 volts until the energy is exported off the site to a substation that is directly adjacent to this project site and will match the low-end voltage to the substation of 12,470 volts; components in solar facility will adhere to the national electric code, state/federal/local building permit reviews and plans be UL listed; the use meets (and in some cases exceeds) all required conditions and specifications; the design layout meets the Ordinance's 50' setback from property line or any right-of-way; will remove some trees and keep some areas as a natural vegetative screen via type "A" and "B" screenings (as outlined on site map); submitted a property appraiser report with application and a certified property appraiser is present to answer any questions about report; this site was chosen for a utility scale solar project because it was next to Duke Energy's 500 kV transmission substation and the surrounding vegetation; the four-month construction period will create about 40 local temporary construction jobs involving driving galvanized steel aluminum framing piers 6' or 7' into ground and bolting panels on top of framing to track sun's path from east to west; during operational period the site will be unmanned and the performance of the system will be remotely monitored by computers; no personnel on site virtually manned; will perform preventative maintenance two or three times per year and wash panels if needed; it will be a quiet operation and a visibly limited neighbor to the community; will sign a guaranteed contract with Duke Energy once the interconnection studies are completed and afterwards an energy sales agreement; will have a 15-year contract although the system can operate up to 30 years; assuming a 30-year operation, projecting \$830k in property tax revenues;

also have a land lease agreement with Generation Church of Gastonia to receive monthly lease payments for use of property during the 15-20 year period; site will generate clean, emissionsfree energy and the fixed pricing will remain the same for 15 years.

Chairman Brown called for questions from the Planning Board; hearing none, called for questions from the BOC.

Commissioner Grant asked how many acres/panels the project would involve.

Mr. Davis responded roughly 30 acres/8,000 panels.

Commissioner Philbeck addressed representatives from the Church and advised that if a portion of church property is used for business, the tax exemption would be removed; a Church representative, who had been sworn in earlier, indicated from the audience that they were aware of the stipulation.

Mr. Davis added that the church had leased it out for other purposes in the past and was aware of condition.

Hearing no other comments, Chairman Brown moved to the next item of business.

Public Hearing - Zoning Map Change Z17-04 - James B. Galloway and Christine Galloway (Applicants); Property Parcel193091, located at 200 Crawford Road, Gastonia, NC, Rezone from the (R-1) Single Family Limited Zoning District w/US Overlay to (R-2) Single Family Moderate Zoning District w/US Overlay

Mr. King cited application information as outlined and set forth above and presented as follows: subject property is currently zoned R-1 (single family limited within U.S. Overlay); proposal is to rezone property to R-2 (single moderate district within US Overlay); involves approximately 7.19 acres; currently property is undeveloped; reviewed vicinity map, zoning review map and aerial map depicting property location, surrounding zoning (R-1 and C3), CH overlay, City of Gastonia's jurisdiction and street network; property is located within northeast riverfront Gaston small area; proposed map amendment is consistent with Comprehensive Land Use Plan; issues that citizens indicated were important include maintaining quality of life and further connectivity in road improvements; no municipal coordination was required; staff received no calls about application.

Chairman Brown called for citizen comments and for questions from the Planning Board; hearing none called for questions from the BOC.

Commissioner Hovis advised that the interior parcel did now show a right-of-way (r-o-w).

Mr. King advised there is an existing easement that allows access to the property.

Commissioner Hovis advised that the interior parcel did not show a r-o-w; asked if there were plans to put in a 450' dedicated r-o-w to meet state standards.

Mr. King responded there is an existing easement that allows access to the property; staff can look at r-o-w issue, but something would have to be worked out with landowners to acquire that additional land to Crawford Road.

Commissioner Brown asked for confirmation that the Applicant did not own any parcels inside the area on map.

Mr. King responded that is "correct, to the best of my knowledge".

Chairman Brown agreed that the easement does not provide the Applicant a way on to the property; called the Applicant to the podium.

Mr. James Galloway, 80 Linestowe Dr., Belmont, Applicant and owner of subject property stated that the northern most portion of lot #4 had a deeded 15' r-o-w into it off Crawford Road; it is basically 220' but the property line is in the road.

Chairman Brown asked what the differences were for the R-1 and R-2 zoning.

Mr. Galloway advised the property was sold to him as unrestricted land; however, R-1 zoning is restrictive – it allows modular homes but not mobile homes and doublewides; there is a \$50k difference in the same footprint of a modular home and a doublewide and that is the purpose of the rezoning request.

Hearing no further comments, Chairman Brown excused the Planning Board to Room 2029 for deliberations.

<u>Public Hearing – Re: Commissioner Hovis – To Support and Approve Resolution Authorizing a One-Time Eligibility for the Osage Mill Redevelopment Project's Legal Entity in Gaston County's Local Investment Grant Program</u>

Chairman Brown introduced the County Attorney for comments.

The County Attorney advised The Osage Development in Bessemer City requested to be qualified for a local economic development grant that the County provides as part of its economic development policies; this "one-time" eligibility project is unusual because these grants are typically available for manufacturing facilities, and the amount received depends on the taxable value of the property; this request was advertised in accordance to statute. Mr. Donny Hicks, Economic Development Director, is present with the Development Team to provide more details about the project.

Mr. Josh Ross, Bessemer City's Economic Development Officer, thanked the BOC for considering the Resolution for a one-time use grant; advised they have been working on project over two years; this project will positively impact the downtown region and community; the Bessemer City Council will consider adopting this Resolution at its April 10<sup>th</sup> Regular Meeting. He introduced the Development Team members, namely: Dr. Ganesan (Dr. Vish) Visvabharathy, President of Hawthorne Development; Guru Naganathan, Hawthorne Development Partner and

Developer; Denise Shaw, Developing Partner; Mayor Becky Smith of Bessemer City; Victoria Rittenhouse, Centralina Council of Government's Community and Economic Development Director and consultant to Bessemer City; and Mr. Donny Hicks. He deferred to Dr. Vish to speak about the project and to answer any BOC questions.

Dr. Vish advised that Hawthorne Development has developed around \$800M in projects in the past 27 years; have another \$200M in the project pipeline involving 4,000,000SF and another 1,000,000SF; received several awards for quality construction; have operated in Illinois, Florida, Chicago and down state; total Osage Mill project cost is about \$40M for 175 multifamily rentals, 105 affordable units and 28,000SF of retail manufacturing areas; preliminary study shows that the impact of direct, indirect and induced jobs of this development is about 300; construction is estimated to start in 2017 and be completed in 2018; this project will create an economic engine of 500 new residents by adding 10% to Bessemer City's population of 5,000; company restores historic national landmarks, is green friendly and very much sustainability driven; it will be a netzero building because the energy needed for the project will be produced on site: this will demonstrate the viability of clean energy, net-zero and cost savings in affordable housing market for the first time in NC; it will be the largest net-zero commercial project in NC; will use solar and geothermal for energy savings and some of the savings will be passed on to low-income residents; entered project in a contest sponsored by the Department of Energy for creating solar for affordable housing residents and will know the results soon. He reviewed pictures depicting roof and interior damage, asbestos issues, site plan of building and parking lots, rendering of how building will look with solar installation in parking lot and on the roof; this request is to be eligible to participate in County's investment grant program to revitalize Bessemer City's downtown area and to create new growth and development in the County and Bessemer City.

On motion introduced by Commissioner Hovis and seconded by Commissioner Philbeck, the BOC unanimously accepted the handout (presentation slides) as information.

Chairman Brown called for citizen comment; hearing none, called for questions from the BOC.

Commissioner Hovis advised the Osage property was built in the late 1890s; opened in 1908 as The Southern Cotton Mill by Mr. John Smith, founder of Bessemer City; this is a great opportunity to repurpose the building into housing for the community; was employed 20+ years by the Reeves Brothers company – operators of the plant for 60+ years; attended Bessemer City's annual Retreat last month where issue was discussed; Mr. Hicks was there also; Bessemer City has worked hard on this for two years; this is an excellent example of a private investment group doing what is needed to understand the depth and breadth of a project.

Commissioner Keigher recalled attending the rollout meeting in September and thought this was a great proposal; advised the County's growing age group is 60+; the County is going to have an affordable housing issue with people living to their 80s, 90s and beyond; cited a similar project developed in the early 2000s in Gastonia and noted that the County has many buildings where this concept can be used.

Commissioner Worley asked if the contest involved a grant award for the winner.

Dr. Vish responded "no"; it is not like a grant; they call it a prize.

Mr. Naganathan responded "it is possible"; contests that have no monetary award, often gain recognition from a private investment perspective.

Hearing no further comments, Chairman Brown called for a motion to approve.

# 2017-050 Commissioner Hovis – To Authorize a One-Time Eligibility for the Osage Mill Redevelopment Project's Legal Entity in Gaston County's Local Investment Grant

On motion introduced by Commissioner Hovis and seconded by Commissioner Grant, the BOC unanimously approved Resolution **2017-050** as follows:

- WHEREAS, the Osage Mill Redevelopment Project's Legal Entity is considering an investment of \$38,600,000 to redevelop a former textile mill located at 201 S. Twelfth Street in downtown Bessemer City, into a commercial and residential mixed use project; and,
- WHEREAS, the Osage Mill Redevelopment Project in downtown Bessemer City will greatly assist the City's revitalization efforts by stimulating the local economy; and,
- WHEREAS, North Carolina General Statute §158-7.1 authorizes a County to allow eligibility of an economic development project in a local investment grant program for the purposes of rehabilitation of existing structures; and,
- WHEREAS, the Gaston County Board of Commissioners finds that it is in the best interests of the County to provide a one-time eligibility of the Osage Mill Redevelopment Project's Legal Entity to participate in the Gaston County Local Investment Grant Program; and,
- WHEREAS, an Economic Development Agreement between the City of Bessemer City, Gaston County and the Osage
  Mill Redevelopment Project's Legal Entity, to allow a one-time eligibility to participate in the Gaston County
  Local Investment Grant Program by April 15, 2022, will be written and agreed to by all parties; and,
- WHEREAS, the Gaston County Board of Commissioners has held a public hearing to consider whether to approve the authorization of a one-time eligibility for the Osage Mill Redevelopment Project's legal entity in Gaston County's local investment grant program to Osage Mill Redevelopment Project's Legal Entity.

NOW, THEREFORE, BE IT RESOLVED, that Gaston County Board of Commissioners:

The Chairman of the Gaston County Board of Commissioners is authorized to:

Execute a three-party Economic Development Agreement for this one-time eligibility for the Osage Mill Redevelopment Project's Legal Entity to participate in the Gaston County Local Investment Grant Program.

# <u>Public Hearing – RE: Commissioner Keigher - To Support and Approve Resolution to Authorize Gaston County to Spend \$55,000 for North Carolina Highway Study with the City of Gastonia</u>

Chairman Brown introduced the County Attorney for comments.

The County Attorney advised that all expenditures for economic development purposes have to be approved subject to a Public Hearing; this particular agreement was advertised as required by statute; BOC can act on request after taking public comments.

Chairman Brown called for public comments; hearing none, called for questions from the BOC.

Commissioner Keigher asked if the study was 100% in the City of Gastonia.

Commissioner Keigher advised he was under the impression from a message he received from Mr. Michael Peoples, City of Gastonia's Interim Manager, that it was just the section through Gastonia; asked for clarification.

The County Manager advised his understanding was that it extended all the way along the NC-7 corridor.

Chairman Brown called on Mr. Donny Hicks, Economic Development Director, for clarification.

Mr. Hicks clarified the current study involves New Hope Road to the western terminus with Franklin Boulevard in Gastonia; staff studied the Lowell part of the NC-7 corridor the last time under the PPSDI (Public-Private Site Development Initiative).

Commissioner Keigher asked for the County Manager's opinion and advised he would support staff's recommendation.

The County Manager stated the project has a lot of merit since portions of that route are blighted and need redevelopment; connects with the FUSE (Franklin Urban Sports & Entertainment) District; City of Gastonia is making substantial investments in this district; there is potential for it to be developed and create a good economic stimulus through a substantial section of the County.

In response to Chairman Brown, Mr. Hicks advised the cost would be split 50/50; staff added some specific scope of work items into study that were more relevant to the County.

Chairman Brown asked if the FUSE District meets NC-7; if the County's portion of funding would fit under Travel & Tourism?

Mr. Hicks clarified the City will look at the entire scope; see it as the main access into Gastonia; the County's interest is north with NC-7 to the Ozark Avenue interchange back towards New Hope Road, where a lot of the mills have been torn down; will study for flex space and commercial use opportunities.

The County Manager advised that most of it would be looking at commercial developmental along that corridor that would not necessarily be tourism related.

Commissioner Keigher advised he supports most County projects, stated constraints on County funds and noted the eventual need to look at raising more money.

Commissioner Philbeck asked if the mills in questions were located off Groves Street (Flint Groves Mill, etc.).

Mr. Hicks responded "yes"; from New Hope, turn left onto Ozark/NC-7; the mills on left side of road and the Wix building further down, have been demolished; staff would like to do a site development plan to encourage the kind of private investment the County wants to incur there.

Commissioner Worley asked if staff planned to identify specific properties and if the study includes the engagement of property owners.

Mr. Hicks responded "it does"; the study has a section where staff would work with owners to try to encourage them to sell or develop it jointly.

In response to Commissioner Keigher's concerns, Commissioner Worley stated that the effect of that type of development would be an increase to the tax base.

Commissioner Hovis stated this is an excellent corridor to address and the conditions are right; finding a good fit will provide the County with a better marketing position.

Responding to Commissioner Grant, Mr. Hicks clarified that staff modified the scope with the City and the area in question is from Modena Street, then east to N. New Hope Road. County's interest is primarily from the former Wix mill, then east to New Hope Road, which is where the greatest commercial redevelopment potential is; the City's interest is creating a unified corridor with landscape, hardscape, lighting and a better entrance which would encourage desired type development; the County will take an engineering look at NC-7 and Gastonia's portion of the study will be to engage landowners and create a nicer streetscape and entrance into the City.

Commissioner Grant advised the area is roughly a mile in length and has two major lots that could be developed; noted that it is being bounded by the old P&N railroad tracks to the north and the southern railroad tracks to the south and inquired how much could actually be developed.

Mr. Hicks responded that is one reason staff is largely focusing on smaller commercial type users for flex space; would build one 10,000SF building and cut it into sections with 3,000SF users; County would benefit by not having to spend a lot of money for infrastructure; think there is enough depth to do these types of commercial buildings; staff will conduct some engineering to determine if we can redevelop a one-building parcel into two or three buildings and get the depth needed between the railroad and road.

Commissioner Grant asked if staff was spending \$110k to study two parcels of land for development, and if it would be better to use some staff and save that money to build something.

Mr. Hicks explained this involves studying the entire corridor from New Hope Road to where it connects on the west side of Franklin, which is the City's primary interest; the County is focusing on the section from New Hope to NC-7; have a narrow window to do something with it; the County's portion is \$55k; intent is to market and find developers that will build commercial space there; plan will also help guide the whole corridor's redevelopment.

With discussion coming to a close, Chairman Brown called for a motion to approve.

# 2017-051 Commissioner Keigher – To Support and Approve Resolution to Authorize Gaston County to Spend \$55,000 for a North Carolina Highway Study with the City of Gastonia

On motion introduced by Commissioner Hovis and seconded by Commissioner Worley, the BOC unanimously approved Resolution 2017 as follows:

- WHEREAS, the City of Gastonia and Gaston County continue to support proper planning and orderly development of our community; and.
- WHEREAS, the Corridor Study of North Carolina Highway 7, from East New Hope Road to West Franklin Boulevard, in Gastonia will greatly assist the City's development efforts by providing a way forward in an efficient and responsible manner; and.
- WHEREAS, this study will augment the existing Gaston County sponsored Public-Private Site Development Initiative (PPSDI) Study of North Carolina Highway 7 Corridor in Lowell and will help to identify additional private sector development opportunities for flexible space and potential locations for small businesses; and,
- WHEREAS, the Gaston County Board of Commissioners finds that it is in the best interests of the County to provide funding assistance for this development planning effort; and,
- WHEREAS, an Economic Development Agreement between the City of Gastonia and Gaston County to allow for meaningful input and sharing of information will be written and agreed to by all parties; and,
- WHEREAS, the Gaston County Board of Commissioners has held a public hearing to consider whether to approve the authorization of \$55,000 (fifty-five thousand dollars) from the County's General Fund to assist in funding of the Corridor Study of North Carolina Highway 7.

NOW, THEREFORE, BE IT RESOLVED, that Gaston County Board of Commissioners:

The Chairman of the Gaston County Board of Commissioners is authorized to:

Execute an Economic Development Agreement to finalize the authorization of \$55,000 (fifty-five thousand dollars) from the County's General Fund to assist in funding of the Corridor Study of North Carolina Highway 7.

Chairman Brown introduced the County Attorney for comments.

The County Attorney advised this involves the same statutory provision to advertise and conduct a Public Hearing before approving expenditures for economic development purposes; staff has done so as required by statute; spoke with Mr. Cramer about project and learned there has been no development of the scope of work or contract with MXD; requested the documentation be provided to the County as soon as possible.

Mr. Joel Long, representing the GGDC (Greater Gaston Development Corporation), advised the BOC has had the report for a couple of weeks; introduced Mr. Stuart Hair, Economic Community Affairs Manager, for The Charlotte Douglas International Airport "CLT" to answer any questions.

Commissioner Keigher introduced the motion to approve. Commissioner Philbeck provided the second for the purpose of discussion.

Commissioner Worley asked if this had been approved by the Charlotte City Council.

Mr. Hair advised that the Charlotte City Council approved and awarded a \$900k contract to MXD Development Strategists in October 2015; MXD and their sub consultants, have created a development strategy involving the land CLT owns around the airport; received final draft of the report today and MDX is implementing the plan now; realized during stakeholder conversations that there was a potential opportunity to leverage that study for development in Gaston County; that is how the study and initial scope came about – as an expansion of what The Charlotte City Council had already approved.

Commissioner Worley asked about the process for developing the study in the County.

Mr. Long advised that MDX would be partnering and already has approvals from several municipalities to proceed; involves a 50/50 partnership between municipalities and Greater Gaston Development Corporation (GGDC); CLT has agreed to partner with us to share all data to build the initial strategy; MXD will then look at the proximity to CLT and how to positively affect the development in the County as CLT markets the possibilities of development around the airport; the initial study stopped at the Catawba River.

Commissioner Worley asked if there would be a steering committee within the County and who would sit on the committee.

Mr. Long advised MDX would take the entities that are partnered on the financial end, and bring their representatives together to have a voice; BOC can elect to do that since the County is involved; currently Belmont, Mount Holly and Cramerton have already agreed.

Commissioner Hovis inquired about the progress of the West Boulevard relocation and the airport expansion.

Mr. Hair advised CLT has been working with FAA to contract for an Environmental Impact Statement (EIS) which is mandated within the National Environmental Protection Act Study; believe a contract is ready to go to the Charlotte City Council in the next couple of sessions; it will be a lengthy process (three to five years) when the EIS begins; will involve closing the crosswind runway and replacing it with a fourth parallel runway between the center runway and the western most runway; part of that EIS will study the closure of West Boulevard and possibly relocating NC-160 much further south than its existing alignment; would potentially align with road network of the private River District Development; have worked extensively in ensuring that this road network is robust enough to handle the relocation of West Boulevard to the south and any potential connection across the Catawba River.

Commissioner Hovis asked if the river district plan was still viable and robust enough to allow that thoroughfare to continue.

Mr. Hair responded "exactly"; the river district is moving forward; anticipate an announcement about first phase of project soon; additional phases would include roads that would connect into what is being done south of the airport and potentially any connectivity across the Catawba River, south of the existing Wilkinson Boulevard interchange.

Commissioner Hovis requested that the above comments be noted in the record.

Commissioner Grant asked if that could be interpreted to mean that there will be a bridge coming across the water.

Mr. Hair responded it can be interpreted to mean that CLT is intentionally studying how West Boulevard relocates and how other roads south of the airport are constructed so that it does not prevent a bridge from being constructed.

In response to Commissioner Grant, Mr. Long advised that the City of Gastonia had agreed to participate; this is an opportunity to look at the use of that land going forward via the County's close proximity to the airport.

Commissioner Worley asked for examples of similar studies that had taken place outside of Charlotte.

Mr. Hair cited examples of Denver International Airport and Edmonton, Alberta Canada.

Mr. Long advised that doing this will put the County on the CLT planning map; anyone viewing that map in future will see the connection with the County; this will be a huge benefit from a marketing standpoint.

Commissioner Hovis asked if the Charlotte Regional Partnership was participating as a subset for this activity.

Mr. Long advised the Partnership participated on the Charlotte portion of the study but is not connected to this portion.

Commissioner Brown stated he would like the Economic Development Director be part of the board.

Mr. Long responded they would welcome anyone the BOC recommends.

With discussion coming to an end, Chairman Brown called for the vote, and the BOC unanimously approved 2017-052 An appropriation, not to exceed \$45,000, for Gaston County's cost share to participate in a collaborative public-private development of a Gaston County-Charlotte Airport Economic Positioning Strategy, to be conducted by MXD Development Strategists and coordinated by the Greater Gaston Development Corporation
