The Gaston County Board of Commissioners (BOC) met in Regular Session on January 25, 2022 at 6:00 p.m., in The Harley B. Gaston, Jr. Public Forum, Gaston County Courthouse.

Chairman Chad Brown presided with Commissioners Bob Hovis, Vice-Chairman; Allen R. Fraley and Ronnie Worley in attendance.

Commissioners Kim Johnson, Tom Keigher and Tracy L. Philbeck were not in attendance.

Others present included Dr. Kim Eagle, County Manager; Courtney C. Rogers, Interim County Attorney; and Donna S. Buff, Clerk to the Board.

Upon request of Chairman Brown, Commissioner Hovis led those assembled in the Invocation and Commissioner Fraley led in the Pledge of Allegiance.

Public Hearing - RE: Commissioner Fraley - Building & Development Services - Zoning Map Change: Z22-01 Jessica Black & Joseph Dayne Sneed (Applicants); Property Parcels: 157267 and 157266, Located at 919 Tot Dellinger Rd., Cherryville, NC, Rezone from the (I-2) General Industrial Zoning District to the (R-2) Single Family Moderate Zoning District

Chairman Brown announced the Public Hearings as advertised; explained procedures to be used and called for the motion to enter into Public Hearings.

On motion introduced by Commissioner Worley and seconded by Commissioner Fraley, the BOC unanimously entered into Public Hearings.

Chairman Brown recognized Mrs. Jamie Kanburoglu, Building and Development Services Long Range Planner, for comments.

Mrs. Kanburoglu advised subject request is to rezone parcels 157267 and 157266, located at 919 Tot Dellinger Rd., Cherryville, NC, from the (I-2) General Industrial Zoning District to the (R-2) Single Family Moderate Zoning District; the Applicants/Property Owners are Jessica Black and Joseph Sneed; total acreage of parcels is 3.30 acres; current and proposed use of the property is residential; staff is currently reviewing a Recombination Application for the parcels.

She referred to the maps and advised that staff reviewed and found the application to be consistent with the Comprehensive Land Use Plan (Comp Plan) as presented; Planning Board met on January 10th and unanimously recommended approval; notices were mailed out and the property was posted per County policy.

Chairman Brown called for citizen comment and for questions from the BOC; hearing none, declared the Public Hearing closed.

Chairman Brown introduced the Interim County Attorney to provide comments on the Planning Board's recommendation.

The Interim County Attorney advised the Planning Board voted unanimously to recommend approval of the rezoning; "The proposed rezoning is in the Rural future land use plan. Residential

homes are located on large lots and are set back from the roads they front upon. It is understood that this is the default use designation for Gaston County. The use, going from (I-2) to (R-2) will make the subject parcel residential in nature, which is consistent with the Rural designation and is in harmony with uses within the immediate vicinity."

Chairman Brown called for a motion to approve.

On motion introduced by Commissioner Fraley and seconded by Commissioner Hovis, the BOC unanimously approved **2022-004**, upon consideration of the map change application, public hearing comment and recommendations from the Planning Board and Planning staff, finds:

The map change request is consistent with the County's approved Comprehensive Land Use Plan. The proposed rezoning is in the Rural future land use plan. Residential homes are located on large lots and are set back from the roads they front upon. It is understood that this is the default use designation for Gaston County. The use, going from (I-2) to (R-2) will make the subject parcel residential in nature, which is consistent with the Rural designation and is in harmony with uses within the immediate vicinity.

The Commission considers this action to be reasonable and in the public interest, based on: Planning Board recommendation and compatibility with existing land uses in the immediate area. Therefore, the map change request for property parcels: 157267 and 157266, is hereby approved, effective with the passage of this Resolution.

Public Hearing - RE: Commissioner Johnson - Building & Development Services - Zoning Map Change: Z22-02 Cleroy & Sandra Dunlap (Applicants); Property Parcel: 142291, Located at 538 Queens Rd., Gastonia, NC, Rezone from the (RS-12) Single Family 12,000 sq ft Zoning District to the (R-3) Single Family General Zoning District

Chairman Brown recognized Mrs. Kanburoglu for comments.

Mrs. Kanburoglu advised this request is to rezone parcel 142291, located at 538 Queens Rd., Gastonia, NC, from the (RS-12) Single Family 12,000 sq ft to the (R-3) Single Family General Zoning District; the Applicants/Property Owners are Cleroy and Sandra Dunlap; total acreage of property is .79 acres; currently the lot is vacant.

She referred to the maps and advised there is a mixture of single-family residences, manufactured housing and single/double-wide housing in the area; staff reviewed the application and found it to be consistent with the Comp Plan as presented: Planning Board met on January 10th and voted 5-0 not to recommend approval; notices were mailed out and the property was posted per County policy.

Chairman Brown called for citizen comment.

Ms. Arleta Nelson, 1207 Culver Spring Way, Charlotte, NC, advised she wants to purchase and place a double-wide home on the property to live next door to her sister and help care for grandmother who lives two doors down; her father owns the property.

Chairman Brown called for questions from the BOC.

Commissioner Worley asked if single/double-wide mobile homes were adjacent to the property in addition to stick built and manufactured homes.

Mrs. Kanburoglu responded "yes, sir"; there is a mixture of housing types in the area.

Hearing no further questions, Chairman Brown declared the Public Hearing closed.

Chairman Brown asked the Interim County Attorney to comment on the Planning Board's recommendation.

The Interim County Attorney advised the Planning Board voted unanimously to recommend disapproval of the request; they found it was inconsistent with the future Comp Plan. "The proposed rezoning is in the Suburban Development future land use plan. Suburban Development consists of significant single-family residential areas that exist around commercial pockets representing a standard suburban center. Suburban centers can also include multi-family houses and support services as well. The use, going from (RS-12) to (R-3) will make the subject parcel residential in nature, which is inconsistent with the Suburban Development designation and the primary commercial uses in the surrounding corridor".

Chairman Brown called for a motion to approve.

Commissioner Worley introduced the motion to approve the rezoning request and Commissioner Fraley provided the second.

Chairman Brown called for discussion.

Commissioner Hovis asked if the (R-3) zoning district allowed single/double-wide mobile homes and if the (RS-12) did not.

Mrs. Kanburoglu responded "yes, sir"

Commissioner Hovis asked if it involved the type of housing and not the residential use.

Mrs. Kanburoglu responded "correct".

Commissioner Hovis recalled that the Planning Board had stated that it is against the commercial nature of the Comp Plan.

Mrs. Kanburoglu responded it is against the surrounding commercial nature.

Commissioner Hovis advised that he supports like development in the area; going from (RS-12) to (R-3) for a single plot is spot zoning and jeopardizes the County's ordinance; Mrs. Sarah Penley, Building and Development Services Senior Planner, will explain it.

Mrs. Penley advised the (RS-12) and (R-3) zoning districts involves different lot sizes; the (RS-12) defines the lot size to 12,000SF; sometimes staff looks at the density of the lot sizes and not the types of housing when doing an overall zoning district; the neighborhood has a mixture of non-

conforming homes already; placement of the home would not be out of character for the existing housing types currently there; the Planning Board's reference to commercial uses may be due to the fact that this neighborhood is off of a major corridor (US-321 South).

Commissioner Hovis advised that the lot size for the (R-3) zoning district is 3,000SF.

Mrs. Penley clarified the lot size for the (R-3) zoning district is 30,000SF.

Hearing no further discussion, Chairman Brown called for the vote and the BOC approved **2022-005**, upon consideration of the map change application, public hearing comment and recommendations from the Planning Board and Planning staff, finds:

The map change request is consistent with the County's approved Comprehensive Land Use Plan. The proposed rezoning is in the Suburban Development future land use plan. Suburban Development consists of significant single-family residential areas that exist around commercial pockets representing a standard suburban center. Suburban centers can also include multi-family houses and support services as well. The use, going from (RS-12) to (R-3) will make the subject parcel residential in nature, which is consistent with the Suburban Development designation and is in harmony with the diversity of housing types and styles in the area.

The Commission considers this action to be reasonable and in the public interest, based on: compatibility with existing land uses in the immediate area. Therefore, the map change request for property parcel: 142291, is hereby approved, effective with the passage of this Resolution.

<u>Public Hearing - RE: Commissioner Keigher - EDC - To Authorize the Sale of Real Property for Economic Development and to Authorize a Level Four Economic Incentive Grant and a Local Match for a One NC Grant - Project Conduct</u>

Chairman Brown recognized Mr. Donny Hicks, Economic Development Commission Director, for comments.

Mr. Hicks advised that Project Conduct is a foreign manufacturing company looking to invest \$50M to establish its first U.S. facility (in Apple Creek Business Park); the County has competed against other locations and is their front runner if they can work it out; Project Conduct is considering buying 11 acres and starting construction in 2024 because of the timing of financing and construction.

He reviewed a map depicting properties sold in Apple Creek Business Park: GNT, a natural food coloring manufacturing facility from the Netherlands that opened in October; Project DUO, a US/Italian joint venture - days away from closing; Project Ashbury, another food project; Project Knoll, a German company that makes various conveyor systems and ships machines for machine tools -- that will be their headquarters, tech center, and training center; Project Conduct will be directly above it. He advised half of the park is committed by acreage and the County has sold a

little bit less than that. Project Conduct will pay about \$75k an acre; if they qualify for a Level Four Grant and the state offers them a One NC Grant, staff will ask the BOC to authorize a 5% match for the One NC Grant via the County's tax grant, which will save staff from coming before the BOC again.

Chairman Brown called for citizen comment and for questions from the BOC; hearing none, declared the Public Hearing closed.

Chairman Brown called for a motion to approve.

On motion introduced by Commissioner Hovis and seconded by Commissioner Worley, the BOC unanimously approved **2022-006** as follows:

- WHEREAS, North Carolina General Statute 158-7.1 authorizes a County to undertake an economic development project by conveying property to a company in order to cause the company to locate or expand its operations within the County; and,
- WHEREAS, Gaston County is the owner and developer of the Apple Creek Business Park, Lot 11 of which is a 18.21 acre tract; and,
- WHEREAS, Gaston County and Project Conduct have engaged in private negotiations for the conveyance of Lot 11, to the end that Project Conduct may construct a manufacturing facility on the tract, and have reached tentative agreement on the terms for conveyance; and,
- WHEREAS, the Board of Commissioners of Gaston County has held a public hearing to consider whether to approve conveyance of the tract to Project Conduct, to authorize a Level Four Economic Development Grant, and to authorize a match for a ONE NC GRANT to be provided by the State.
- NOW, THEREFORE, BE IT RESOLVED that the Gaston County Board of Commissioners:
 - Authorizes the Chairman and Vice-Chairman of the Gaston County Board of Commissioners to execute the necessary documents to convey to Project Conduct the real property more particularly described below:

- 2. The conveyance of the property to Project Conduct will stimulate the local economy, promote business, and result in the creation of 30 jobs in Gaston County that pay at or above the median average hourly wage in the County. The median average hourly wage in Gaston County, as determined by the North Carolina Employment Security Commission, is \$42,100 per year. The probable average annual wage at the facility to be constructed by Project Conduct is \$50,000. The determination of the probable average annual wage at the facility is based upon materials provided to the County by Project Conduct
- The fair market value of the property, subject to the covenants and conditions associated
 with the Apple Creek Corporate Center, is \$75,000.00 per acre. This determination of fair
 market value is based upon the sales prices of comparable tracts of land, as reported to
 the Board of Commissioners.
- 4. As consideration for the conveyance of the property, Project Conduct has agreed to construct on the property an advanced manufacturing facility at a cost of at least \$50,000,000.
- 5. As further consideration for the conveyance of the property, Project Conduct will pay \$75,000/acre, subject to survey, at closing. This facility will generate property tax revenues over the next ten years in an amount at least sufficient to return to the County the total fair market value of the property.

BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman, County Manager or designee are authorized to execute the necessary documents to apply for and commit to a matching grant of \$37,500 to match a ONE NC GRANT for Project Conduct (50% of total grant).

<u>Public Hearing - RE: Commissioner Keigher - EDC - To Approve a Gaston County Level One Incentive Grant Pursuant to N.C. Gen. Stat.158-7.1 and To Authorize Gaston County to Enter into an Economic Development Agreement (EDA) with EQUUS</u>

Chairman Brown recognized Mr. Hicks for comments.

Mr. Hicks advised EQUUS, a Philadelphia based development group, is building a 300,000SF spec building in Kings Mountain; the shell is already completed; EQUUS is asking the County to agree (confirm) they qualify for a Level One Incentive Grant and an Economic Development Grant (EDA) to provide assurance to the tenant.

Chairman Brown called for citizen comment and for questions from the BOC; hearing none, declared the Public Hearing closed.

Chairman Brown called for a motion to approve.

On motion introduced by Commissioner Worley and seconded by Commissioner Hovis, the BOC unanimously approved **2022-007** as follows:

WHEREAS, EQUUS is considering a total investment of \$15 million in the upfit of an existing building in the Kings Mountain Corporate Center, and the purchase and installation of machinery & equipment to establish an advanced manufacturing facility with the expectation to complete this investment on or before December 31, 2022; and,

- WHEREAS, North Carolina General Statute §158-7.1 authorizes a County to undertake an economic development project by providing grants for the location of industry; and,
- WHEREAS, it is anticipated that the Company's capital investment in and at the Property and its operations thereat will generate significant ad valorem tax, sales tax and other revenues to the County; and,
- WHEREAS, the County will prepare a detailed Economic Development Agreement (EDA), between EQUUS, and the County, to provide a Level One Incentive Grant, so as to induce the company to provide good job opportunities and capital investment which will enhance the County's ability to attract additional business and industry.
- NOW, THEREFORE, BE IT RESOLVED that the Gaston County Board of Commissioners approves a Level
 One Incentive Grant and authorizes the Chairman, Vice-Chairman, County Manager or designee
 to execute any documents necessary to complete an Economic Development Agreement for
 EQUUS.

Chairman Brown announced that the Public Hearings were concluded.

Citizen Recognition

Representatives of Piedmont Lithium provided follow-up comments to various citizen questions raised during the public comment segment of the January 11th Work Session as follows:

Mr. David Klanecky, 417 Robmont Rd., Charlotte, NC, and Piedmont Lithium Team Member:

- Re: Water Contamination and Wells: Piedmont Lithium will not artificially alter naturally occurring (ground)water nor use it as part of its integrated facility operations; will have an extensive monitoring system in place at all key points throughout its operations; the project will not cause widespread "drying up" of local wells; can share hydrological and geological studies at BOC's convenience
- Re: Lithium-ion Batteries: Majority of vehicles and battery makers are moving towards a high nickel content battery requiring lithium hydroxide to make cars go faster, farther and charge faster; an average 60-kilowatt hours lithium-ion battery today will contain about 55 kilograms of lithium hydroxide per vehicle; Piedmont Lithium plans to produce about 30,000 tons of lithium hydroxide to supply roughly 550,000 vehicles

- Re: If Alternative Technologies will Jeopardize Growth of Electric Vehicles: Lithium-ion batteries are in commercial use today; other technologies on the drawing board currently are the solid-state battery that will require more lithium or hydrogen; Toyota has announced it is relocating its battery manufacturing plant to NC; they were strong proponents of hydrogen but switched its technology trends towards lithium-ion batteries
- Re: Reclamation: Piedmont Lithium is committed to returning the site to a ready-for-most-anyuse condition the County decides upon when it finishes its operations in 40 to 50 years and wants to discuss those options with the County; Piedmont Lithium will conduct progressive reclamation as it moves from one quarry site to the next; since this area will already have water and utilities the County can locate other types of businesses on the site.

He distributed a copy of comments and an Annual Report to the BOC.

On motion introduced by Commissioner Hovis and seconded by Commissioner Worley, the BOC unanimously accepted the document as information.

Mr. Brian Risinger, 211 Poplar St., Belmont, NC, and Piedmont Lithium Team Member, advised that water is a valuable resource that should be protected and preserved; Piedmont Lithium will not artificially alter the ground or surface water; will pump out naturally occurring water from rainfall; water collected during the extraction process will go into holding ponds and no harmful chemicals will be used; will have an extensive water monitoring level network and any issues will be corrected; water used in the refining operations will go through the same wastewater treatment process used by other industrial operations and will not be dispersed into any streams or wetlands; it is highly improbable to negatively impact residential wells when there is no lake or river directly below the ground's surface and the bedrock has disconnected veins, channels and aquifers.

Mr. Austin Devaney, Fort Mill, SC and a Piedmont Lithium Team Member, advised the NC Department of Environmental Quality identified 747 active mines last summer; there are 37 active mines in six nearby counties, including Gaston, and 40 active mines in the Catawba River Basin; mines fuel and support development; live 4.8 miles from a mine (Martin Marietta's Pineville Quarry); located within one mile of that site are homesites, a cattle farm, high tech manufacturers and Carowinds; materials mined in NC range from aggregate sand, dirt, and rock used for construction purposes and high tech materials (high purity quartz, phosphate); Piedmont Lithium will also produce high purity quartz, feldspar for building products and mica; the land that Piedmont Lithium submitted for its permit to the NC Mining Registry will not register amongst the top ten mines that average 4,000 acres in size which is nearly three times the size of Piedmont's site.

Ms. Emily Blackburn, 106 Stonewood Estates Dr., Cherryville, NC, and Piedmont Lithium Team Member, advised after receiving a Bachelors' Degree in Geology that she applied for many jobs online and ended up working in Apple Valley, MN; after a few months she received a call about a career opportunity in the County and is now a Geologist for Piedmont Lithium; they will create jobs for local Engineers, Geologists and other people in the area.

Ms. Malissa Gordon, 7554 Sedgebrook Dr., Stanley, NC, and Piedmont Lithium Team Member, advised its sustainability efforts require social and community progress, economic growth and environmental stewardship; its program extends far beyond business operations and has impacted the community and County; in 2021 Piedmont Lithium focused on the community and made contributions to the Department of Social Services Children and Family Services, the Cathy Mabry

Cloninger Center, Belmont Police Department Shop with a Cop Program, Cherryville Area Ministries, Backpack Weekend Food Program and the United Way Christmas Wishes Program; contributed 100+ volunteer hours to Meals on Wheels Program in November and December; sponsors events via its membership with several Chambers of Commerce and is a corporate partner and sponsor for The Schiele Museum, Gastonia Honey Hunters, Gaston County Schools, Cherryville High School Baseball and Cherryville High School Education Foundation; Piedmont Lithium wants to be part of the community, serve it as well and be an advocate for the County.

Commissioner Hovis reported that *CaroMont Health's Critical Care Tower* is pretty much weathered in; about 3.5 stories of the second Belmont site is beginning to tower over the dirt off I-85N; CaroMont has set records the last seven days on the number of patients cared for due to Covid-19; *CaroMont Health Foundation Board* met today and via joint efforts with Gaston College

and the Schools will help CaroMont to staff the new Hospital through scholarships and internships with a focus on local talent, to continue the delivery of healthcare in the County.

Commissioner Brown reported that he and Commissioner Hovis, the County Manager and Economic Development Commission Director visited Dhollandia in the SouthRidge Business Park in Bessemer City yesterday; the facility is over 200,000SF and is magnificent; they met the Ambassador and General Counsel of Belgium; Dhollandia will make lift gate systems for wheelchairs, delivery trucks, etc.

Commissioner Hovis advised a lot of activity is going on at Dhollandia in regard to penetrating the market with its products; he summarized the activity and stated it is great to have their headquarters in the County.

Chairman Brown announced the Compensation Study was completed; all Departments were included in the study; it will be implemented by the end of the month; thanked employees and staff for their valued services.

County Manager's Report

The County Manager thanked staff and thanked the BOC for supporting the compensation study that is critical in the County's efforts to recruit and retain talent; advised that the BOC has a copy of the Strategic Plan page from the County's website and a sampling of the General Fund dashboard. She presented as follows:

- Re: Gaston County Strategic Plan: The BOC approved the Strategic Plan a couple of months ago
- Re: General Fund Dashboard: Budget & Strategy staff is developing some financial and strategic dashboards so that the BOC and public can access that critical information; the public will be able to email questions or feedback to staff; County will have some robust, interactive and effective dashboards in the Fall via its updated website.
