#### BUDGET IMPACT

General Fund: Decrease revenue and expenditures by \$900.

Community Investment Fund: Increase revenue and expenditures by \$900.

General Government Capital Fund: Increase revenue and expenditures by \$900.

#### BACKGROUND

A budget transfer of \$900 is requested to cover the increased cost of two Motorola radios being purchased under the previously awarded FY24 Edward Byrne JAG Grant (Resolution #2025-018). The Sheriff's Office was awarded a total of \$16,900 from this grant; \$12,100 was allocated in a Capital Fund account and \$4,800 was allocated in a General Fund account.

The updated quote came in higher than the originally allocated \$12,100. To accommodate this increase, \$900 is being transferred from the General Fund account (which holds the \$4,800 allocation) into the Capital account (which holds the \$12,100 allocation).

Both accounts fall under the same Department of Justice budget category.
