BACKGROUND

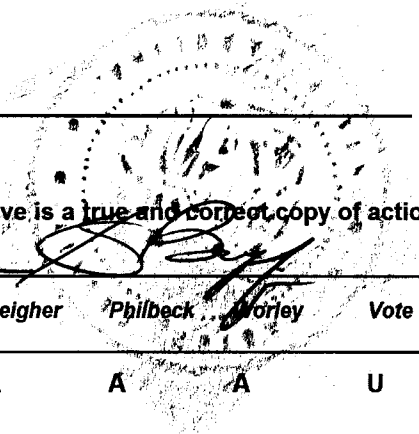
