GASTON GIGABIT INCUBATOR SCOPE OF WORK AND SCHEDULE

CONCEPT OVERVIEW

"Gaston Innovation Works" (GIW) will be a hybrid business incubator, providing a new opportunity to drive economic development in Gaston County. Focused on helping to grow Startups, Entrepreneurs and existing Small Businesses, it could be a catalyst to establish an Entrepreneurial Ecosystem in Gaston County. A key feature of GIW will be the availability of Gigabit-speed Internet access and its use as a demonstration & learning site for new, cutting edge technologies and services, enabled by this capability. Through collaboration with other organizations such as city/county governments, educational institutions, philanthropies/foundations, businesses/industries and other community organizations, GIW could stimulate job growth and strategically position Gaston County for the future.

PRIMARY FUNCTIONAL ACTIVITIES

The GIW is planned to have four primary functional activities, with a number of supporting activities:

- 1. The Business & Internet Technology Innovation & Demonstration Center would showcase cutting-edge business & Internet technology that leverages the Gigabit-speed Internet connection. This may include: conference rooms and business event space with Video Conferencing/Telepresence and interactive, touch-sensitive, whiteboards to support "Virtual Meetings" and global collaboration; the use of networked/Internet connected devices ("The Internet of Things"), including SmartBuilding/SmartHome technologies like audio/video streaming, digital signage, electronic door locks, HVAC, lights, robotics, security cameras, window shades, etc.
- 2. <u>The Startup Incubator</u> designed to accelerate the growth and success of new & existing small businesses through a unique and highly flexible combination of business/Internet technology, capital, education, office space, mentorship, promotion, referral and support services.
- 3. <u>The Co-Working Space</u> —a shared working environment, where individuals & small groups work in open, flexible and collaborative communities, but for different companies, paying a monthly membership for access to a shared bundle of business technology services.
- 4. The Business Accelerator would provide a startup with seed funding and an intensive, industry focused, education and mentorship program of short duration, typically 90-120 days, in exchange for a small equity stake. This fourth functional area may not be developed during the initial 3-year period of GIW operations.

Additional functional activities might include a "MakerSpace" with 3D printers, laser cutting and CNC machines to support rapid prototyping & proof-of-concepts; and a "coding academy"

providing an intensive short-term educational certificate in computer programming. Both of these activities could be developed as joint ventures and coding academies are frequently forprofit ventures. Development of these is dependent upon funding availability (primarily from cost savings achieved through rent concessions, donation of equipment or services, and similar savings on budgeted items), partner identification, space availability and related factors. The term "Gaston Innovation Works" is intended only as a temporary name for the hybrid business incubator and its programs and activities and development of a permanent name is one of the major milestones detailed below.

NOTE: These are budget estimates for line items and variances will occur. It is expected that some expenses will be avoided due to concessions on items such as rent, gigabit internet service, etc. In the event concessions are secured or other budget savings achieved, funds may be reallocated between delineated line items as necessary or designated for other activities supporting GIW, with quarterly reporting to the County.
