

RESOLUTION TITLE: TO APPROVE THE APPOINTMENT OF GASTON COUNTY TAX DIRECTOR, ASSESSOR, COLLECTOR PURSUANT TO G.S. §105-294 AND 349

- WHEREAS, North Carolina General Statute §105-294 authorizes a County to appoint the office of County Assessor and North Carolina General Statute §105-349 authorizes the County to appoint the office of Tax Collector; and,
- WHEREAS, on July 26, 2012, via Resolution 2012-235, the Gaston County Board of Commissioners found it to be in the best interests of the County to combine the appointed positions of County Assessor and Tax Collector into one title to be known thereafter as the Tax Director; and,
- WHEREAS, Cecil Jackson, Tax Director, retired on June 3, 2022, and Chelsea Morrow Tarbush was appointed as Interim Tax Director, with a term expiring immediately upon the appointment of a permanent Tax Director; and,
- WHEREAS, Chelsea Morrow Tarbush is a person of character and integrity whose experience in business and collection is satisfactory to the Gaston County Board of Commissioners; and,
- WHEREAS, the Gaston County Board of Commissioners finds it is in the best interests of the County to have stability and expertise in the position of Tax Director.
- NOW, THEREFORE, BE IT RESOLVED that the Gaston County Board of Commissioners hereby appoints Chelsea Morrow Tarbush as Tax Director, effective October 25, 2022, for the remainder of the term ending on the 30th day of June 2023, followed by a regular four-year term ending on June 30, 2027.
