BUDGET ORDINANCE IMPACT

Increase Federal revenues by \$135,210 and appropriate \$135,210 into Adoption Promotions Project account.

BACKGROUND

In June, 2020, DHHS (Social Services Division) received \$135,210 in additional Adoption Promotion Funds to be used exclusively to enhance the adoption program. The Adoption Promotion Funds were deposited into the FY19-20 revenue account, which rolled to Fund Balance at year end closeout. These funds require appropriation to the FY2020-2021 Social Services Budget, therefore we are requesting to allocate from Fund Balance. These funds are carried forward each new fiscal year until funds are expensed.
