BACKGROUND

Gaston County Police has received a grant from PhRMA (Pharmaceutical Research and Manufacturers of America) in the amount of \$8,800. These funds will be used along with county funds to provide rehabilitation and treatment services over incarceration for those for individuals addicted to opioids through the Phoenix Counseling Center. Phoenix Counseling Center and the Gaston County Police Department have entered into a contract (2018-39) for implementing the treatment program over a twelve month period or until funds are exhausted.

Gaston County Police requests the grant in the amount of \$8,800 be accepted and appropriated to the account listed on the BCR.

JUSTIFICATION FOR REQUEST:

Transfer of funds for providing over a twelve month period or until funds are exhausted to Phoenix Counseling for treatment program to give individuals addicted to opioids the opportunity to receive comprehensive, community-based treatment as a primary response over incarceration. Gaston County shall provide \$148,800 with PhRMA (Pharmaceutical Research and Manufacturers of America) providing a \$8,800 grant. The \$140,000 will be transferred from the salaries G/L into the DDAT account.
