- WHEREAS, following her tenure at South Point High School, Mrs. Chisholm served as the Librarian at Woodhill and Lingerfeldt Elementary Schools before returning to the classroom in 2007 as a French teacher at Ashbrook High School; and,
- WHEREAS, as an "original employee" of Gaston County Schools who is still teaching, Mrs. Chisholm was chosen to serve as the Honorary Grand Marshal for the "Big 50 Parade," which was held on September 22, 2018 to celebrate the 50th Anniversary of Gaston County Schools; and,
- WHEREAS, now, 50 years later, Mrs. Chisholm still has the passion for teaching and devotion to her students just as she did when she was first hired in Gaston County Schools on August 22, 1968.
