JUSTIFICATION FOR REQUEST:

The Department of Social Services Child Welfare Division was approved to receive \$58,800 in Governor Crime Commission Grant funds for translation services. Therefore, we are requesting to appropriate the additional funding into the FY2018-2019 budget. The additional funds will be used for translation services and training in the Child Welfare Division. This grant does require a 20% match that will be met with currently budgeted positions. No additional county funds are required.
