CONFUSION OF TAX VALUE

- **NC IS TRUE VALUE STATE**
- **TAX VALUE EQUALS FULL MARKET VALUE**
- **TYPICAL PURCHASE PRICE**
- **100% FULL MARKET VALUE, JANUARY 1, 2019**



GASTON COUNTY BY THE NUMBERS

- **TAXABLE VALUE COMPARISON**

- 2018 \$ 12,529,765,941

- 2019 \$ 15,463,150,610

- 23.41% INCREASE

- * REAL PROPERTY ONLY

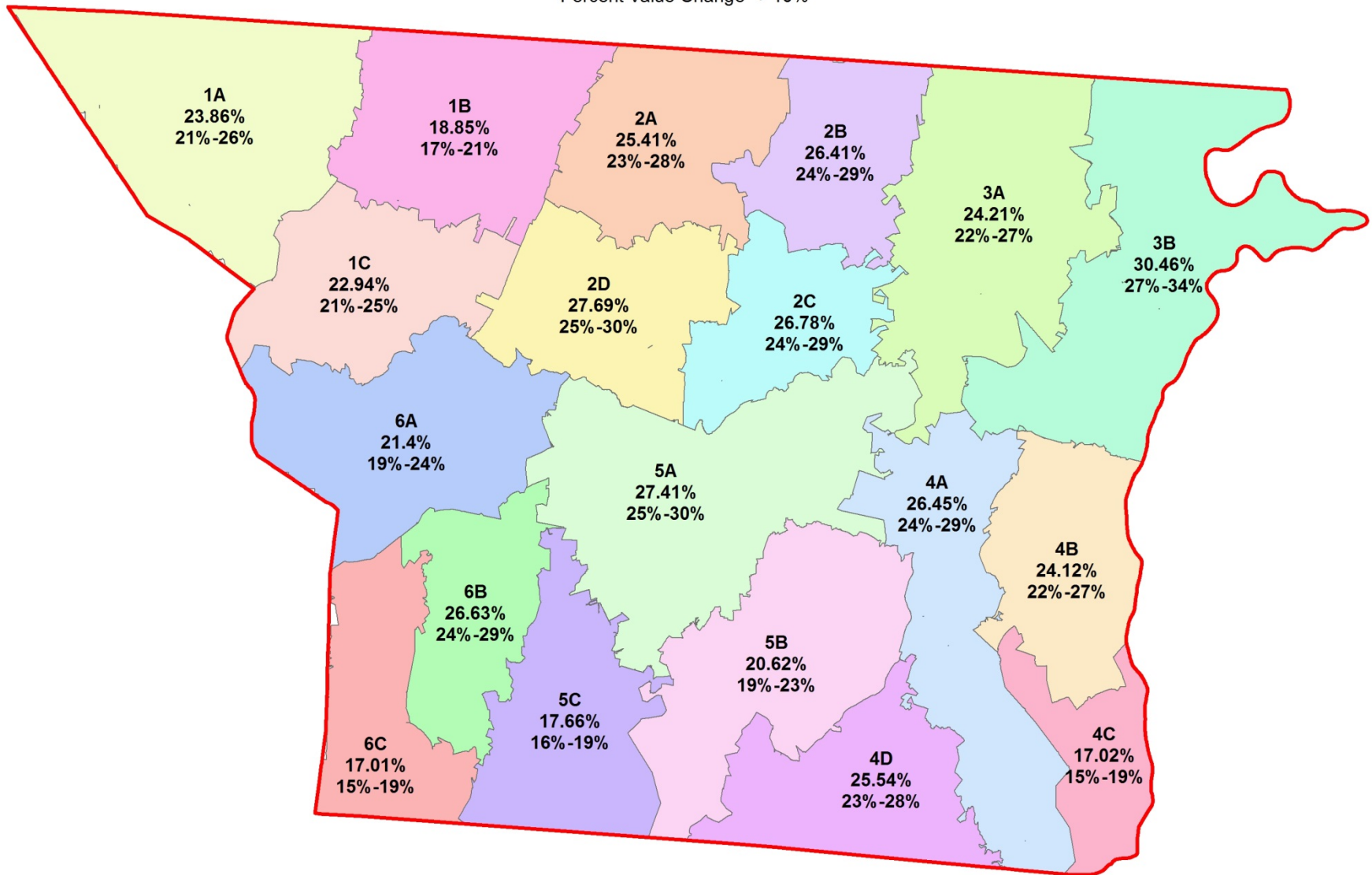

- **ALL APPEAL DECISIONS WILL BE MAILED INCLUDING INFORMATION REGARDING NEXT LEVEL OF APPEAL**
