BACKGROUND

The Gaston County Board of Commissioners approved funding in the FY20 budget to complete ADA improvements at various County facilities. Due to age and continued usage of these facilities, the buildings and surrounding parking lots/landscaping are in disrepair and do not meet current accessibility requirements. Tindale Oliver previously conducted an in-depth study of various County facilities and provided ADA remediation recommendations to Gaston County. Based on the results of that study, C Design Inc. designed the needed repairs and prepared bidding documents for public bidding purposes. The project was publicly advertised on March 22, 2020 and a bid opening was held April 7, 2020 with the following results:
