BACKGROUND

Board Action 2016-180 established an interlocal agreement for yard waste disposal services between the City of Gastonia and Gaston County. This interlocal agreement combined the efforts of the City and County to achieve cost savings and greater efficiency. This Board Action will extend the interlocal agreement for a term of 2 years. All other terms and conditions of the original agreement remain in full force and effect. Approval of this Board Action authorizes the attached interlocal agreement between Gaston County and the City of Gastonia, authorizes the County Attorney to modify and finalize the agreement where necessary for signature purposes, authorizes the County Manager or her designee to sign said agreement and updates the yard waste acceptance fee per the agreement terms.

FIRST AMENDMENT TO INTERLOCAL AGREEMENT FOR DISPOSAL SERVICES

between the City of Gastonia, a North C	Carolina Municipal Corpor	ration (hereinafter referred to as
"City"), and Gaston County, a political	subdivision of the State	of North Carolina (hereinafter
referred to as "County");		

WITNESSETH:

Whereas, City and County have previously entered into an Interlocal Agreement for Disposal Services dated July 19, 2016 (the "Agreement") whereby they contracted for the disposal of yard waste collected by the City at a yard waste facility maintained by the County; and,

Whereas said Interlocal Agreement expires June 30, 2021; and,

Whereas, City and County desire to amend the Agreement in order to extend the term of the Agreement for two years until June 30, 2023;

Now, Therefore, in consideration of and subject to the agreements, terms and conditions hereinafter set forth, City and County covenant and agree as follows:

1. Paragraph 6 of the Agreement is hereby amended to read as follows:

This Agreement shall be in effect from the effective date above, through June 30, 2023. The term of this Agreement shall thereafter be automatically renewed on an annual basis until either party elects to cancel this Agreement by giving written notice to the other party thirty (30) days prior to the expiration of the then current contract term (fiscal year). Extension of this Agreement shall be under the same terms and conditions.

2. Except as amended herein, all other terms and conditions of the Agreement remain in full force and effect and are hereby ratified and confirmed by City and County.
