The Gaston County Board of Commissioners (BOC) met in Regular Session on August 22, 2017 at 6:00 pm, in The Harley B. Gaston, Jr. Public Forum, Gaston County Courthouse.

Chairman Chad Brown presided with Commissioners Ronnie Worley, Vice-Chairman; Don Grant, Bob Hovis and Tom Keigher in attendance.

Commissioners Allen R. Fraley and Tracy L. Philbeck were not in attendance.

Others present included Earl Mathers, County Manager; Charles L. Moore, County Attorney; and Donna S. Buff, Clerk to the Board.

Upon request of Chairman Brown, Commissioner Grant led those assembled in the Invocation and Commissioner Hovis led in the Pledge of Allegiance.

Chairman Brown announced the Public Hearings as advertised; explained procedures to be used; called for the motion to enter into Public Hearings.

On motion introduced by Commissioner Worley and seconded by Commissioner Keigher, the BOC unanimously entered into Public Hearings.

Public Hearing - Zoning Map Change: (Z17-06) Mitzi Brown (Applicant); Property Parcels: 204358 and 157113, Located at 1100/1106 Baxter Road, Cherryville, NC, Rezone from (R-1) Single Family Limited Zoning District to (R-2) Single Family Moderate Zoning District

Chairman Brown recognized Mr. David Williams, Development Services Director, for a brief overview.

Mr. Williams restated the request as outlined above and presented as follows: request is to rezone two parcels 204358 consisting of 2.47 acres and 157113 consisting of 2.39 acres, from R-1 (Single Family Limited Zoning District) to R-2 (Single Family Moderate Zoning District); advised that subject properties involve a combined total of 4.6 acres; current property is undeveloped; reviewed property boundary, surrounding zoning, street network, surrounding neighborhoods, and outline of property via maps and noted the property location in the northwest of the City of Cherryville near the Lincoln and Cleveland County line; the road frontage is Baxter Road, which lies west and is south of Kens Way and north of Old Fallston Road, with Old Fallston Road running almost perpendicular into the property; it is staff's opinion that the proposed map amendment is consistent with the Comp Plan; request was advertised and sent to adjacent property owners per County policy; no municipal coordination was required; staff received two calls for information.

Chairman Brown called for citizen comment.

Ms. Mitzi Brown, property owner, stated the requested rezoning would allow her to place a double wide trailer on the property for her daughter, on the other side of her son's property. She pointed out subject property via maps and noted entrance is off Kens Way; the easement was in place when she moved there; her property is listed as Baxter Road; neighbor has questioned the traffic

impact to Kens Way; have made a drive that comes across it; agreed to help keep up the road and has given money before; if necessary, daughter will have road frontage and could cut her own road.

Ms. Kay Ramirez, 532 Kens Way, stated that she spoke with the applicant about her concerns; Kens Way is on her plat; Kens Way residents signed a document agreeing to maintain the road; is concerned that the road cannot handle additional traffic; applicant would need to enter into an agreement to maintain Kens Way.

Chairman Brown recognized Ms. Brown for additional comments.

Ms. Brown stated her house faces Baxter Road and that is why no one asked her to sign anything for road upkeep; the people behind her signed; she was there first, and did put down gravel and did give money for the maintenance to the road; now daughter and son have agreed to help keep it up and if not, they will cut their own road; believes road can handle more traffic; didn't sign agreement initially because was not made aware; would be glad to sign.

Mr. Steve Dockery, 530 Kens Way, stated the reason she was not notified about keeping the road maintained is because her address is Baxter Road, not Kens Way. She did help one time to put down gravel on the road.

Chairman Brown called for questions from the Planning Board; hearing none, called for questions from the BOC.

Chairman Brown inquired if well and septic were located on the property.

Mr. Williams responded "not to my knowledge". This request is for a general zoning; if the rezoning passes, the applicant would have to come in and submit the requisite paperwork; Health Department doesn't do prescreening of property anymore; general rezoning would have to take place first, if approved.

Chairman Brown stated the road issue does not have any bearing on the Board's decision tonight.

Commissioner Grant stated that Ms. Brown mentioned part of the land didn't perk; inquired if anyone checked to see if the upper part will perk.

Ms. Brown indicated (from the audience) that it had been checked and it will perk.

Chairman Brown moved to the next item of business.

Public Hearing - Zoning Map Change: (Z17-07) Eaton Corporation (Amy Rowell, Manager)(Applicant); Property Parcel 192172, Located at 2306 South Point Road, Belmont, NC, Rezone from the (R1) Single Family Limited Zoning District w/ (CH) Corridor Highway, (SV) Scenic View and (US) Urban Standards Districts Overlays to (C-1) Light Commercial Zoning District w/ (CH) Corridor Highway, (SV) Scenic View and (US) Urban Standards Districts Overlays

Mr. Williams restated the request as outlined above and presented as follows: request is to rezone parcel 192172 from R-1 (Single Family Limited Zoning District w/ CH, SV and US Overlay Districts) to C-1 (Light Commercial w/ CH, SV and US Overlay Districts); advised that subject property involves approximately 4.48 acres; current property use – commercial electrical testing facility; reviewed property boundary, surrounding zoning, street network, surrounding neighborhoods, and outline of property via maps and noted the property location in the southeastern part of County, South Point Road; it is the opinion of staff that the proposed map amendment is consistent with the Comp Plan; request was advertised and sent to adjacent property owners per County policy; no municipal coordination was required; staff received no calls for information.

Chairman Brown called for citizen comment.

Ms. Amy Rowell, representing Eaton Corporation, displayed a photograph of the existing facility and stated it has been there since the sixties; the desire is to move to commercial zoning; does not believe there will be any issue based on the facility and the use.

Chairman Brown called for citizen comment and questions from the Planning Board; hearing none, called for comments from the BOC.

Commissioner Hovis inquired if there were any plans for expansion.

Ms. Rowell stated there were plans to expand a warehouse.

Commissioner Hovis inquired if the requested zoning would place the property in conformance and Ms. Rowell stated "yes".

<u>Public Hearing - Planning/Zoning - To Approve Renaming of Private Drive from Roland Conner</u> Ln to Scott And Dawson Ln

Chairman Brown recognized Mrs. Sarah Penley, Planning GIS Specialist III, for a brief overview.

Ms. Penley restated the request as outlined above and presented as follows: Staff was presented with a property owner petition bearing 100 percent signatures with the request to rename a private drive that accesses parcel 151222. This property is located in the northwest small area district off of Bess Town Road, within an existing mobile home park in the County. The applicant is the new owner of the property and wishes to establish a different name in an effort to distinguish himself from the previous owner and the previous management. He wishes to rename the private drive that accesses the property as Scott and Dawson Lane, which is a non-duplicating road name and is in compliance with 9-11. Referring to maps, Ms. Penley outlined the vicinity and the subject road; road is located in the ETJ of Bessemer City and they were notified accordingly; is located off Bess Town Road, between Bessemer City and Cherryville; there are some existing mobile homes located on the drive to be named and the property owner advised that most of the mobile homes are currently vacant or will be. Ms. Penley stated that the effective date can be adjusted if necessary, to accommodate any tenants that may be residing in

those units at this time. The Planning Board reviewed the application and approved a recommendation to the Board at their July 25, 2017 meeting; notices were mailed in accordance with County policy and no calls have been received to date; it is staff's recommendation that the application be approved as it fulfills the requirements set forth in the addressing and road naming ordinance.

Chairman Brown called for citizen comment and Planning Board comment and hearing none called for comments from the BOC.

Commissioner Hovis inquired if the road meets State standards.

Ms. Penley stated that it is a private drive contained within that private community and is maintained solely by the property owner.

Commissioner Grant inquired how this would affect mail delivery with the postal service and the time frame for Google Maps.

Ms. Penley stated that when a change of any kind is made, County data is updated immediately; will typically set the effective date 25-30 days out to give residents time to make the change; rollover occurs immediately with 9-11 and with US Postal Service; USPS generally will mail to either the old or new address; third party vendors such as Google, Amazon, UPS, etc., purchase data from USPS in mass and the County has no knowledge or control over the time schedule of the data purchases; the County's primary focus is 9-11 delivery and mail service.

Before proceeding to the vote, Chairman Brown excused the Planning Board to Room 2029 for its deliberations on the previous zoning matters.

Chairman Brown called for citizen comment and comments from the BOC and hearing none, called for a motion to approve.

# 2017-180 Commissioner Hovis - Planning/Zoning - To Approve Renaming of Private Drive from Roland Conner Ln to Scott And Dawson Ln

On motion introduced by Commissioner Hovis and seconded by Commissioner Keigher, **2017-180** was unanimously approved as follows: Renaming Private Drive from Roland Conner Ln to Scott And Dawson Ln and authorize the County Manager to make the necessary notifications to the appropriate State and local officials.

Public Hearing - Planning/Zoning - To Approve Naming of Private Drive as Darden Trl

Chairman Brown recognized Mrs. Sarah Penley, Planning GIS Specialist III, for a brief overview.

Ms. Penley restated the request as outlined above and presented as follows: Staff was presented with a property owner petition bearing 100 percent signatures with the request to name a private drive that accesses parcel 223516 and 225728. This property is located in the Dallas

Township off Dallas, Spencer Mountain Road; the applicant owns two parcels with a combined total of 25.79 acres. An existing structure with road frontage has been removed from the property and the owner currently uses it for recreational hunting. He expressed the intent to build at a later date with the possibility of adding more than one home which would be located well outside the visibility of the roadway, making it difficult for emergency responders to locate. The applicant wishes to name the private drive as Darden Trail which is a non-duplicating road name and in compliance for use with 9-11. Referring to maps, Ms. Penley outlined the vicinity and the subject road; road is located off Dallas-Spencer Mountain Road, before the city limits of Spencer Mountain; addressing in the area is very tight; if applicant were to add homes on the property, there would be an issue with not having enough addresses to accommodate the property owner; placement of a street sign would be helpful in the event there is an emergency on the property prior to the construction of a home; Planning Board reviewed the application and approved recommendation to the BOC at their July 25, 2017 meeting; notices were mailed in accordance with County policy and no calls were received; staff recommends approval as it fulfills the requirements set forth in the addressing and naming ordinance.

Chairman Brown called for citizen comment and comments from the BOC and hearing none, called for a motion to approve.

# 2017-181 Commissioner Philbeck - Planning/Zoning - To Approve Naming of Private Drive as Darden Trl

On motion introduced by Commissioner Worley and seconded by Commissioner Keigher, **2017-181** was unanimously approved as follows: Naming Private Drive as Darden Trl and authorize the County Manager to make the necessary notifications to the appropriate State and local officials.

<u>Public Hearing - RE: Commissioner Brown - Provide an Advisory Opinion to NCDOT Concerning</u> Possible State Abandonment of Bay Shore Drive

Chairman Brown reiterated the public hearing procedures and called on the County Attorney for introductory comments.

The County Attorney noted this is the first step in what might be an extended process with respect to the street. Per the Department of Transportation's rules, when NCDOT receives a petition to abandon maintenance and right-of-way of the secondary road system, they request the Commissioners to provide an advisory opinion on the matter. Once that is done, NCDOT will then take the matter up and give notice to property owners that they intend to consider it at a board meeting. If they approve the abandonment, the road will be removed from the State maintenance system and NCDOT's interest and right-of-way will be extinguished. To close the actual road and remove the platted roadway from the record would then require the Commissioners to take action under the general statutes that provide the County's authority to close the use of a road. Paperwork would be filed to notice the public that the previous plat, showing a right-of-way, has been extinguished. He indicated that the NCDOT District Engineer may be in attendance.

Chairman Brown called for citizen comment.

Mr. Gerald Kennedy, 256 Bay Shore Drive, stated he and his wife were the petitioners for the requested closure. He indicated that it involves approximately the last 315 feet [of the road] and noted they own the property on both sides of the road in the subject area. He reiterated the request is to close the last 315 feet and not the entire Bay Shore Drive.

Mr. Thomas Tyler, 212 Bay Shore Drive, stated he was in attendance to represent the other members of this community. He asked how someone could start building and installing pillars on a road that is maintained by the State without prior approval. He noted there is only a half turnaround that won't fit a regular truck; two trucks have had to be backed up recently; there are kids playing on the road. He indicated it is not fair to the neighbors that paid money to upgrade the road to State standards.

Chairman Brown called for comments from the BOC.

Commissioner Hovis inquired if NCDOT officials were supposed to be in attendance to offer technical insight and assistance.

The County Attorney responded that he had reviewed a lengthy e-mail string from the past two weeks and was under the impression the District Engineer would make an effort to be in attendance.

Chairman Brown recognized Mr. Kennedy for additional comments.

Mr. Kennedy stated the process was stopped as soon as they realized it wasn't done correctly; met with the County and the DOT at the turn-around; will actually be providing a much bigger turn-around than was provided previously in front of current residence and the survey for the turn-around has been approved; will not affect anyone else on that stretch of road.

Commissioner Grant inquired if the residents had paid to bring the road up to State standards; if the State should or should not abandon the road; and, if the property line extends to the center of the road.

The County Attorney responded that should the State decide to abandon the right-of-way and remove it from State maintenance, it would be a matter for the Commissioners to close the road and eliminate it from the plat that was filed many years ago. He confirmed the property line would be the center line of the road and that maintenance for the road would return to the property owners along the road; it essentially becomes a private road again.

Ms. Jenna Jones, Attorney with Bishop Delaney Joyner and Abner, P.A., representing the Kennedys, noted that the section of road being closing is bounded on both sides by property that is owned only by the Kennedys. The other residents on this road will not be affected by the closure. Their portion of the road will continue to be a DOT maintained right-of-way.

Commissioner Worley stated that he contacted Mr. Spangler and received clarification that the property owners own the road to the center on both sides; Mr. Kennedy owns property on both

sides of the portion in question and so therefore owns that entire section of the road; he also noted that Mr. Spangler indicated that nothing above where the proposed gates and columns are located would be affected regarding the State's continued maintenance of the road.

Commissioner Hovis referenced the e-mail thread and NCDOT's late clarification of the process. He noted the email made reference that the State could, if it so decided, remove the entire length of Bay Shore Drive. He pointed out that while that is not Mr. Kennedy's request, it is an example of why someone from the NCDOT should have been at this meeting to assist the Board in fully understand the extent of this Boards "advisory opinion" and to provide confirmation that it's not going to further extend the scope of what the NCDOT will do and that it will be limited only to the area requested. He noted that he requested renderings of the proposed end of the road and has still not personally received that information. He suggested tabling the matter until NCDOT can be in attendance.

Chairman Brown noted that following earlier meetings with the Kennedys involving various County and State officials, a moratorium was put in place to stop the situation from progressing further, which he believes was happened before pictures of the columns surfaced. Noting his agreement with Commissioner Hovis, he stated this issue should not have been passed down to the County and the matter should therefore be tabled.

Commissioner Hovis clarified that his request is for Mr. Spangler and his superior to be present.

Chairman Brown called for a motion to close the Public Hearings.

On motion introduced by Commissioner Hovis and seconded by Commissioner Grant, the BOC unanimously closed the Public Hearings.

# 2017-203 Board of Commissioners - County Attorney - Resolution Relating to the Issuance of General Obligation School Bonds

Chairman Brown called for a motion for the purpose of discussion. Commissioner Keigher introduced the motion and Commissioner Hovis provided the second.

At the request of Commissioner Worley, the County Manager explained the issuance is in essence a bank issue of \$6M with the proceeds to be used primarily for reimbursing the County in the amount of \$4M for the acquisition of land and the design of the new Belmont Middle School facility; there will also be some associated transactional costs estimated at \$200k; any remaining money would be used for other school improvements. He explained that while the 2.1% rate is marginally higher than market, the transactional costs will be lower so it is essentially a wash. He concluded that it is the most expeditious route and he is confident the LGC will approve it.

With discussions coming to a close, Chairman Brown called for the vote.

- (d) That the County desires to sell said School Bonds to be issued (the "Bonds") at private sale and caused a Request for Proposal, dated July 12, 2017 (the "Request for Proposal") to be distributed to various financial institutions requesting such institutions to submit their proposals for the purchase of the Bonds.

Pursuant to said orders and the Proposal, the County desires to issue the Bonds as a single bond registered in the name of Key Government Finance, Inc., as the purchaser thereof, in the principal amount of \$6,000,000, designated "General Obligation School Bond, Series 2017", dated the date of delivery thereof, stated to mature in annual installments of principal of \$600,000 on August 1, 2018 to 2027, inclusive, and bearing interest at the rate of two and one hundred three thousandths per centum (2.103%) per annum, which interest is payable on February 1 and August 1 of each year, commencing on February 1, 2018 (the "Bond").

Section 3. The Local Government Commission of North Carolina (the "Local Government Commission") is hereby requested to sell the Bond at private sale without advertisement to any purchaser or purchasers thereof, at such prices as the Local Government Commission determines to be in the best interest of the County, subject to the approval of the County Manager or the Finance Director of the County; provided that the Bond is sold at a purchase price of not less than ninety-eight percent (98%) of the face value of the Bond plus one hundred percent (100%) of any interest accrued thereon from the date thereof to the date of delivery and payment therefor and, further, that the interest rate of the Bond does not exceed two and one hundred three thousandths per centum (2.103%) per annum.

Section 4. The Proposal, substantially in the form presented to the Board of Commissioners and subject to the provisions of Section 3 of this resolution, is hereby approved. The County Manager or the Finance Director of the County is each hereby authorized to approve the purchase price of the Bond in connection with the private sale of the Bond. The County Manager or the Finance Director of the County is each hereby further authorized to approve such changes to the Proposal as either may deem necessary or appropriate and to execute and deliver the Proposal for and on behalf of the Board of Commissioners and the County.

Section 5. The County Manager, the Finance Director and the County Attorney of the County and their designees are hereby authorized and directed to take such other actions and to execute and deliver such other documents, certificates, undertakings, agreements or other instruments as may be necessary or appropriate to effectuate the issuance of the Bond.

Section 6. This resolution shall take effect upon its passage.
