The Gaston County Board of Commissioners (BOC) met in Rescheduled Session on December 12, 2017, immediately following its Work Session at 6:31 pm, in The Harley B. Gaston, Jr. Public Forum, Gaston County Courthouse.

Chairman Chad Brown presided with Commissioners Ronnie Worley, Vice-Chairman; Allen R. Fraley, Don Grant, Bob Hovis, Tom Keigher and Tracy L. Philbeck in attendance.

Others present included Earl Mathers, County Manager; Charles L. Moore, County Attorney; and Donna S. Buff, Clerk to the Board.

Upon request of Chairman Brown, Commissioner Hovis led those assembled in the Invocation and Commissioner Fraley led in the Pledge of Allegiance during the preceding Work Session.

<u>Public Hearing - City of Lowell - 1) Lowell Planning & Zoning Board; 2) Lowell Zoning Board of Adjustments ETJ</u>

Chairman Brown announced the Public Hearing as advertised; explained procedures to be used; called for the motion to enter into Public Hearings.

On motion introduced by Commissioner Grant and seconded by Commissioner Keigher, the BOC unanimously entered into Public Hearings.

Chairman Brown reported that one position was available on subject boards; application was received from Mr. Bill F. Stegall as recommended by the Lowell City Council, to serve as an extraterritorial jurisdiction representative to both boards. The Chairman called for any additional applications or comments; hearing none, called for questions from the BOC.

Commissioner Philbeck explained his opposition to ETJs and noted his reason for voting against ETJ appointments.

In response to Commissioner Philbeck, Commissioner Keigher noted that the ETJ appointments do at least provide some representation on those boards.

Chairman Brown called for a motion to approve.

On motion introduced by Commissioner Worley, seconded by Commissioner Fraley, the BOC reappointed Mr. Bill F. Stegall to the *Lowell Planning and Zoning Board* and to the *Lowell Board of Adjustments* to terms ending November 30, 2020. The vote carried as follows:

<u>Public Hearing – Authorization for a Standard Level Three Grant and to Convey Approximately</u> 16+/- Acres in The Southridge Business Park - Project "Wonder Woman"

Chairman Brown introduced Mr. Steve Nye for comments.

Mr. Steve Nye, EDC Marketing Director, advised the request is to approve a standard Level Three Grant and to convey approximately 16+/- acres in the Southridge Business Park, depending on the final survey, at a total price of \$425,000 or \$26,562/AC. The project has made three visits since June 22<sup>nd</sup> and is a very fast-moving project. They plan to invest approximately \$30M through 2022; facility will house the North American corporate office and an advanced metal working facility; will build approximately 160,000 square feet - expandable; intend to create an estimated 150-200 new jobs paying an average annual wage \$46,100 (current Gaston county average annual wage is \$38,438). Bessemer City Council has approved the standard Level Three Grant plus a \$25,000 site development grant for this project; County Attorney is working to develop an economic development agreement.

# 2017-280 Commissioner Brown - EDC - To Authorize a Standard Level Three Grant and to Convey Approximately 16+/- Acres in The Southridge Business Park - Project "Wonder Woman"

On motion introduced by Commissioner Philbeck and seconded by Commissioner Hovis, the BOC unanimously approved **2017-280**, as follows:

- WHEREAS, Project WONDER WOMAN is considering an investment of \$30,000,000 to construct a an advanced manufacturing operation to Gaston County, including the installation of machinery and equipment and the establishment of a North American corporate office and the creation of at least two hundred new jobs (200) expecting to pay an average annual wage of \$46,100 which is above the 2017 average annual wage of Gaston County of \$38,438; and,
- WHEREAS, North Carolina General Statute §158-7.1 authorizes a County to undertake an economic development project by providing grants and land conveyance for the location of industry in order to increase the local tax base and provide quality jobs; and,
- WHEREAS, the Gaston County Board of Commissioners finds that it is in the best interests of the County to offer a standard level three grant for Project WONDER WOMAN; and,
- WHEREAS, the Gaston County Board of Commissioners finds that it is in the best interests of the County to convey the 16+/- acres of property in the Southridge Business Park at a total price of \$425,000 or \$26,562.50 per acre for 16+/- acres, which is dependent upon the final survey, for the proposed investment of \$30,000,000 which will create at least 200 new jobs expecting to pay an average annual wage of \$46,100; and,
- WHEREAS, the Gaston County Board of Commissioners has conducted a properly advertised public hearing to provide an economic development agreement for the standard level three grant and to convey the 16+/- acres of property in the Southridge Business Park at a total price of \$425,000 or \$26,562.50 per acre for 16+/- acres, which is dependent upon the final survey.

NOW, THEREFORE, BE IT RESOLVED, that Gaston County Board of Commissioners:

The Chairman of the Gaston County Board of Commissioners is authorized to:

 Execute any documents necessary to complete the County's incentive proposal to convey approximately 16+/- acres in the Southridge Business Park and the standard level three grant for Project WONDER WOMAN.

<u>Public Hearing – Authorization for an Economic Development Agreement to Provide a Standard Level Two Local Incentive Grant - Project "KARMA"</u>

Chairman Brown introduced Mr. Steve Nye for comments.

Mr. Steve Nye, EDC Marketing Director, advised that the request is to approve an economic development agreement to provide a standard Level Two Grant for Project Karma – a multiphase, international project looking at purchasing a building in Ranlo; the Town Commissioners will meet on Thursday night and the EDC will report the results of the meeting to the County Manager; the company manufactures high performance and advanced textiles for the composite industry; Seventy-seven year-old privately held company; estimate the investment at approximately \$11-18M depending on the market; will create approximately 150-200 new employment positions with an average annual wage of \$41,000; County Attorney is working to develop an economic development agreement.

Commissioner Grant thanked EDC staff for their efforts.

## 2017-281 Commissioner Brown - EDC - To Authorize an Economic Development Agreement to Provide a Standard Level Two Local Incentive Grant - Project "KARMA"

On motion introduced by Commissioner Worley and seconded by Commissioner Fraley, the BOC unanimously approved **2017-280**, as follows:

- WHEREAS, Project KARMA is considering an investment of \$18,500,000 over a period of five calendar years to establish an advanced manufacturing operation to Gaston County, including the installation of machinery and equipment and to establish a North American corporate office and intends to create at least two hundred new jobs (200) expecting to pay an average annual wage of \$41,478 which is above the 2017 average annual wage of Gaston County of \$38,438; and,
- WHEREAS, North Carolina General Statute §158-7.1 authorizes a County to undertake an economic development project by providing grants for the location of industry; and,
- WHEREAS, the Gaston County Board of Commissioners finds that it is in the best interests of the County to provide a standard level two grant for Project KARMA for the investment years of 2017, 2018, 2019, 2020, 2021 and 2022 where the company's net new taxable investment would normally qualify for a standard level one grant; and,
- WHEREAS, this proposed local incentive offering will be incorporated into a detailed economic development agreement, between Project KARMA, the County and the Town of Ranlo, so as to induce the company to provide good job opportunities and capital investment in Gaston County which will enhance the County's ability to attract additional business and industry.

NOW, THEREFORE, BE IT RESOLVED; that Gaston County Board of Commissioners:

The Chairman of the Gaston County Board of Commissioners is authorized to:

 Execute any documents necessary to complete this economic development agreement for Project KARMA.

WHEREAS, the citizens of Gaston County are currently protected by an antiquated and obsolete UHF/VHF emergency services radio system that is approaching 16 years of service and becoming increasingly difficult to maintain adequately; and,

WHEREAS, in September 2013 a multi-agency subcommittee of public safety officials along with County staff was commissioned to evaluate available options for the next generation emergency services radio system platform; and,

WHEREAS, following an extensive evaluation of multiple system options the subcommittee voted unanimously to designate the NC VIPER system as the preferred system for implementation; and,

WHEREAS, due to the predicted cost burden, it was deemed to be in the public interest for all agencies to develop creative funding sources where possible, and specifically for the fire service, to collaboratively seek a Joint Regional Federal Emergency Management Agency (FEMA) Assistance to Firefighters Grant (AFG) to more cost-effectively purchase and install the county-wide VIPER radio system; and,

WHEREAS, the FEMA AFG program limits such radio system grant awards to non-infrastructure purchases to a maximum of \$2 million dollars and requires the regional grant partners to provide a one-time 10% fund match

NOW, THEREFORE, BE IT RESOLVED that the Gaston County Board of Commissioners wishes to designate the NC State Highway Patrol Voice Interoperability Plan for Emergency Responders (VIPER) as the next generation emergency services radio system platform and to endorse the county-wide fire service bid for a 2017 Joint Regional Federal Emergency Management Agency Assistance to Firefighters Grant by providing the required 10% matching grant funds not to exceed \$200,000 dollars.
