The Gaston County Board of Commissioners (BOC) met in Regular Session on April 24, 2018 at 6:04 pm in The Harley B. Gaston, Jr. Public Forum, Gaston County Courthouse.

Chairman Chad Brown presided with Commissioners, Tom Keigher, Vice-Chairman; Allen R. Fraley, Don Grant, Bob Hovis, Tracy L. Philbeck and Ronnie Worley in attendance.

Others present included Earl Mathers, County Manager; Charles L. Moore, County Attorney; and Angela Stacks, Deputy Clerk to the Board.

Upon request of Chairman Brown, Commissioner Worley led those assembled in the Invocation and Commissioner Philbeck led in the Pledge of Allegiance.

Items Pulled From Consent Agenda

2018-082 Commissioner Brown - Public Works - To Award a Construction Contract and Authorize the County Manager to Execute said Contract with PHC Industrial of Hampton, Virginia for the Construction of the Gaston County Animal Care and Enforcement Facility, and Approve Funding at a Cost not to Exceed \$5,499,721

On motion introduced by Commissioner Philbeck and seconded by Commissioner Grant, the item was pulled from the Consent Agenda by unanimous vote.

Chairman Brown called for a motion to approve for the purposes of discussion.

Chairman Brown recessed the meeting for a brief reception. The meeting was reconvened at 6:47 pm.

<u>Public Hearing - ETJ 18-01: To Consider Acceptance of the Relinquished Extraterritorial Jurisdiction (ETJ) by the City of Mt. Holly into the Gaston County Zoning Jurisdiction and the Recommended County Zoning Districts for the Relinquished Areas</u>

Chairman Brown announced the Public Hearings as advertised; explained procedures to be used; called for the motion to enter into Public Hearings.

On motion introduced by Commissioner Worley and seconded by Commissioner Keigher, the BOC unanimously entered into Public Hearings.

With a quorum of the Planning Board in attendance, Chairman Brown recognized Mr. David Williams, Planning & Development Services Director, for comments.

Mr. Williams requested the MPO comments be accepted into the record and on motion introduced by Commissioner Hovis, seconded by Commissioner Keigher, the BOC unanimously accepted the document as information.

Mr. Williams reviewed the application as set forth above and presented as follows: request is to respectively accept and rezone the extraterritorial jurisdiction (ETJ) as relinquished by the Mt. Holly City Council on January 8, 2018 into the Gaston County jurisdiction and the recommended County zoning districts; the effective date for the relinquishment is June 1, 2018. There are two hundred and ten (210) parcels covering approximately 1,006.45 acres to be rezoned from Mt. Holly Zoning Districts RAMF, R-10, R-12, R-20, H-I, L-I and O-I to County zoning districts either RMF, R-1, RS-12, RS-20, C-2, I-1, I-2, I-3 and/or OLC with US and CH overlay districts. Staff worked to find similar zoning districts for the relinquished parcels. The Gaston County Planning Board is acting as the applicant and is thus considered an administrative request. The parcels in question are sporadically located in and around the City of Mt. Holly. He reviewed the properties in eleven areas via vicinity, aerial and zoning maps which depicted current and proposed zoning and noted that Area 9 is located in the railroad right of way; if the railroad is ever abandoned it will automatically default to the R-1 zoning.

Commissioner Hovis requested clarification on Mt. Holly's "CDSF" zoning which is being rezoned to residential.

Mr. Jonathan Wilson, Planner with the City of Mt. Holly, clarified it is part of the River Park subdivision; property originally in the ETJ and not a part of the City; when a new developer purchased the property, it went through a conditional district rezoning process, however property was never annexed into the city; single family with no conditions for this portion of the neighborhood that would apply; R-1 makes the zoning less stringent.

Mr. Williams concluded that it is staff's opinion that the request is compatible with current County zoning districts and therefore consistent with the comprehensive land use plan. The request was advertised and sent to adjacent property owners in accordance with County policy. Staff received 28 calls regarding the proposed changes, for which a vast majority were for information only.

Chairman Brown called for comments from citizens; hearing none called for comments from the Planning Board.

Chairman Brown asked Mr. Wilson to relay thanks to Mr. Danny Jackson, City Manager, the Mt. Holly Planning staff and City Council for working with the County throughout the process.

Mr. Wilson thanked Gaston County Planning staff on behalf of the City of Mt. Holly.

Chairman Brown called for comments from the BOC.

Commissioner Philbeck stated he has had several conversations with Mr. Jackson about ETJs; has been his goal to see ETJs eventually abolished; noted his reasons for his opposition and suggested that anyone living in an ETJ should petition their City Council to be removed.

Mr. Williams requested the MPO comments be accepted into the record and on motion introduced by Commissioner Hovis, seconded by Chairman Brown, the BOC unanimously accepted the document as information.

Mr. Williams reviewed the application as set forth above and presented as follows: request is to rezone twenty-two (22) contiguous parcels from R-1, C-1, C-U/C1 Conditional Use, with US and CH Overlays to the I-2 General Industrial District with US and CH Overlays. Applicant is Gaston County Economic Development Commission (EDC); 317.65 acres located generally between Dallas Bessemer City Hwy, White Jenkins Road, and Dallas Cherryville Hwy, near the towns of Dallas and the City of Gastonia jurisdictions; mostly undeveloped and has open space. He reviewed the property via vicinity, aerial and zoning maps as follows: located in the Northwest Gastonia area between Bessemer City and Dallas; residential with some commercial; he noted the adjacent property owners as depicted on the zoning map, were notified of the request; property is within the Rural and Rural Communities Small Planning Area; Mr. Williams concluded that based on the goals and objectives in the zoning district pattern in the general area, it is staff's opinion the request is consistent with the Comp Plan; request was advertised and sent to adjacent property owners in accordance with County policy; staff received three calls for information.

Chairman Brown called for citizen comment.

Mr. Don Barkley, Gastonia: noted the County's economic development; efforts and requested a report reflecting the County's return on investment for economic development activities; referenced payments made to Greater Gaston Development Corporation (GGDC) and inquired about their role in economic development since the County has an Economic Development Commission. He referenced the City of Gastonia de novo hearing process and asked if this is property he County is planning to purchase

Ms. Gloria Ratchford, 310 Applewood Road, Dallas: late husband, Joe Ratchford previously owned Apple Creek Golf Course and Applewood Properties; until the time of passing in 2014, he worked diligently with the EDC to pursue the extension of the GTP to the golf course property; supports zoning change to increase the tax base for Gaston County.

Mr. Seth Ratchford, 9232 Deer Spring Park Lane, Charlotte (formally of Applewood Road): noted positive impacts of the proposed zoning; compared the Apple Creek property to similar successful project in Chatham County.

Ms. Mary Ann and Carl Dutterer, 126 Applewood Road, Dallas: inquired how the rezoning will affect their veterinary business; didn't see the use in the description of I-2; animal shelter/kennel shown as conditional use permit with supplemental regulation. She inquired if the property is rezoned, would a future buyer be allowed to continue the use in the new zoning and would they be allowed to expand; and, if sold, could a buyer live in the residence, which is also located on the property.

Mr. Moore inquired if the parcel was scheduled to be adjusted in the rezoning.

She stated it is area 15 on the map – parcel 170432.

Mr. Williams stated the current use would be allowable now and the future; noted the zoning runs with the land and not the property owner.

Chairman Brown directed Mr. Sam Shames, Assistant County Attorney, to assist them with any additional questions and to make sure they receive something in writing.

Mr. Robert Browne, 1663 Backcreek Lane, Gastonia: Chairman of the Economic Development Commission; thanked Board for consideration of the rezoning; property is adjacent to GTP and would fall within similar characteristics of the park; would provide additional economic development opportunities and would increase the tax base of County.

Mr. Steve D'Avria, President and CEO of the Chamber: spoke in support of the rezoning; outlined the project's benefits and noted the proposed business park will serve approximately ten industries; is an important opportunity to continue the County's growth and expansion of the tax base.

Mr. John Forgan, Chairman of the Gaston Regional Chamber: spoke in support of the rezoning; the proposed development is critical to the community; other counties are vying for the same economic development projects.

Mr. Jason Thompson, Planning Director, City of Gastonia, 150 S. York Street, Gastonia; spoke in support of the rezoning; it is an opportunity to assemble large tracts of land for the purpose of well-coordinated development in the future.

Mr. John Lineberger, 304 Farm View Lane, Bessemer City, NC: owner of parcel 22 on handout; requested the reversion of the zoning in the event the County doesn't purchase the property.

Commissioner Philbeck responded that he discussed the matter with the County Attorney and that is the intention.

Chairman Brown called for Planning Board comments, hearing none, called for BOC comments.

Commissioner Philbeck requested the County Manager send the economic development report to Mr. Barkley; he also noted the GGDC is a private entity made up of private industries; is not funded by County tax dollars.

Chairman Brown excused the Planning Board to Room 2029 for deliberations.

Commissioner Philbeck noted for the record that Item X was pulled from the Consent Agenda and voted on earlier in the meeting.

On motion introduced by Commissioner Philbeck and seconded by Commissioner Keigher, the BOC unanimously approved the Agenda of April 24, 2018 with changes as noted above.

Citizen Recognition

Mr. Wil Neuman, representing the School Bonds Committee, spoke in favor of the May 8th School Bond Referendum; he summarized the initiative and noted it was a low turnout ballot and encouraged voters to support the bonds. He provided two presentation slides which depicted the branding logo for the initiative and logos depicting various entities in support of the initiative.

Commissioner Philbeck asked if the Committee is also supporting the Quarter-Cent Sales Tax Referendum.

Mr. Neuman noted they were supporting the Quarter-Cent as well, although it was not their original charge; he displayed a Quarter-Cent Fast Facts handout which was provided by the County; he noted that it has been promoted on Face Book and is being given out at the precincts, along with the School Bond handout.

Commissioner Philbeck stated the Board has made it very clear, if the Quarter-Cent Sales Tax doesn't pass, it will be virtually impossible to pay for the bonds.

Chairman Brown noted that Mr. Booker and Mr. Mathers videos are airing regularly on the Government Channel.

Mr. Anthony Giacobbe, Gastonia, Treasurer of the Gaston County Tea Party: spoke in favor of School Bonds and Sales Tax referendums; thanked Commissioner Philbeck and the County Manager for meeting with their leadership to discuss ways to improve the County's accountability and transparency and for their timely response to those requests; referenced Non-Consent Agenda item D and noted it addresses two requests from the Tea Party: a commitment that the sales tax revenue be used solely for school bond debt service and, once the \$250M school bonds have been paid for, the County will place the sales tax back on the ballot for the citizens to repeal if they so choose.

Sheriff Cloninger informed the Board that after consulting with staff and the Director of Carolina Correctional Health, the Sheriff's Office will be bringing forward another request, in the amount of

\$100,000, to the Commissioners May 22nd meeting. He explained that inmates are increasingly coming in with serious health issues, which have included cancer, heart attacks, and substance abuse related conditions.

Commissioner Philbeck inquired about insurance.

Sheriff Cloninger stated he contacted the North Carolina Sheriff's Association, which does have a catastrophic insurance policy. Gaston County Chief Deputy Kim Johnson indicated that it would probably cost more because of the number of inmates in Gaston County. He noted that another factor contributing to the increased medical costs is jail overcrowding.

Commissioner Philbeck inquired if the hospital had been consulted to see if they could help with the issue and the Sheriff responded they plan to meet with them to make sure they are still qualifying inmates for Medicaid when they are brought in.

As a means to address the escalating costs, Commissioner Fraley asked the Sheriff to provide the Board with the cost for a blanket insurance premium that could be included in the budget.

In response to Commissioner Worley, the Sheriff stated federal prisoners are covered for outside facility expenses; internal expenses are the responsibility of the County.

Commissioner Philbeck introduced a motion for purposes of discussion and Commissioner Grant provided a second.

Chairman Brown called for discussion.

Commissioner Worley inquired if it would be possible to utilize the additional appropriation of \$102,400 before the end of the school year.

Commissioner Philbeck stated that he spoke with Mr. Booker and the Sheriff and it was determined that the County Police or Sheriff's Office could provide the coverage.

Commissioner Worley inquired about the additional training that is required.

Sheriff Cloninger stated that under North Carolina law, there is currently no required SRO training; any certified law enforcement officer may serve as an SRO. He added that he is the Vice-Chair of the North Carolina Governor's Crime Commission Safe Schools Committee; they met yesterday and will be exploring requirements for school resource officers. He noted that if they had to go out and hire 20 new officers, it would not be possible; it is better to utilize local law enforcement and allow County law enforcement to continue to serve as backup. All officers that will serve as SROs will go through the existing County Police Department's SRO training this summer. If the training is ever mandated, the SRO course authorized through the NC Justice

Academy is a 40-hour program which is currently held six times a year with 24 spots in each class.

Assistant Chief George Osborne stated that the officers that are currently providing elementary SRO duty will continue in that role; the money being appropriated will use more officers from the same group, more efficiently.

In response to Commissioner Fraley, the County Manager stated the cost for a full year is \$640k.

Sheriff Cloninger clarified the \$640k provided by the County is in addition to a \$500k State grant received by the School system for elementary SROs.

Commissioner Philbeck stated there may be an opportunity for more State funds. He reiterated how the current SROs will be utilized for more hours at the elementary schools versus hiring 16 new officers. He stated this is the most efficient model and it is supported by the various law enforcement agencies in the County.

Asst. Chief Osborne stated they would initiate the process immediately to get the program in place.

Sheriff Cloninger stated he would be finishing up meetings with the Schools and local police chiefs and is confident it will be implemented as soon as possible.

Commissioner Hovis requested that the commission be provided with a list of the officers and their relative hours at each school.

Commissioner Philbeck clarified that Gaston Schools will decide who the agency and which officer will go into those schools. The County is the funding mechanism.

Asst. Chief Osborne confirmed that is already set up through the schools.

Commissioner Hovis responded that he wants to see the blend of multi-jurisdictional participation across the County. It is a positive endorsement of our local law enforcement.

Commissioner Grant introduced a motion to approve and Commissioner Hovis provided a second.

Chairman Brown called for discussion.

Mr. Mathers stated the GEMS fees are an effort to maximize cost recovery through Medicare/ Medicaid; is not an attempt to enhance revenue.

Commissioner Keigher countered that it will affect many people that aren't on Medicaid or Medicare as well. He noted he would not vote in favor of the increased fees.

Commissioner Hovis stated that departments have been charged with analyzing costs and establishing cost/revenue neutral fees where possible. He noted his agreement that Gaston County is in a better financial position and now is the time to put these fees in place and keep departments running at optimum efficiency.

Commissioner Philbeck suggested removing the GEMS fees and bringing those fees back at a later date; he introduced an amendment to the main motion to remove the GEMS fees from the FY19 Fee Schedule. Commissioner Grant provided the second.

Commissioner Fraley asked Mr. Mark Lamphiear, EMS Chief, for clarification on the FY19 fee increases for his department.

Mr. Lamphiear noted the Commissioners charged him with maximizing revenue; he noted that by not charging these fees, revenue is being left on the table for third party payers and the cost is thereby born by tax payers and users; approximately 60-65% of patients are Medicare patients and 5-10% are Medicaid patients; commercial insurances typically follow the same example as Medicare reimbursement. He noted that GEMS' fees are roughly in the 75-80% percentile with other emergency management systems in the State.

Commissioner Grant noted the increase to DOA transports and asked if an ambulance is being tied up to transport a deceased body; he also asked why GEMS is staying on the scene if the patient is deceased.

Mr. Lamphiear responded that it is not their business model, but because the current fee is so inexpensive, GEMS is often taken advantage of – the increased fee is an attempt to incur less of that type of business. He also noted it is GEMS' practice to remain with the body until it is transported by a funeral service or body transport service.

Commissioner Fraley suggested tabling the fee schedule.

Commissioner Philbeck withdrew his motion to amend and introduced a motion to table the item. Commissioner Grant provided the second and the motion passed unanimously.

Zoning Districts Defined

RMF RESIDENTIAL MULTI FAMILY

The purpose of this district is intended primarily as a residential district for the location of single family, two family and multifamily dwellings along with their customary accessory uses so as to establish areas where development patterns are somewhat denser than surrounding areas. In order to ensure that developments are well planned and compatible with adjoining residential uses, density levels of development in excess of six (6) units per acre are allowed subject to the issuance of a Conditional Use Permit (CUP) by the Board of Adjustment. This district should have access to public or community water and sewer utilities.

RS-12 SINGLE FAMILY 12,000 SQUARE FEET
The purpose of the RS-12 District is primarily for the development of single family residential with a standard minimum lot size of twelve thousand (12,000) square feet. This district is generally found in the Urban Standards Overlay (USO) district and is served by public or community water and sewer utility. Higher densities than this is normally allowed and a variety of different residential types may be accommodated through Planned Residential Developments (PRD), Infill Residential Developments and Traditional Neighborhood Developments (TND) and/or through the satisfaction of certain performance design and construction.

RS-20 SINGLE FAMILY 20,000 SQUARE FEET

The purpose of the RS-20 District is primarily for the development of single family residential with a standard minimum lot size of twenty thousand (20,000) square feet. This district is generally found in the Urban Standards Overlay (USO) district and is served by at least one (1) public or community water or sewer utility. Higher densities than this is normally allowed and a variety of different residential types may be accommodated through Planned Residential Developments (PRD), Infill Residential Developments and Traditional Neighborhood Developments (TND) and/ or through the satisfaction of certain performance design and construction.

The I-3 district is established to provide areas for the most intensive heavy manufacturing and industrial uses that may have impacts such as excess noise, environmental concerns and extended hours of operation. Uses in this district are extremely limited and include mining uses, petroleum refining and slaughterhouses. I-3 districts shall not be located adjacent to any property that is zoned for residential use. Any areas that are rezoned to an I-3 district subsequent to the adoption of this Ordinance shall be located so as to have direct access to or lie in close proximity of a principal or minor arterial.

I-2 GENERAL INDUSTRIAL

The I-2 district is established to provide for areas of heavier manufacturing and industrial uses that are properly sited, based on such factors as: adjacent land uses, access to the transportation network, and the availability of public services and facilities. It is the intent of this district to provide an environment for industries that is unencumbered by nearby residential or commercial development. I-2 zoned districts shall be located in areas where conflicts with other uses can be minimized to promote orderly transitions and buffers between uses. The I-2 district is established in order to provide sites for activities that involve major transportation terminals, and manufacturing facilities that have a greater impact on the surrounding area than industries found in the 1-1 district. I-2 districts shall generally not be located adjacent to any property that is zoned for residential use, except when mitigating factors (i.e., terrain, buffering, and transportation access) are in place to substantively mitigate any potential negative impacts upon such residential areas caused by uses in the I-2 district. Any areas that are rezoned to an I-2 district subsequent to the adoption of this Ordinance shall be located so as to have direct access to or lie in close proximity of a principal or minor arterial.

I-1 LIGHT INDUSTRIAL

The I-1 district is established to provide for areas that contain a mix of light manufacturing uses, office park and service uses in an attractive setting with proper screening and buffering.I-1 districts should include areas that continue the orderly development and concentration of light industrial uses. Any areas rezoned to the I-1 district subsequent to the adoption of this Ordinance should be located so as to have direct access to or lie within close proximity of a principal or minor arterial.

OLC OFFICE/ LIGHT COMMERCIAL

The OLC district also allows for and is designed to accommodate mixed office, retail and residential development. Such higher intensity development will most likely occur within the Urban Standards Overlay District where public utilities may present and where access to major thoroughfares and/or transit is found. Development in OLC areas will most likely be at a higher intensity level than in the TMU district.

APRIL 24, 2018

GASTON COUNTY, NORTH CAROLINA

R-1 SINGLE FAMILY LIMITED

The purpose of this district is to accommodate single family site built and modular construction. The minimum lot size allowed in this district will be dependent on the provision of public or community water and sewer facilities. Although areas may be served with such utilities, most of these areas are located beyond existing or anticipated utility service coverage areas. The minimum lot size for residential uses in this district is therefore larger than in other residential zoning districts.

C-2 HIGHWAY COMMERCIAL

The C-2 Highway Commercial District is primarily intended to accommodate those retail service and distributive uses that are typically located along or adjacent to principal or minor arterials and which require high visibility, good road access, and which cater primarily to passing motorists. Development in this district is designed to promote aesthetics and the safe and efficient movement of traffic so as to not unduly burden adjacent thoroughfares. As larger and/or more intensive developments normally will create more significant impacts on adjoining neighborhoods and road and utility infrastructures, larger developments may be allowed in this zoning district. Most C-2 zoning districts will be located within the Urban Standards Overlay District.

USO URBAN STANDARDS OVERLAY DISTRICT

Areas of the County which are located outside their corporate limits and /or municipal Extra Territorial Jurisdiction (ETJ) but where the provision of public water and sewer services can reasonably be expected to occur over the next 10-15 years, have been designated as the "Urban Standards Overlay District". Accordingly, standards for development, more akin to those that traditionally are found in urban areas, as opposed to rural areas, are called for. Standards addressed, but not limited to: building design, off-street parking, road, lot and subdivision standards.

Note: If any portion of the subject property is within the USO, then the entire property shall be developed in accordance with USO standards.

CH Corridor Highway Overlay District

The purpose of the CH District is to preserve and enhance the streetscape along designated corridor highways in Gaston County. A CH District may exist along the entire length of a roadway or along any identifiable segment of a roadway. Any CH District initially established shall contain a minimum length of at least one thousand (1,000) linear feet as measured along one side of a designated corridor highway. The CH District shall consist of all lots fronting on the corridor highway for a depth of two hundred-fifty (250) feet as measured from the centerline of the corridor highway (for a total width of five hundred (500) feet), unless otherwise indicated on the Zoning Map. Although such corridor highways may vary in character, particular aspects of development along those roads raise common concerns and should be managed in a consistent way in order to preserve and enhance the streetscape.

The County Attorney corrected a statement he made earlier in the public hearing regarding parcel 170432, noting that it is in included in the proposed rezoning. He also clarified that if the zoning were to be changed, the owner may continue the current use (veterinary clinic and residence) and there would be no requirement to conform to the rezoning now or at a later date; a future owner of the property would be allowed to continue the same commercial use, however if a different use is desired, a rezoning or variance would be required.

Chairman Brown called for a motion for the purposes of discussion.

Commissioner Hovis introduced a motion and Commissioner Grant provided a second.

Commissioner Hovis inquired: 1) will the residence become non-conforming as a result of the zoning change; 2) would significant improvements or additions be allowed to the non-conforming use (he noted the municipal threshold is 30% of the appraised property value and anything above that is considered to beyond the scope of the property's current footprint); 3) is the County planning to acquire their property and are they willing to sell.

The County Attorney confirmed the use would become non-conforming; should the project not occur, the Economic Development Commission would apply to return all of those properties to their former zoning.

Commissioner Philbeck asked the property owners of parcel 170432 if they were satisfied with the information they received. They indicated affirmatively (from the audience) that they were satisfied.

Chairman Brown requested the rendering from the Planning Board.

The County Attorney advised that the Planning Board recommended approval by a unanimous vote on staff's recommendations outlined on the map shown by the Planning and Development Services Director during public hearing.

On motion introduced by Commissioner Hovis and seconded by Commissioner Grant, the BOC unanimously approved **2018-113** after consideration of the application, Public Hearing comment and Planning Board recommendation:

- 1) The map change request is consistent with the County's approved Comprehensive Plan. The area in question is approximately 325 acres of property and is generally in the Rural and/or Rural Community land use designations. The area is in the North 321 Gaston/North Central Gaston Small Area District. Key issues for the community include in part steering development towards existing infrastructure and near developed areas. The rezoning is consistent with the comprehensive plan due to its location on or near major roads such as NC 279 and NC 275 and an existing industrial park located near the subject location. The Commission considers this action to be reasonable and in the public interest, based on: Planning Board recommendation and compatibility with existing land uses in the immediate area. Parcels: 170270, 170271, 170405, 170418, 170419, 170420, 170426, 170432, 170788, 170790, 170889, 207268, 207270, 207271, 207273, 207275, 207277, 212069, 212070, 212071, 213893, 219200 (portion of), be approved, effective with the passage of this Resolution.
- 2) The County Manager is authorized to make necessary notifications in this matter to appropriate parties.

County Manager's Report

The County Manager reported as follows:

- Delivered factual summaries on the School Bonds and Quarter-Cent initiatives to different community groups in the County; noted that voter turnout is quite low to date
- Hosted different groups from a couple other Counties (Catawba and Cleveland) to discuss jail diversion programs and substance abuse programs; those programs seem to have progressed well in Gaston County and they are hoping to replicate in those areas.

County Attorney's Report

Other Matters

Chairman Brown stated that he spoke at the Gaston Regional Chamber last Friday on the School Bonds and Quarter-cent Sales Tax Referenda.

Commissioner Hovis reiterated it is the Board's intent to use the proceeds from the quarter-cent sales tax solely to service the \$250M bond debt. He commented that Gaston is one of only two counties that have opted to use this particular funding mechanism.
